**Mr. President, Mr. Speaker and  
Members of the Louisiana Legislature**

In accordance with La. R.S. 27:15 (B)(9)(b), the Louisiana Gaming Control Board herewith renders its annual report for 2001.

To categorize the gaming environment as "changing" would be a gross understatement. Major revisions to tax structure, changes in ownership of several entities, as well as new developments in the "slots at tracks" sector, have been the focus of attention of the Louisiana Gaming Control Board this past year.

Once again, the riverboat segment has been the dominant area of gaming activity. The summary report and economic impact statements contained in this document bear this out. Riverboat operators, in exchange for authority to conduct dockside gaming, agreed to a tax increase. The original franchise fee of fifteen percent was increased to eighteen percent. The new tax applicable to vessels operating in the Shreveport-Bossier area, which did not sail, will be phased in over a three year period. The revenues from the new tax and a nine percent allocation from the three and one half percent provided in La. R.S. 27:91(B)(2), have been chosen by the legislature as a major portion of the money dedicated to the Support Education in Louisiana First Fund. The revenue is appropriated to provide for recent salary increases granted to teaching personnel at all levels of education.

It is too early to judge the fiscal impact of a higher tax scale, changes in ownership, additional amenities and dockside gaming. Additionally, the September Eleventh tragedy, and a slowdown in the national economy coupled with a downturn in travel may have a potential adverse effect on gaming revenues. More definitive results will become apparent in future months.

The Baton Rouge segment has continued to show the positive effects of reconfiguration and construction (by Argosy) of an on-site hotel. Extra space was made available as a replacement for establishments that previously offered video poker to customers. The Casino Rouge riverboat was sold. A suitability investigation was completed on the new owner, Penn National Gaming. It is domiciled in Pennsylvania and operates a casino in Mississippi, as well as several racetracks. Their West Virginia facility (race track) has a large video poker operation complete with hotel, restaurant and entertainment center.

Lake Charles continues to grow gaming revenues mainly as a result of major improvements (hotel, restaurant, entertainment) by Harrah's. Of major import will be the effect of the granting of the fifteenth license. The Louisiana Gaming Control Board has awarded it to Pinnacle Entertainment (PNK, L.L.C.) which is listed on the New York Stock Exchange. The company headquarters in California and currently owns other casinos in Louisiana (Bossier City and New Orleans), Indiana, Mississippi and Nevada. They intend to spend approximately \$225,000,000 on the project. The plans include construction of a riverboat, hotel, restaurants, retail shops, entertainment center and a golf course. In addition, large-scale improvements will be made to the area infrastructure (roads and river front). The operators plan to employ in excess of fifteen hundred people with a payroll, including benefits, of thirty four million dollars. Economists have projected that at full operation an additional nine hundred and fifty jobs (twenty

million dollar payroll) will be added to the area workforce. Pinnacle will locate its facility on approximately two hundred and twenty five acres of property leased from the Port of Lake Charles. In addition to the annual rental, the lease includes provisions for land and waterfront improvements. Prior to construction, the project will require voter approval.

The revenues in the Shreveport-Bossier area continue to increase. The growth is directly attributed to the newly opened Hollywood Casino. As anticipated it drew gaming revenue from all of the area riverboats. Horseshoe still maintains state leadership in riverboat gaming receipts.

In order that you may broaden your perspective of riverboat gaming in Louisiana, we recommend close review of the section of this report that compares Louisiana with other states.

After extensive legal and fiscal analysis, the legislature gave approval to a series of amendments to the statutes governing the landbased casino (Harrah's in New Orleans). The minimum annual guarantee of \$100,000,000 was reduced to \$50,000,000 for the first year and to \$60,000,000 for each fiscal year thereafter. The basic minimum tax of eighteen and a half (18.5) percent established by law was raised to twenty-one and a half (21.5) percent in the operating contract. The latter becomes effective when gross gaming receipts exceed the minimum guarantee. Concessions were granted that eased restrictions on hotel and restaurant operations. The intent is to increase patronage and income. Based on latest activity reports, the revenues have remained somewhat stable and overall expenses have declined. Consequently, the casino has experienced an upturn in its "bottom line." As in the case of riverboats, the income from the landbased casino will be placed in the Support Education in Louisiana First Fund and appropriated for the latest teacher pay raise.

The complexion of video poker has been radically altered. As a result of the statewide referendum approximately eleven hundred locations, supporting slightly more than five thousand machines, no longer offer video poker. It is of interest to note that though there are fewer facilities offering video poker to patrons, the number of machines and accompanying revenues has risen. The small "mom and pop" operators have been replaced by a growing number of truck stops authorized to provide up to fifty machines on site.

Adding to the changing face of gaming is the status of slot machine placement at the three authorized race tracks previously approved by the legislature.

The construction at Louisiana Downs in Bossier Parish is nearing completion. There is a proposed change of ownership and the necessary suitability investigations will have to be performed before slots can be approved.

Evangeline Downs, currently operating in Lafayette Parish will re-locate to St. Landry Parish. The track owners have sold a significant number of shares to Peninsula Gaming who is presently undergoing a pre-suitability investigation, which they may request under the law. The partners propose to build a new racetrack and casino plus other amenities that will offer hotel and dining for its patrons.

The third facility in Vinton (Calcasieu Parish) has been purchased by Boyd Gaming. They own a casino (Treasure Chest) in Kenner, as well as operations in several other states. They have been found suitable, and operating plans have been approved by the Louisiana Gaming Control Board. Operations commenced February 13, 2002.

The three Indian tribes operating casinos have negotiated new compacts with the state. Due to federal law, the Gaming Control Board has virtually no authority with respect to the Indian casinos even to ascertain gaming revenues.

Underage gaming appears to have been minimized as a result of joint action by casino operators implementing restrictive measures monitored by law enforcement personnel. While problems with compulsive gaming activities are still evident, their existence still continues to draw attention of the industry, the legislature and this Board. Awareness and educational programs directed to all employees is the current nationwide approach to the problem. As it has in the past, Louisiana still maintains the lead in state supported treatment for gambling addiction.

Of prime import to the Board has been a recent decision rendered by the state Supreme Court. A judgment in a suit extending over several years with court action at all levels was rendered in favor of the Louisiana Gaming Control Board. It enables the Board to exercise its authority as intended by the legislature, and resolves a potential administrative nightmare that could have severely impacted the functioning of the Board.

The operating budget for the current year is \$1,207,819. Despite mandatory increases for insurance, the requested budget for next year is essentially the same. Once again the major expenditures are in the areas of risk management insurance and the operations of a hearing office. As in the past, the exercise of prudence has resulted in a surplus. We will strive to continue the process.

The Louisiana Gaming Control Board is aware of its responsibilities in regulating the gaming industry. Consequently, the mission statement contained in the preface to this report guides us in our deliberations and actions.

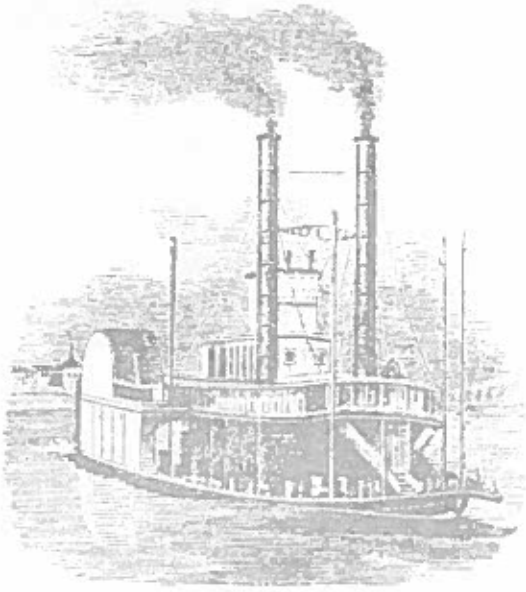

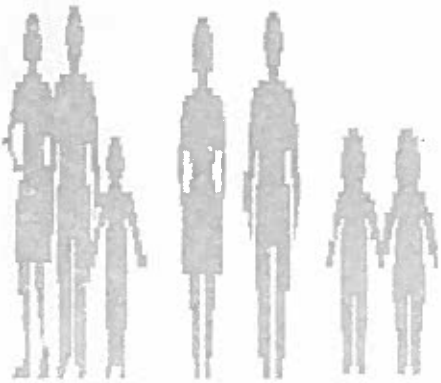

### **Use of Funds**

New Jersey law requires that the state tax, 8% of casino adjusted gross revenue, shall be used for programs aiding senior citizens and the disabled, specifically including a pharmaceutical drug assistance program, a program allowing an annual cash credit toward utility costs, a transportation assistance program and others.

The reinvestment projects, 1.25% of adjusted gross revenue, have been used for developing approximately two thousand (2000) housing units in Atlantic City, parks, beautification programs, agricultural loan programs, a Vietnam Veteran Memorial and others.





**NEVADA**

At the end of FY 2001-2002 there were over two hundred and thirteen thousand (213,000) slot machines in Nevada, over six thousand (6,000) table games and approximately five hundred (500) poker tables.

- C. **Monthly Percentage Fee (Nonrestricted Gaming License)(NRS 463.370)** based on gross gaming revenue - payable on or before the 24th day of each month covering the preceding calendar month at the following rates:

- 4% of the next \$84,000 plus
- 6¼% of revenue exceeding \$134,000.



**D. Casino Entertainment Tax (NRS 463.403) payable on or before the 24th day of each month covering the preceding calendar month.**

This tax applies only to licensees licensed for more than 50 slot machines, more than 5 table games, or any combination thereof.

The tax rate is 10% of all amounts paid for food, refreshment, merchandise, and admissions or similar charges, while in a casino entertainment status.

Casino entertainment status is that condition which renders the selling of food, refreshment or merchandise subject to the tax, and commences either at the time entertainment starts or at the time when any charge such as admission, entertainment fee, minimum, cover, or similar charge attaches, whichever is earlier.

**MICHIGAN**

In November 1996, Michigan voters approved a proposal authorizing up to three (3) licensed casinos in the City of Detroit. Two casinos began operation in July and December, 1999 and as of December, 2001 all three casinos were in operation.

**USE OF FUNDS**

Michigan statutory provisions allow imposition of an 18% tax on adjusted gross revenues, 55% of which or 9.9% of AGR goes to the city for use in connection with:

1. The hiring, training and deployment of street patrol officers.
2. Neighborhood and downtown economic development programs designed to create local jobs.
3. Public safety programs such as emergency medical services fire department programs and street lighting.
4. Anti-gang and youth development programs.
5. Other programs that are designed to contribute to the improvement of the quality of life in the city.
6. Relief to the taxpayers of the city from one of more taxes or fees imposed by the city.
7. The costs of capitol improvements.
8. Road repairs and improvements.

8.1% of AGR is used by the state for deposit in the school aid fund to provide additional funds for K-12 classroom education.



**LIVE RACING FACILITY**  
**PARI-MUTUEL SLOT MACHINE GAMING**

**LOUISIANA**

By Act 721 of the 1997 Regular Session, the Legislature authorized slot machine gaming at live horse racing facilities in St. Landry, Bossier and Calcasieu Parishes. Voters have approved slot machine gaming in those parishes and taxing districts have been authorized and established.

Slot machine gaming at Delta Downs in Calcasieu Parish commenced on February 13, 2002. The other two tracks are expected to open for slot machine gaming in the future.

**OTHER STATES**

**WEST VIRGINIA**

Slot machine or video lottery gaming is conducted at two (2) horse tracks and two (2) dog tracks in West Virginia. The West Virginia Lottery determines which machines will be placed in operation, which are owned or leased by the tracks. All machine revenues are swept 5 days per week. From Gross Terminal Revenue, 4% is deducted for administrative costs. A total of six thousand two hundred thirty five (6,235) terminals or devices were in operation at the end of FY 2000-2001. **DELAWARE**

Slot machine or video lottery gaming is conducted at three horse race tracks in Delaware. The activity is regulated by the Delaware Lottery, which selects and leases the machines. All machine revenue is swept weekly by the Delaware Lottery and distributed in accordance with statutory provisions. 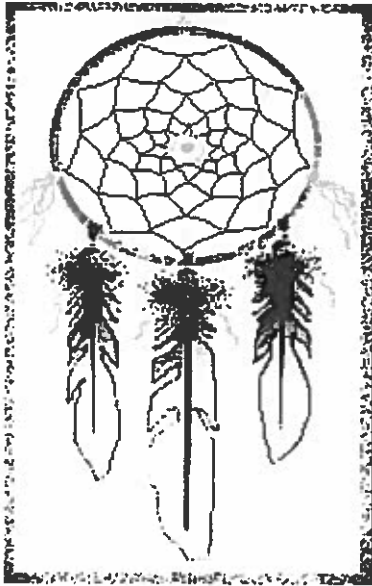

**RHODE ISLAND**

In Rhode Island, slot machine or video lottery gaming is conducted at one pari-mutuel dog track and one pari-mutuel jai alai fronton. The Rhode Island Lottery selects the types of machines that will be placed in operation which are leased by the facilities. All revenues go to the Lottery for distribution in accordance with statutory provisions reflected below. The remaining funds are retained by the state. The activity began in 1992 and at the end of FY 2001, two thousand four hundred seventy eight (2,478) terminals were in operation at the two (2) facilities.
