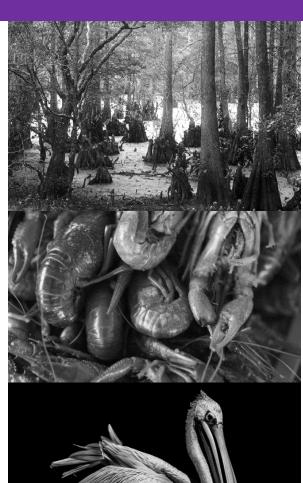
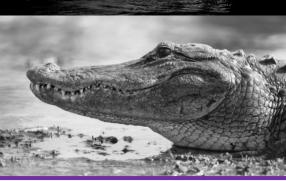

Mr. President, Mr. Speaker and Members of the Louisiana Legislature

The Louisiana Gaming Control Board submits the 27th annual comprehensive report to the Legislature in accordance with La. R.S. 27:15(B)(9)(b).

Statutes legalizing and regulating gaming were enacted in 1991 by the Legislature and, in 1996, the Louisiana Gaming Control Board was created. The Board consists of nine members who are appointed by the Governor, confirmed by the Senate, and serve staggered terms of six years. At least one member is appointed from each congressional district and is eligible to be reappointed for one additional term. The Board is required by law to meet at least once a month. Minutes and transcripts of Board meetings are found on the Board's website and, when the technology is available, meetings are streamed live over the internet.

The Chairman serves in a full time capacity and fulfills the role of CEO for the Board in the conduct and management of its regulatory responsibilities. The Board has three other full time employees who manage the day-to-day affairs of the Board.

The Board exercises regulatory authority, control, and jurisdiction over all aspects of gaming activities and operations as authorized pursuant to the provisions of the Louisiana Gaming Control Law which includes the Louisiana Riverboat Economic Development and Gaming Control Act, the Louisiana Economic Development and Corporation Act, the Video Draw Poker Devices Control Law, and the Louisiana Pari-mutuel Live Racing Facility Economic Redevelopment, Gaming Control Act, Fantasy Sports Act, Sports Wagering Act.

The Board's operating budget for FY 2021-2022 was \$1,022,286 funded through statutory dedicated funds of \$840,173 from the Riverboat Gaming Enforcement Fund, \$99,020 from the Sports Wagering Fund and \$83,093 from the Pari-mutuel Live Racing Facility Gaming Control Fund.

Fiscal year 2021-2022 started off with optimism and potential for positive growth within the gaming industry in Louisiana. On June 10, 2021, the Louisiana State Legislature approved legislation establishing a licensing framework for retail and online sports betting in the fifty-five Louisiana parishes that voted to authorize sports betting in the November 2020 election.

Fantasy Sports went live in July of 2021, retail sportsbooks went live in October of 2021, and mobile sports wagering went live in February of 2022.

The fiscal year ended June 30, 2022 with adjusted gross revenue of \$1,808,444,803 an increase of \$188,222,255 from the previous year.

RIVERBOAT GAMING

Fifteen riverboat casinos are authorized to operate in Louisiana. This report reflects the data for all fifteen riverboat casinos.

There are six riverboat casinos in the Shreveport-Bossier City area; three in Lake Charles; three in East Baton Rouge Parish; and one each in Kenner, Harvey and Amelia. These riverboat casinos employ approximately 8,787 individuals and, in FY 2021-2022, contributed \$388,815,633 in net revenue to the state. Adjusted gross revenue increased in Lake Charles, Baton Rouge, Shreveport/Bossier and New Orleans.

The Shreveport-Bossier City market had adjusted gross revenues of \$583,755,319, for FY 2021-2022, an increase of \$26,403,701 from the previous fiscal year, with \$125,507,395 in fees paid to the state.

The Lake Charles market had adjusted gross revenues of \$684,272,954, an increase of \$100,587,419 from the previous fiscal year, with \$147,118,685 in fees paid to the state.

The riverboat casinos in Kenner, Harvey and Amelia had adjusted gross revenues of \$271,084,593 an increase of \$33,950,167 from the previous fiscal year, with \$58,283,187 in fees paid to the state.

The riverboat casinos in East Baton Rouge Parish had adjusted gross revenues of \$269,331,937, an increase of \$27,278,669 over the previous fiscal year, with \$57,906,366 in fees paid to the state.

HARRAH'S NEW ORLEANS

The landbased casino in New Orleans generated \$228,270,627 in gaming revenue to the state. This was a \$15,081,929 increase from the previous fiscal year. Harrah's employed 1,916 individuals.

RACETRACK GAMING

Slot machine gaming at the racetracks adjusted gross revenue for FY 2021-2022 was \$329,876,353, an increase of \$8,389,738 from the previous fiscal year. After subtracting the Support Contribution Deduction of \$59,377,742 for Purse Supplements, Executive Committee of the Louisiana Thoroughbred Breeders' Association, and Executive Committee of the Louisiana Quarter Horse Breeders Association, the State received fees in the amount of \$50,042,243. There were 1,247 individuals employed at the racing facilities.

VIDEO POKER

As of June 30, 2022, there were 1,433 video poker outlets and 12,143 devices in the 31 parishes where video poker gaming had been approved in the local option election of November 5, 1996. These machines are authorized in bars, restaurants, hotels, off-track betting parlors, and truckstops. Franchise fees to the state from video poker amounted to \$250,575,185 for FY 2021- 2022, an increase of \$17,323,091 from the previous fiscal year.

FANTASY SPORTS

Act 141 of the 2020 Regular Legislative Session was signed by Governor Edwards on June 9, 2020. This piece of legislation provided the regulatory structure and laws for the operation of fantasy sports. It required the Louisiana Gaming Control Board to institute rulemaking procedures no later than August 1, 2020. During the Boards July 16, 2020 meeting, the Board approved the institution of rulemaking for Fantasy Sports. The Board, State Police Gaming Division, and the AG's Gaming Division worked diligently to promulgate rules and facilitate the applications for fantasy sports operations in Louisiana. Emergency rules were not authorized in the legislation. Therefore, in order to comply with the Administrative Procedures Act and due to substantive changes, the rulemaking process took from July 16, 2020 until February 20, 2021.

Fantasy Sports went live on July 15, 2021. The State of Louisiana levies a tax of 8% upon the net revenues of fantasy sports contest offered to the consumers within the state. From July 2021 through June 2022, the Gross Fantasy Sports Contest Revenues are \$20,089,294, net revenue is \$2,176,486 and \$174,119 was paid in taxes.

SPORTS WAGERING

On June 10, 2021, the Louisiana State Legislature approved legislation establishing a licensing framework for retail and online sports betting in the fifty-five Louisiana parishes that voted to authorize sports betting in the November 2020 election.

During the 2021 Regular Session, the Louisiana Legislature adopted Act 440, which directs the Gaming Control Board to adopt emergency rules for the promulgation of the initial administrative rules pertaining to sports wagering that shall be considered to constitute a matter of imminent peril to public health, safety, and welfare. The rules codify Acts 80, 435, and 440 of the 2021 Regular Legislative Session and Act 215 of the 2020 Regular Legislative Session that enact the Louisiana Sports Wagering Act and authorize the conducting, application, licensing, permitting, enforcement, collection of fees and taxes, and regulation of racehorse wagering and sports wagering.

The Gaming Control Board determined that the Emergency Rules were necessary to comply with the legislative mandate in Act 440 of the 2021 Regular Session of the Louisiana Legislature. This Emergency Rules became effective August 23, 2021.

The State of Louisiana levies a 10% tax upon the net gaming proceeds from sports wagering conducted onsite at a licensed sports wagering establishment. Any sports wagering conducted through mobile application or a website on the premises of a licensed sports wagering establishment is taxed at a 15% tax rate. After deposit into the State Treasury, the state treasury credits the following amounts into the following funds:

- o 2% of the monies collected or \$500,000, whichever is greater, shall be credited to the Behavioral Health and Wellness Fund.
- o 25% of the monies collected, not to exceed \$2 million dollars, shall be credited to the Louisiana Early Childhood Education Fund.
- 10% of the monies collected shall be credited to the Sports Wagering Local Allocation Fund.
- o 2½ % of the monies collected shall be credited to the Sports Wagering Purse Supplement Fund.

Retail Sports Wagering went live in October of 2021. From November of 2021 through June of 2022, there were \$240,480,752 wagers written. The net proceeds were \$22,941,014 and \$2,383,517 were paid in taxes. The win percentage was 9.5%.

Mobile Sports wagering went live in January of 2022. From January of 2022 through June of 2022, there were \$899,637,922 wagers written. The net proceeds were \$72,486,268 and \$11,652,756 were paid in taxes. The win percentage was 8.1%.

INDIAN GAMING

This report contains limited statistical information on tribal gaming. None of the three tribes are required to pay any fees directly to the state nor can they be required to provide the Gaming Control Board with any financial figures. All of the tribes make contributions to local governments in their respective locations. The Board does wish to acknowledge the Chitimacha Tribe in Charenton for its continued cooperation in voluntarily providing the information shown in this and previous reports.

CONCLUSION

Gaming revenue continues to be a substantial part of the Louisiana economy, generating \$764,951,279 for FY 2021-2022, an increase of \$74,581,818 from the previous fiscal year.

The revenue generated from gaming operations funds various programs in the state and is a primary source of funding for the Support Education in Louisiana Fund (SELF). Any decline in revenue or changes in statutory dedications could adversely affect the SELF fund.

The Louisiana Legislature adopted public policy approving gaming as an economic opportunity for the state and its citizens. The Gaming Control Board is committed to the thorough regulation and control of gaming activities under its jurisdiction in a manner which instills public confidence and ensures that regulated activities are free from criminal and corruptive elements. Additionally, the Board strives to foster a regulatory environment that provides optimum economic opportunity for both gaming operations and the Louisiana citizens who are employed by and/or benefit from this industry.

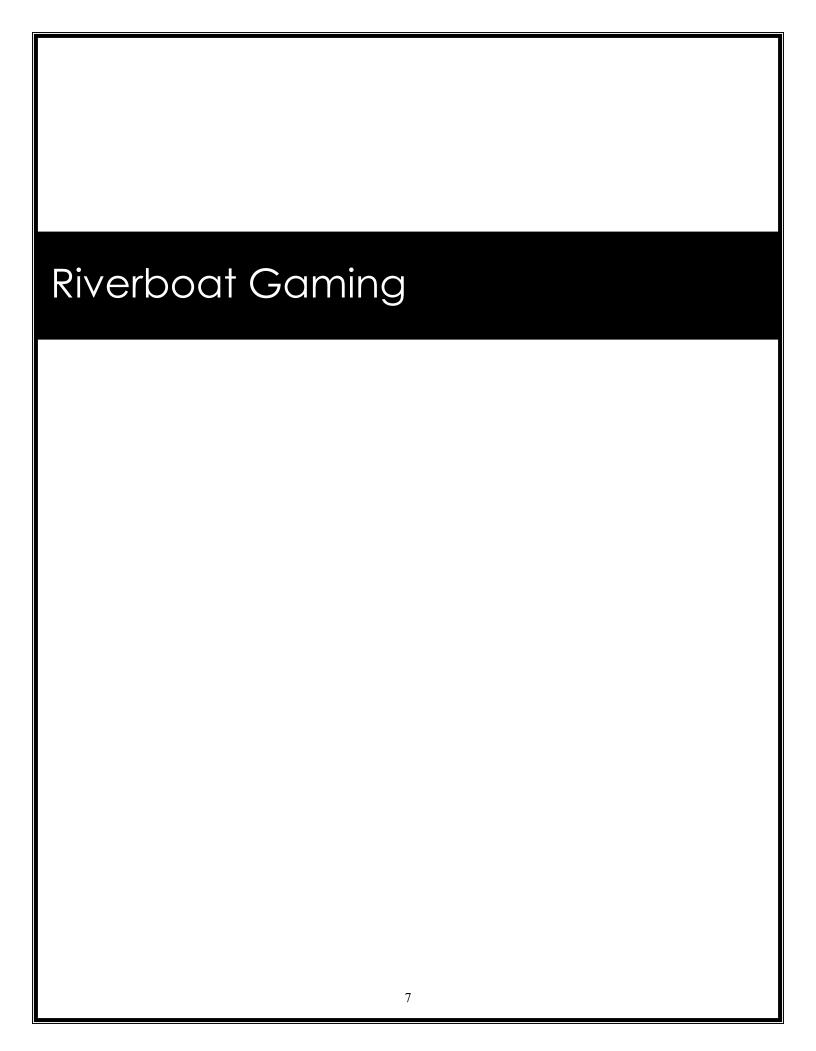

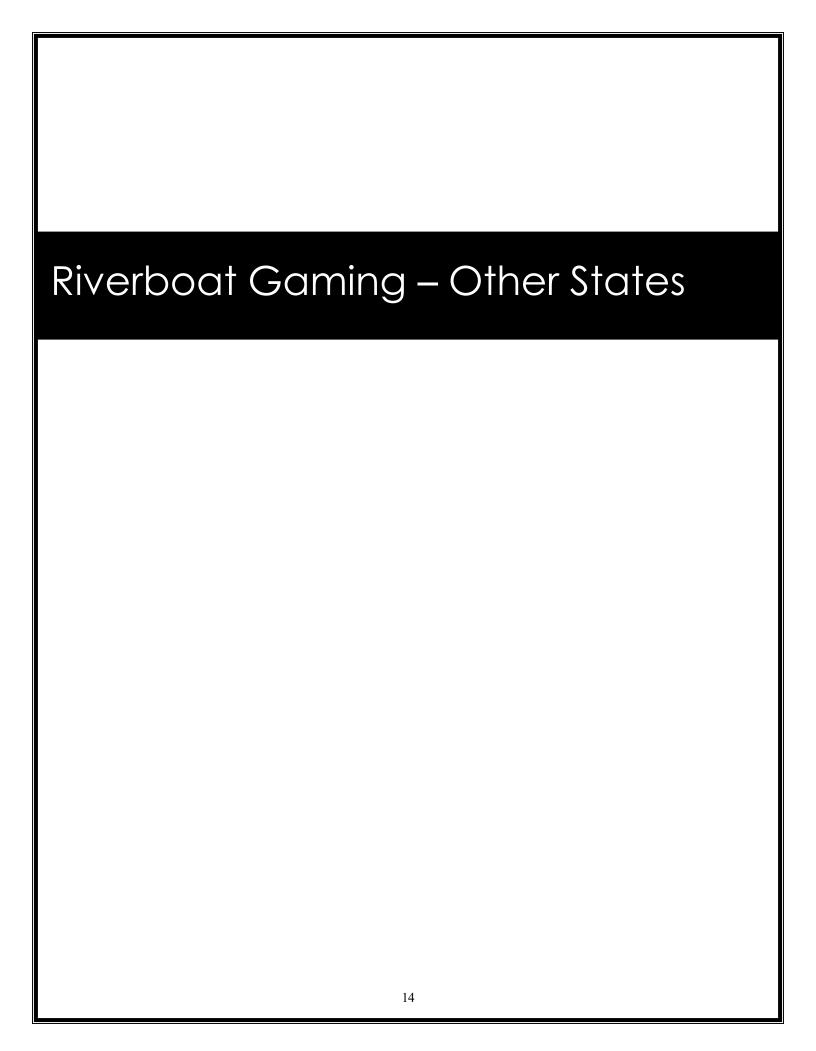

The IGB ensures the integrity of the gaming operations through the regulatory oversight and the licensing of gaming operations and personnel. 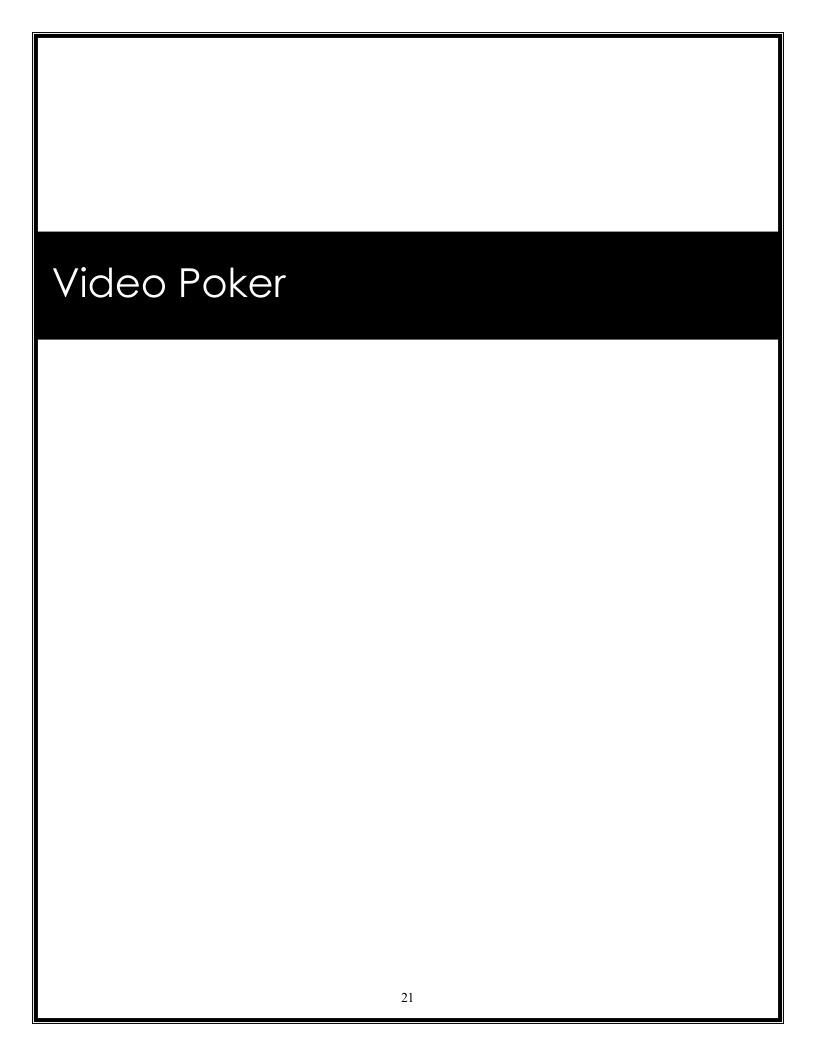

Montana legalized and implemented video poker in 1985. Its Legislature enacted a 15% tax on video gambling machines in 1987. Currently, an individual video gambling machine permit fee is \$240 for the full fiscal year. That amount is reduced each subsequent quarter by a pro-rated amount. Approximately 41% of the fee goes to the local government where the machine is located, and the balance goes to the Gambling Special Revenue Fund.

Montana has more than 1,400 licensed gambling operators and locations that offer more than 16,000 video gambling machines to the public. There are legal gambling establishments in every county in the state.

In November 1984, voters approved an amendment to the Oregon Constitution requiring the establishment and operation of a state lottery. Since then, the Oregon Lottery has become a critical funding source for important Oregon programs, and serves as both a public trust and a market-driven business. 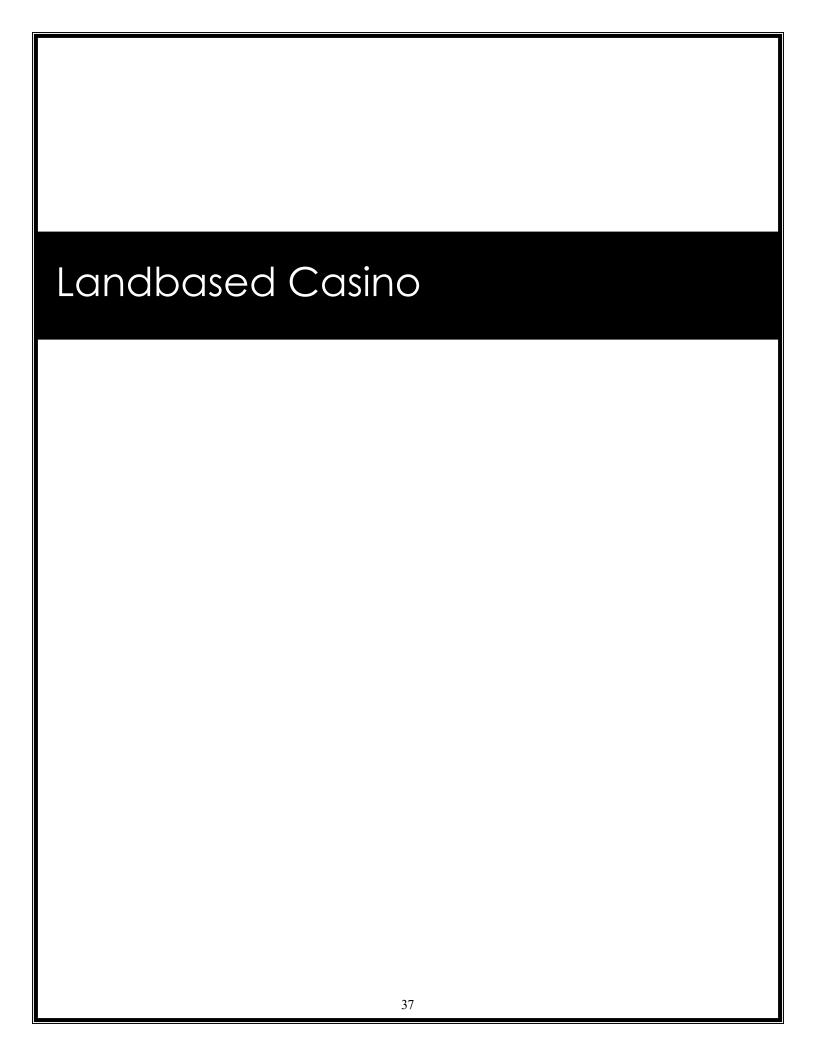

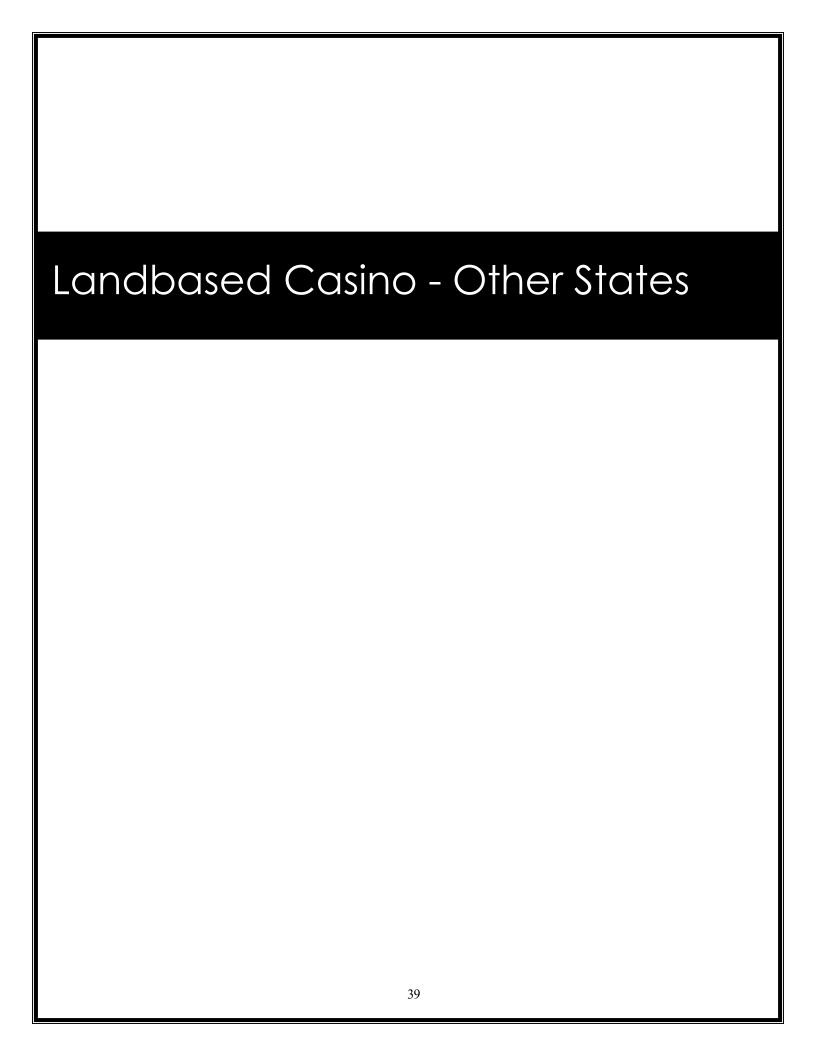

Extended Limited Gaming Distributions

On July 2, 2009, Colorado casinos began to allow \$100 maximum bets, offer the games of craps and roulette, and remain open 24 hours a day, 7 days a week, as the result of an amendment to the State's Constitution approved by Colorado voters on November 4, 2008. This amendment earmarks the distribution of the additional gaming tax revenue generated as a result of the increase bet amount, games and hours in the following manner:

- 78% to the States Public Community Colleges, Junior Colleges and Local District Colleges
- 12% to Gilpin and Teller Counties, based on the proportion of gaming tax revenues that are paid by casinos operating in each county, as a result of the increased bet amount, games and hours
- 10% to the cities of Central City, Black Hawk, and Cripple Creek, based on the proportion of gaming tax revenues that are paid by casinos operating in each city, as a result of the increased bet amount, games and hours.

The Kansas Expanded Lottery Act ("KELA") was enacted in 2007. KELA authorized the Kansas Lottery to own and operate casino gaming in four "gaming zones." Through a competitive bid process, the Kansas Lottery now holds contracts with companies that manage the State's casino games in all four gaming zones. All four casinos are now fully open to the public and generating revenue for the State, Local Governments, Problem Gambling and Addictions Grant Fund, and Casino Managers. Fiscal Year 2022 revenues and transfers are noted below.

C. Monthly Percentage Fee (NRS 463.370)

D. Live Entertainment Tax (NRS 368A)

Restricted licensees are subject to a Live Entertainment Tax if all of the following three criteria are met:

- 1. Live entertainment is offered on the premises.
- 2. An admission charge or drink minimum is collected.

3. The facility in which the live entertainment is provided has a maximum seating/occupancy capacity of at least 200 as determined by the state fire marshal or other official.

The tax is paid quarterly and is payable on or before the 10th day of the month following the end of the preceding calendar quarter.

Non-restricted licensees who have more than 50 slot machines, more than 5 games or any combination thereof and offer live entertainment in a facility with a maximum occupancy/seating of less than 7,500 are subject to a Live Entertainment Tax. For non-restricted locations that license less than 51 slot machines, less than 6 games or any combination thereof, the tax applies only if entertainment is provided in a facility with a maximum occupancy/seating of at least 200 and an admission charge is collected.

The tax rate is 10% of all amounts paid for food, refreshment, merchandise, and admission or similar charges while in live entertainment status. Live entertainment status commences either at the time entertainment starts or at the time when any charge such as admission, entertainment fee, minimum, cover, or similar charge is paid, whichever is earlier. Non-restricted licensees who offer live entertainment in an area with a maximum occupancy/seating of at least 7,500 are subject to a 5% tax on admission sales only.

Non-restricted licensees who offer live entertainment in an area with a maximum occupancy/seating of at least 7,500 are subject to a 5% tax on admission sales.

The tax for non-restricted licensees is payable on or before the 15th day of each month covering the preceding calendar month.

II. "RESTRICTED" Gaming License: Issued for the operation of not more than 15 slot machines and no other games.

Oversight by the Division includes investigations, inspection, audit and criminal regulatory prosecution. The Commission also handles appeals of decisions of or penalties imposed by the Division.

Internet Gaming

Internet Gaming commenced on November 26, 2013, in accordance with P.L. 2013, c.27, effective February 26, 2013. This law authorizes internet gaming in New Jersey for a period of ten years following the operative date of the law as determined by the Division. The operative date was November 25, 2013.

Use of Funds

New Jersey law requires that the state tax 8% on casino gross revenue (table game & slots), 15% on Internet gross revenues, 8.5% on brick and mortar sports wagering, and 13% on online sports wagering. Tax revenue from the casinos shall be used for programs aiding senior citizens and the disabled including a pharmaceutical drug assistance program, an annual cash credit toward utility costs, a transportation assistance program and others.

The Pennsylvania Gaming Control Board is tasked to oversee all aspects of the state's casino industry with the administrative cost of regulation borne directly by applicants and licensed operators. At present, 12 casinos are in operation, offering both slot machine play and table games. With passage of Act 42 in October 2017, casinos may offer sports wagering and iGaming.

Gaming revenue has delivered property tax reductions for all Pennsylvania homeowners, and provided funding needed for the Commonwealth's horse racing industry, fire companies, water/sewer projects, and the state's General Fund. The casino industry also provides a stream of tax revenue to local governments for community projects.

There are a total of 18 land based gaming licenses available in Pennsylvania. Each horse racing (7) or standalone (5) venue is authorized to operate up to 5,000 slot machines and 250 table games. Each resort licensee (2) is authorized to operate up to 850 slot machines and 65 table games. Category 4 "mini-casinos" (4) may operate up to 750 slot machines and 40 table games.

The tax rate is defined by SDCL 42-7B-28 and 42-7B-28.1 and totals 9% of the adjusted gross revenue. SDCL 42-7B-28.1, 42-7B-48, 42-7B-48.1, 42-7B-48.3 establish the distribution structure of these taxes collected.

Per 42-7B-28.1, 1% of the adjusted gross revenue goes directly to the State General Fund.

According to 42-7B-48, 8% of the adjusted gross revenue is distributed as follows:

- 40% of the tax is transferred to the Department of Tourism
- 10% is paid to Lawrence County
- 50% stays in the Commission fund

In addition, each device which includes both table games and slot machines is assessed an annual device fee of \$2,000.00 payable before July 1 of each year. These device fees, all licensing fees and all other miscellaneous revenue received by this office are deposited with the state treasury in the Commission fund.

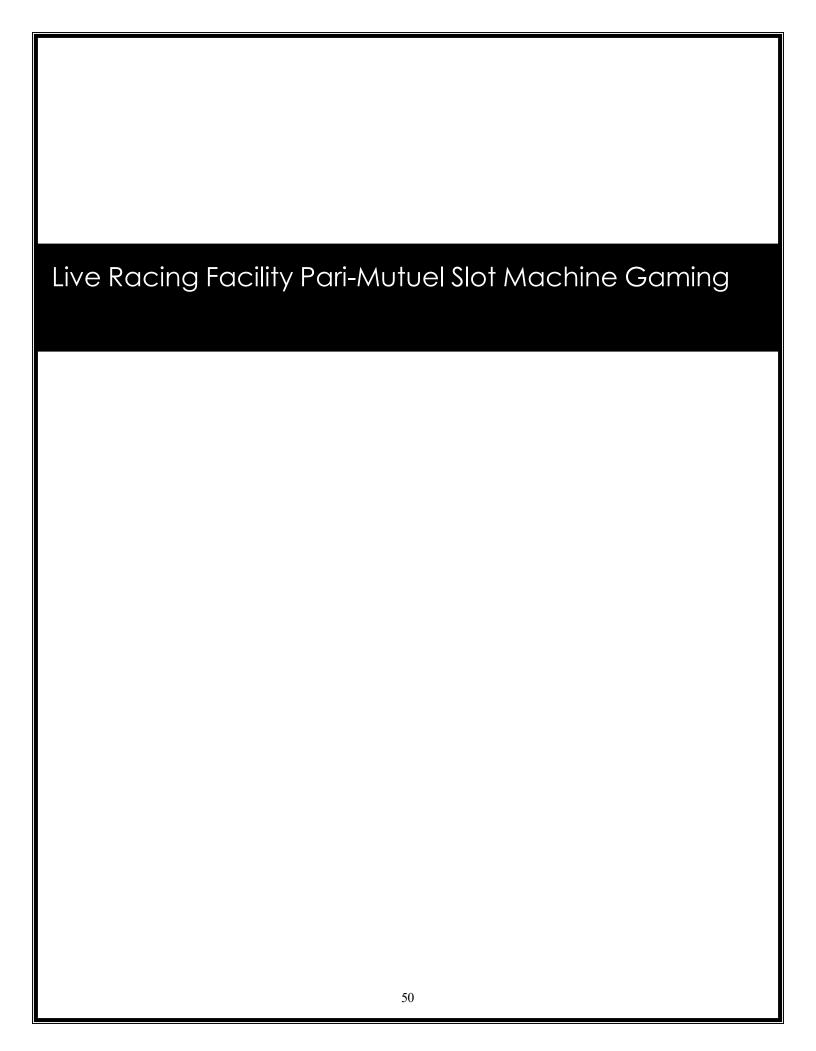
When the net municipal proceeds paid to the City of Deadwood reach \$6,800,000 and in accordance with SDCL 42-7B-48.1, the distribution of funds in excess of this amount changes to:

- 70% of the excess was transferred to the State's general fund
- 10% was distributed to other municipalities in Lawrence County (pro rata according to population
- 10% was distributed to school districts in Lawrence County (pro rata based upon the previous year's average daily membership)
- 10% to the City of Deadwood

Per 42-7B-48.2, the amount which is distributed to the school districts is offset by a dollar for dollar reduction in state aid which the district receives.

LIVE RACING FACILITY PARI-MUTUEL SLOT MACHINE GAMING

LOUISIANA

By Act 721 of the 1997 Regular Session, the Legislature authorized slot machine gaming at live horse racing facilities in St. Landry, Bossier, and Calcasieu Parishes. Voters approved slot machine gaming in those parishes and taxing districts have been authorized and established.

By Act 352 of the 2003 Regular Session, the Legislature authorized limited slot machine gaming at the eligible facility in Orleans Parish. By Act 591 of the 2006 Regular Session, the Legislature authorized a maximum of seven hundred slot machines at the eligible facility in Orleans Parish.

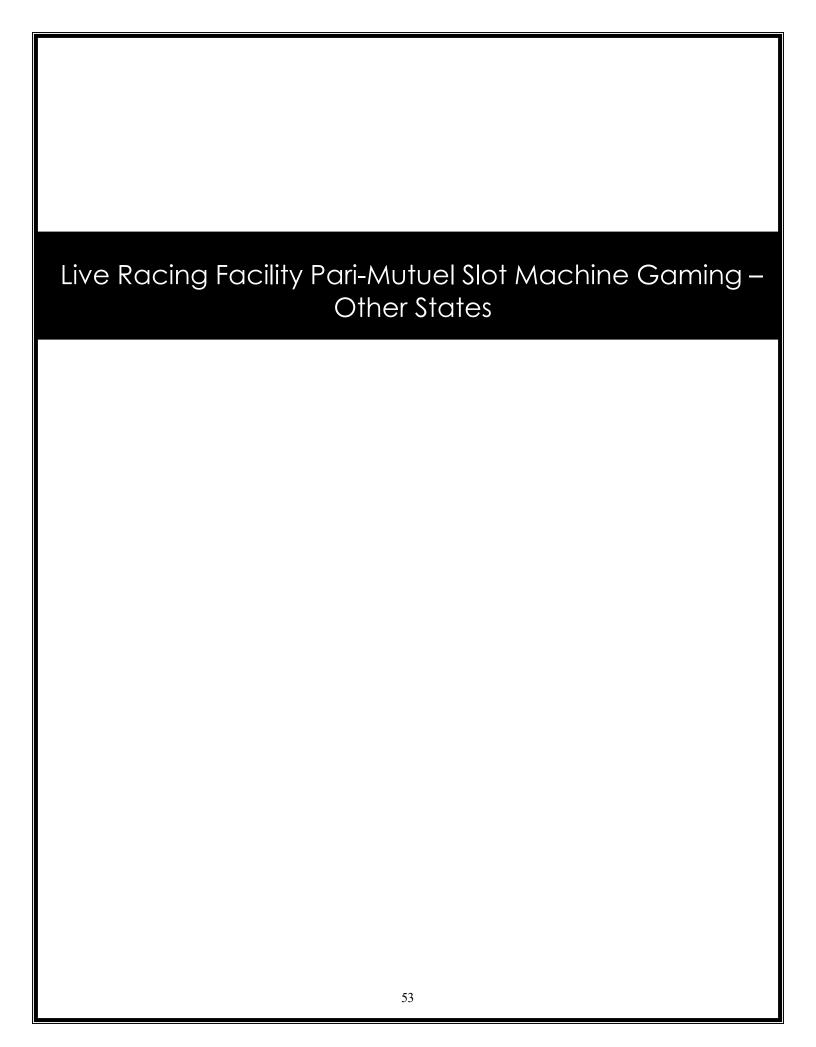
Slot machine gaming at Delta Downs in Calcasieu Parish commenced on February 13, 2002. Harrah's Racetrack & Casino in Bossier Parish commenced slot operations on May 21, 2003. Evangeline Downs in St. Landry Parish opened for slot machine gaming on December 19, 2003. Slot machine gaming at the Fair Grounds commenced operation in a temporary facility on September 19, 2007, with the permanent facility opening on November 7, 2008.

Electronic games of skill at horse racing tracks were authorized in March 2005, approved by local referendum in November 2005, and regulated by the Arkansas Racing Commission. The first machines began operating at Southland Park in West Memphis and Oaklawn Park in Hot Springs in November 2006. Both tracks offer Instant Racing, which is pari-mutuel wagering based on historic races; those games are not included in these figures.

In Florida, pari-mutuel wagering is authorized for horse racing, harness horse racing, quarter horse racing, greyhound racing, jai alai games, and cardroom poker games. Additionally, slot machine gaming at pari-mutuel facilities is authorized in Broward and Miami-Dade Counties. Florida is one of the primary pari-mutuel states in the nation, and is the leading state in greyhound racing, as well as a major horse racing state. Florida is also the only state in the United States where live jai alai games are conducted. As of June 30, 2020, there were 30 parimutuel facilities located throughout the state, with one of the facility's holding both limited intertrack wagering and pari-mutuel wagering.

Agent Commission: The portion of Net Win to the casino operator as compensation for operating the gaming

facility. Most operating expenses of the gaming facility are paid from the agent commission (including horseracing subsidies), with the exception of the gaming floor

itself, which is provided by the other vendors and paid for by the Lottery.

Marketing Allowance: The portion of the Net Win paid to the casino operator to finance the cost of advertising,

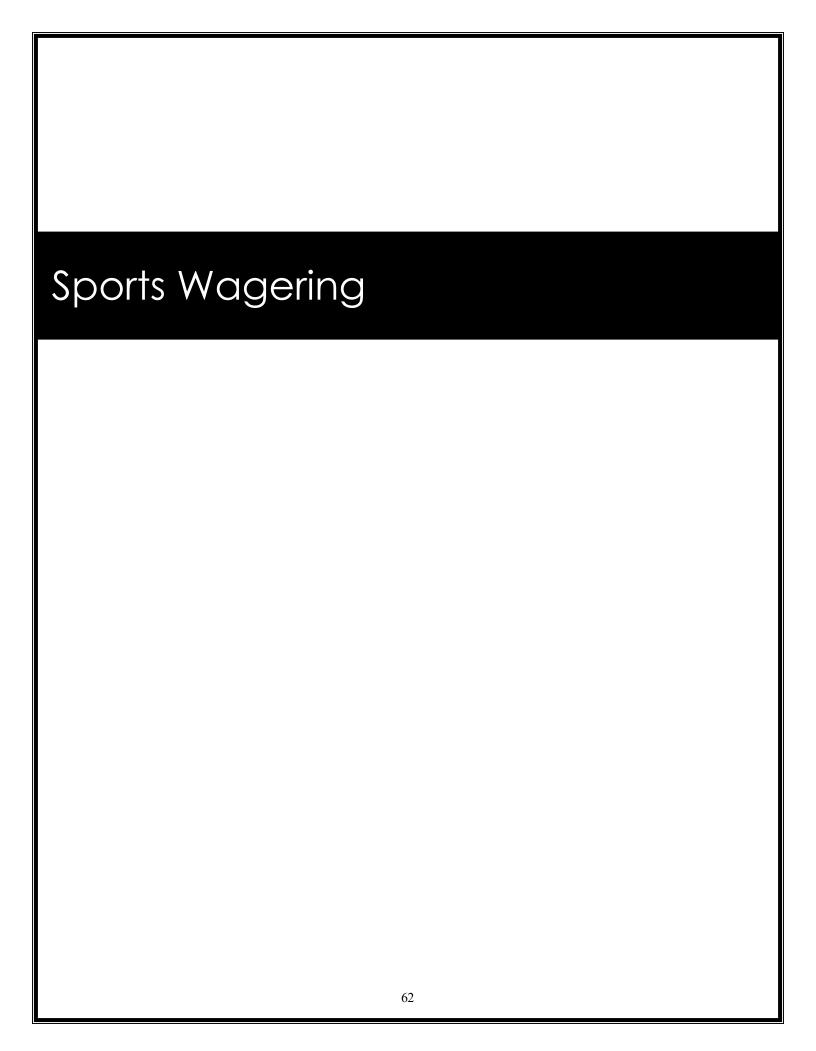

SPORTS WAGERING

LOUISIANA

Overview

From 1992 to 2018, the Professional and Amateur Sports Protection Act, also known as PASPA or the Bradley Act, was a law which effectively banned sports betting nationwide, excluding a few states. In May of 2018, the United States Supreme Court determined that PASPA was unconstitutional in that it conflicted with the Tenth Amendment of the U.S. Constitution. In the aftermath of the Supreme Court's ruling, numerous states, including Louisiana, proceeded to establish legalized sports betting.

Pursuant to Act 215 of the 2020 Louisiana Regular Legislative Session, voters in each parish considered a proposition to allow sports wagering activities and operations in their parish. The election was held on November 3, 2020. Fifty-five (55) out of sixty-four (64) parishes in Louisiana voted in favor of allowing sports wagering in their respective parishes, with the voters of Caldwell, Catahoula, Franklin, Jackson, LaSalle, Sabine, Union, West Carroll, and Winn voting no on the proposition.

Pursuant to La. R.S. 27:601 et seq., The Louisiana Sports Wagering Act, grants the Louisiana Gaming Control Board (the "Board") complete authority, control, and jurisdiction with respect to the regulation of sports wagering in the state of Louisiana. Although not yet operating, La. R.S. 47:9001 et seq., establishes regulatory authority of the Louisiana Lottery Corporation to operate a sports book to allow sports wagering at retail establishments. In accordance with the Act, the Board has developed qualifications, standards, processes and procedures for the issuance and renewal of a license to operate a sports book. A summary of the framework of the Act is provided below.

Sports Wagering Related Licenses and Permits:

Sports Wagering License

- The initial application fee for a sports wagering license is \$250,000 and is nonrefundable.
- The license fee for a sports wagering license issued is \$500,000.
- The license is for a term of five years.
- The license fee shall be submitted on the anniversary date of the issuance of the license every five years.

Sports Wagering Platform Provider Permit

- The initial application fee for a sports wagering platform provider permit is \$100,000 and is nonrefundable.
- The permit fee for a sports wagering platform provider permit issued is \$250,000.
- The permit is for a term of five years.
- The permit fee shall be submitted on the anniversary date of the issuance of the permit every five years.

Sports Wagering Service Provider Permit

- The initial application fee for a sports wagering service provider permit is \$10,000 and is nonrefundable.
- The permit fee for a sports wagering service provider permit issued is \$12,500.
- The permit is for a term of five years.
- The permit fee shall be submitted on the anniversary date of the issuance of the permit every five years.

Sports Wagering Distributor Permit

- The initial application fee for a sports wagering distributor permit is \$5,000 and is nonrefundable.
- The permit fee for a sports wagering distributor permit issued is \$2,500.
- The permit is for a term of five years.
- The permit fee shall be submitted on the anniversary date of the issuance of the permit every five years.

State Taxes and Funds:

State Taxes

- The State of Louisiana levies a 10% tax upon the net gaming proceeds from sports wagering conducted onsite at a licensed sports wagering establishment.
- Any sports wagering conducted through mobile application or a website on the premises of a licensed sports waging establishment is taxed at a 15% tax rate.
- All taxes collected are forwarded to the state treasurer for immediate deposit into the state treasury. Funds deposited into the treasury shall first be credited to the Bond Security and Redemption Fund.

Funds

- After deposit into the State Treasury, the state treasury credits the following amounts into the following funds:
 - o 2% of the monies collected or \$500,000, whichever is greater, shall be credited to the Behavioral Health and Wellness Fund.
 - o 25% of the monies collected, not to exceed \$2 million dollars, shall be credited to the Louisiana Early Childhood Education Fund.
 - o 10% of the monies collected shall be credited to the Sports Wagering Local Allocation Fund.
 - o 2½ % of the monies collected shall be credited to the Sports Wagering Purse Supplement Fund.

Sports Wagering Requirements and Prohibitions

- A person placing a wager shall be at least 21 years of age.
- A person must be physically located in a parish that has approved a proposition authorizing sports wagering.
- A person must have a wagering account established with the operator, if the player is

attempting to place the sports wager through a website or a mobile application.

- A person must not be prohibited from wagering with the operator by law, rule, policy of the operator or self exclusion.
- No sports wagers may be accepted or paid by an operator on any of the following:
 - o On any sport or athletic event not authorized by law or the board.
 - On any sport or athletic event which the operator knows or reasonably should know are being placed by or on behalf of an athlete, coach, referee or other official, or staff of a participant or team that is participating in that event.
 - On the occurrence of injuries or penalties, or the outcome of an athlete's disciplinary rulings, or replay reviews.
 - o On other types, forms, or categories of wagering prohibited by the board by rule.

Louisiana Sports Wagering Licensees and Sports Wagering Platform Providers

The Board may award twenty (20) sports wagering licenses to eligible applicants which, during the initial licensing phase, includes riverboat licensees, slots-at-the track licensees, and the land-based casino operator. The licensees may operate the sportsbook or contract with a sports wagering platform provider to operate the sportsbook. In November of 2021, retail sports wagering became live in Louisiana, with mobile sports wagering following on January 28, 2022. During the 2021-2022 fiscal year, the following licensees and their respective platform providers have been awarded licenses and permits to conduct sports wagering in Louisiana.¹

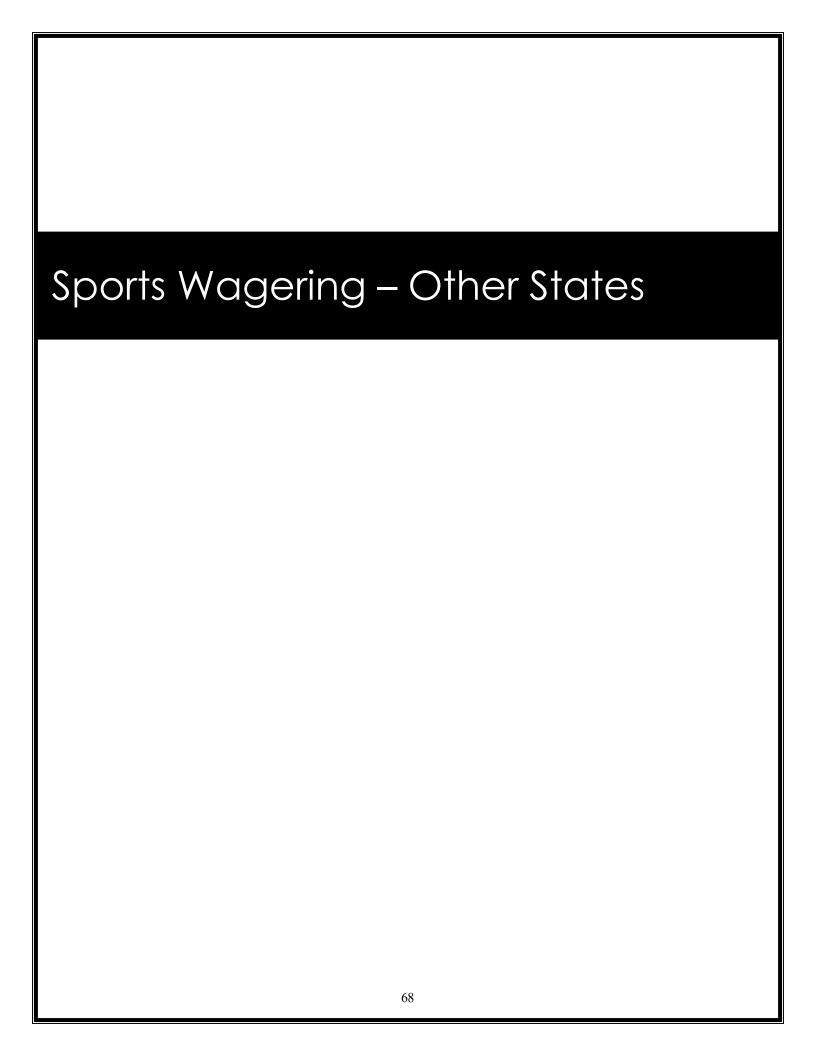

Working in collaboration with the gaming industry, Colorado legislators, and stakeholders, the Division of Gaming implemented several new legislative changes impacting the gaming and sports betting industries. FY22 saw the first year results from the implementation of Amendment 77, which removed betting limits and introduced new games, with taxes collected on limited and extended gaming activities increasing by \$41,523,933, or 34%, over FY21. Another notable legislation impacting the gaming industry was the passage of HB22-1402 to develop a gaming grant program to promote responsible gaming in the state with an appropriation of \$2.5 million to create a responsible gaming cash fund to be distributed through grants to organizations and agencies working on responsible gaming programs in Colorado.

Fiscal year 2022 saw the adjusted gross revenue generated from sports wagering increase to a little over \$610 million, a 60.7% increase from fiscal year 2021.

The table below provides a summary of sports wagering statistics in its first three fiscal years in Illinois. As shown, nearly 369 million wagers have been made during this time. Over \$13.6 billion in bets have been handled with \$12.6 billion in payouts. This results in nearly \$1 billion in adjusted gross receipts from sports wagering, thereby generating approximately \$92 million in tax revenues

The FY 2022 figures benefitted from recent changes to the industry. Originally, State law required online sportsbook registrations for bettors to be completed in-person. After temporarily suspending, then reinstating in-person registration twice over the course of FY 2021, Governor Pritzker permanently waived the in-person requirement in March 2022 ahead of the NCAA men's basketball tournament. This has allowed new bettors to enter the sports wagering foray, mostly as mobile customers through sportsbook applications. In addition, P.A. 102-0689 modified the original law by allowing bettors to wager on a sports event involving an Illinois collegiate team, but only if it is done in-person at an Illinois sportsbook. This provision is set to expire on July 1, 2023.

LOUISIANA

Overview

During the 2018 legislative session, the Louisiana legislature enacted Act 322, which began the process for legalizing and regulating fantasy sports contests and called for a statewide referendum on the measure in Louisiana. Pursuant to the November 2018 election, forty-seven (47) of the sixty-four (64) parishes in Louisiana voted in favor of fantasy sports in their respective parishes, with the voters of Allen, Avoyelles, Beauregard, Caldwell, Catahoula, Franklin, Grant, Jackson, Jefferson Davis, LaSalle, Morehouse, Richland, Sabine, Union, Vernon, West Carroll, and Winn voting no on the referendum. The measure was approved by Louisiana's most populated urban parishes including New Orleans, Baton Rouge and Lafayette, among others, bringing legal fantasy sports to more than 90% of the state's population. However, the referendum only authorized lawmakers to introduce legislation legalizing daily fantasy sports. It was not until 2020, when the Louisiana legislature passed Act 141 during the 2020 Regular Session, Act 34 of the 2020 First Extraordinary Session, and Act 44 of the 2020 Second Extraordinary Session, that the tax structure and the creation of a regulatory framework for daily fantasy sports began.

Pursuant to La. R.S. 27:301 et seq, the Louisiana Fantasy Sports Contest Act, the Louisiana Gaming Control Board (the "Board") was granted all regulatory authority with respect to fantasy sports contests. Based on the legislation, the Board promulgated rules in the Louisiana Administrative Code ("LAC") which provided the structure necessary to properly regulate, enforce, and administer the operation of fantasy sports contest in Louisiana. A summary of the regulatory framework for daily fantasy sports is provided below.

Fantasy Sports Contest Operator

- Before obtaining a license to offer fantasy sports contests in this state, a fantasy sports contest operator must:
 - O Be a person domiciled in Louisiana; or a domestic business entity with a certificate of existence from the secretary of state and in good standing; or a foreign corporation with a certificate of authority to transact business in this state from the secretary of state and in good standing.
 - o Demonstrate to the board that the operator is suitable for licensing pursuant to R.S. 27:28.
 - o Provide the board with financial statements indicating any gross fantasy sports contest revenue for the previous three years.

Fantasy Sports Contest Operator License

- The initial application fee is \$1,000 and is non-refundable.
- The license fee for a fantasy sports contest license shall be submitted to the Louisiana State Police, Gaming Enforcement Division prior to the issuance of the license.

- Each license is granted for a term of three years.
- The license fee shall be as follows:
 - o If the three-year average of the licensee's gross fantasy sports contest revenue is less than \$100,000 or the licensee has no previous revenue, the fee shall be \$5,000.
 - o If the three-year average of the licensee's gross fantasy sports contest revenue is \$100,000 or more, but less than \$300,000, the fee shall be \$15,000.
 - o If the three-year average of the licensee's gross fantasy sports contest revenue is more than \$300,000, the fee shall be \$40,000.
- The renewal fee for a fantasy sports contest license shall be submitted on the anniversary date of the issuance of the license and shall be assessed in the same manner as the original license fee was assessed.

State Taxes and Fund

- The State of Louisiana levies a tax of 8% upon the net revenues of fantasy sports contest offered to the consumers within the state.
- All taxes imposed and collected are forwarded upon receipt to the state treasurer for the immediate deposit into the state treasury.
- Funds deposited are first credited to the Bond Security and Redemption Fund in accordance with the Louisiana Constitution.
- Afterward, the state treasurer deposits the proceeds of the tax into the Louisiana Early Childhood Education Fund.

Fantasy Sports Contest Prohibitions

- As a condition of licensure, a fantasy sports contest operator shall submit evidence to the board that the operator has established and will implement commercially reasonable procedures for fantasy sports contests with an entry fee and shall do the following:
 - Ensure that any of following persons do not participate in fantasy sports contests:
 - Athletes and individuals who engage in or officiate a game or competition that is a real-world sport or athletic event that is the subject of a fantasy sports contest.
 - Any sports agent, team employee, referee, or league official associated with a real-world sport or athletic event that is the subject of a fantasy sports contest.
 - o Verify that a fantasy sports contest player is 21 years of age or older.
 - Provide fantasy sports contest players with access to information on responsible play.
 - o Provide fantasy sports contest players with access to the fantasy sports contest player's play history and account details that are not confidential.
 - O Allow individuals to restrict themselves from entering a fantasy sports contest upon request and provide reasonable steps to prevent the person entering fantasy sports contests offered by an operator.
 - Segregate fantasy sports contest player funds from operational funds or maintain a
 reserve that exceeds the amount of player funds on deposit, which may not be
 used for operational activities. Reserve funds may take the form of cash, cash

equivalents, payment process reserves, payment processor receivables, an irrevocable letter of credit, a bond, or a combination thereof, in the amount that must exceed the total balances of the fantasy sports contest players' accounts.

Fantasy Sports Contest Operators in Louisiana

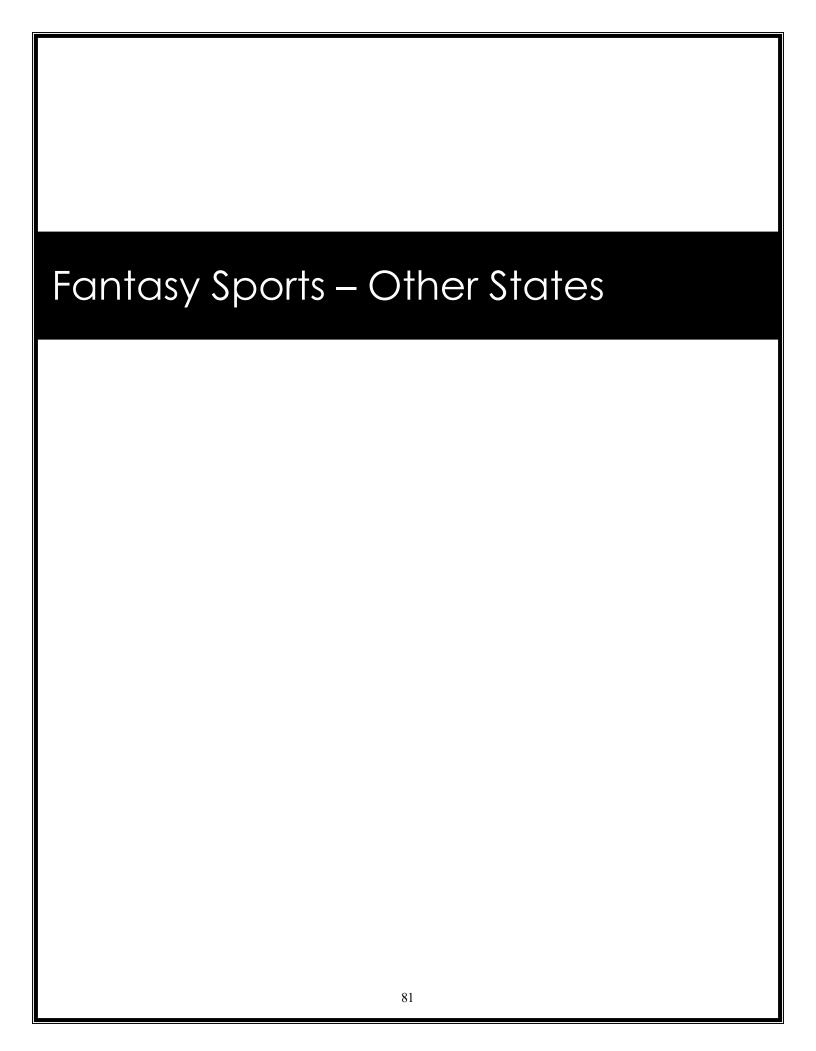
On July 15, 2021, the Board awarded DraftKings a fantasy sports contest operator license. In doing so, it allowed DraftKings to launch its operations in the 47 parishes that allowed fantasy sports contests in their respective areas. On October 21, 2021, the Board approved the license application of Fanduel, a competitor of DraftKings and the second fantasy sports contest operator to be licensed in the state of Louisiana. Both companies submitted to background investigations and financial examinations by the Louisiana State Police, Gaming Enforcement Division (the "Division") in connection to their licensing applications. The Division ensures that both operators are in compliance with all gaming regulations and law, specifically those related to daily fantasy sports.

Arizona Department of Gaming ("ADG") was charged with regulating and enforcing Fantasy Sports for the first time in fiscal year 2022, due to legislation passed in April of 2021. The signing of House Bill 2772 and amended Tribal-State Gaming Compacts directed the ADG to adopt rules and act as the primary regulator and enforcement body for event wagering and fantasy sports contests. Additionally, this legislation required event wagering & fantasy sports contests providers to provide help for those who may have a problem with gambling, as well as allows individuals to exclude themselves from these new forms of legal wagering statewide. Throughout fiscal year 2022, the ADG worked diligently with the public & stakeholders to complete the necessary regulations to efficiently and responsibly set up these new industries in just 147 days. Pursuant to the Arizona state law and regulations, fantasy contest operators must pay an initial license fee of \$2,000. Licenses may be renewed every two years for a fee of \$1,000. For fiscal year 2022, the state of Arizona has 10 fantasy sports contest operators and 4 fantasy sports suppliers.

Pursuant to A.R.S § 5-1201(7), "Fantasy Sports Contest Adjusted Revenues" means the amount equal to the total of all entry fees that a fantasy sports contest operator collects from all fantasy sports contest players minus the total of all sums paid out as prizes or awards to all fantasy sports contest players multiplied by the in-state percentage. Additionally, "Entry Fee" means cash or cash equivalent that is paid by a participant to a Fantasy Sports Contest Operator to participate in a fantasy sports contest [A.R.S. § 5-1201(5)].

In Arkansas, daily and season-long fantasy sports are exempt from gambling prohibitions pursuant to ACT 1075 (HB 2550) of the Arkansas 2017 Regular Legislative Session. Act 1075 of 2017 authorizes paid fantasy sports games in Arkansas. Additionally, Act 1075 imposes a special 8% privilege tax based on the game operator's gross paid fantasy sports game revenues collected during the period of the state's previous fiscal year. The gross paid fantasy sports game revenues are the total of all entry fees that a game operator collects from all game participants, less the total of all sums paid out as prizes to all game participants. The remaining balance of revenues is multiplied by the location percent for Arkansas. The location percentage is determined for each paid fantasy sports game and calculated as a percentage of all entry fees collected from game participants located in Arkansas divided by the total of entry fees from all game participants. The special 8% privilege tax is remitted to the Department of Finance and Administration on a quarterly basis through the Arkansas Taxpayer Access Point. Game Operator is a person who is engaged in the business of professionally conducting paid fantasy sports games for cash prizes for members of the general public and requires cash or cash equivalent as an entry to be paid by a member of the general public who participates in a paid fantasy sports game. Game Participant is an individual who participates in paid fantasy sports games offered by the game operator.

On July 26th, 2017, the Delaware Interactive Fantasy Contest Act was signed into law by Governor John Carney. The act permits online wagering by participants located in Delaware on interactive daily fantasy sports contests offered by those internet operators who have registered in Delaware. Interactive fantasy sports contests are games of skill wherein one or more contestants compete against each other by using their knowledge and understanding of athletic events and athletes to select and manage rosters of players whose performance directly corresponds with the actual performance of competitors on sports teams and in sports contests. The Delaware Division of Gaming Enforcement provides the regulatory oversight to ensure the integrity, accountability and public trust of these contests. Companies authorized to provide interactive fantasy sports contests in Delaware are DraftKings, FanDuel, and Yahoo Fantasy Sports.

The fantasy sports contest operators that authorized to provide paid fantasy sports in Indiana are DK Crown Holdings, Inc.; FanDuel, Inc.; Fantasy Sports Shark, LLC d/b/a Monkey Knife Fight; SHGN Acquisition Corp.; Underdog Sports, Inc.; and Yahoo Fantasy Sports, LLC.

During the Iowa 2019 Legislative session, legislation was signed authorizing sports betting and fantasy sports contests in the state under the regulation of the Iowa Racing and Gaming Commission. On October 25, 2019, fantasy sports contests began operating in Iowa. The initial license for fantasy contest operators in the state of Iowa is for a term of three years. After the initial licensing period, the licensee must pay an annual fee of \$1,000 for licensees with a yearly adjusted gross revenue under \$150,000 or \$5,000 for licensees with a yearly adjusted gross revenue of \$150,000 or greater. The two fantasy contest operators authorized to conduct fantasy sports contests in the state of Iowa are DraftKings and FanDuel.

The Mississippi Gaming Commission is tasked with oversight of fantasy sports contests. Fantasy contest operators wishing to offer fantasy contests must obtain a license from the Mississippi Gaming Commission. Each applicant for licensure must pay an application fee of \$5,000. A license is valid for three years. For the privilege of conducting fantasy contests in Mississippi, licensees must pay to the Department of Revenue a fee equivalent to eight percent (8%) of the operator's net Mississippi revenue. The fantasy contest operators authorized to provide fantasy sports in Mississippi are DraftKings Inc.; FanDuel, Inc.; Underdog Sports, Inc.; Yahoo Fantasy Sports, LLC.; and Bid Ventures, Inc. d/b/a Jockmkt.

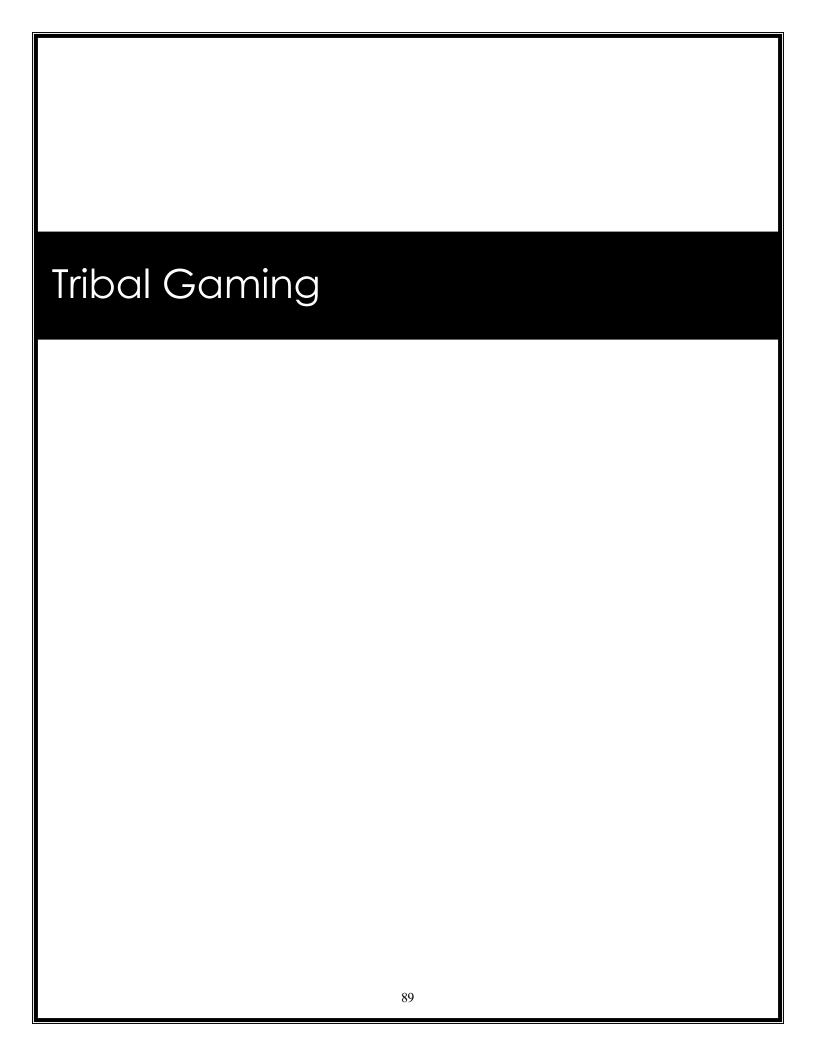

Legislation giving the Ohio Casino Control Commission (the "Commission") oversight of fantasy contests was approved by the Ohio General Assembly in late 2017 and became effective in 2018. The measure gave the Commission the responsibility to license and regulate those conducting fantasy contests. The Commission began accepting license applications in September 2019. Following the appropriate investigations, the Commission approved the first fantasy contest operator licenses in February 2020. There are currently 16 active operators in Ohio. In addition, the Commission has approved several accounting firms to provide the compliance and financial statement audits that are required of licensed fantasy contest operators. Approved firms are eligible to complete audit work for any licensed operator.
