# JOINT MOTION FOR ENTRY OF STIPULATIONS AND APPROVAL OF PROPOSED SETTLEMENT

#### ON THE JOINT MOTION OF:

- 1. the Louisiana Department of Public Safety and Corrections, Office of State Police, (hereinafter "Division"), and
- 2. Promotional Partners Incorporated, Permit No. PO82600583 (hereinafter "PPI"),

who respectfully represent the following:

#### WHEREAS:

- 1. On June 25, 2003 the Louisiana Gaming Control Board issued a Notice of Recommendation of Revocation alleging certain violations of the Louisiana Gaming Control Law. On December 18, 2003, the Louisiana Gaming Control Board issued an Amended Notice of Recommendation of Revocation;
- 2. This matter is scheduled for hearing on January 10, 2005 at 9:00 a.m. before the Honorable William H. Brown; and

NOW THEREFORE, the Division and the PPI hereby propose the following settlement, that:

- 1. In lieu of revocation of its permit, PPI shall surrender its non-gaming supplier permit, with prejudice and it will not be eligible to re-apply for any approval authorized by the Louisiana Gaming Control Law for a period of five years from the date the surrender is accepted;
- 2. PPl stipulates it does not meet the definition of a Minority Business Enterprise or Minority Owned Business as identified in Louisiana gaming regulations. In the event

these Stipulations and Settlement is not approved by the Hearing Officer or Louisiana Gaming Control Board, nothing contained in these Stipulations and Settlement may be used by either PPI or the Division as evidence in the resulting administrative hearing regarding the revocation of PPI's non-gaming supplier permit.

- 3. PPI, Margaret Sims, LeeAnne Leopold, Carol Schafer, Ashley Engerran and August Leopold, Jr. agree not to directly or indirectly, or through any natural or juridical person with which they are affiliated or receive anything of value from, do business, regardless of the monetary amount, with any casino gaming company in the State of Louisiana until such time as their suitability has been determined by the Louisiana Gaming Control Board;
- 4. By their signature on this Stipulations and Settlement, PPI, Margaret Sims, LeeAnne Leopold, Carol Schafer, Ashley Engerran and August Leopold, Jr acknowledge these stipulations and this prohibition;
- 5. PPI shall be allowed to only complete the transactions identified in Exhibit "A";
- 6. Any application by LeeAnne Leopold, August Leopold, Jr. or any entity in which they may have an ownership interest will be judged on its own merits; However, any and all information discovered throughout the course of the PPI investigation may be used in future investigations to determine the suitability of Margaret Sims, LeeAnne Leopold, Carol Schafer, Ashley Engerran or August Leopold, Jr, as well as any natural or juridical person of which they are or become, directly or indirectly, affiliated;
- 7. The form and substance of this settlement are to be interpreted under the laws of the State of Louisiana;
- 8. This settlement constitutes the entire agreement between the Division and PPI pertaining to the subject matter contained herein, and supercedes all prior and contemporaneous agreements, representations, and understandings of the parties;
- 9. This settlement is subject to approval by the Hearing Officer of the Louisiana Gaming Control Board and the Louisiana Gaming Control Board.
- 10. The Division and PPI waive their rights to appeal this settlement if the Order is signed by the Hearing Officer and accepted by the Board.
