COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and Tastee Donuts #59, Inc. d/b/a Tastee #47 (hereinafter "Tastee Donuts #59"), VGL 2600207876, do hereby represent and agree as follows:

WHEREAS, on August 23, 2005, the Louisiana Gaming Control Board issued a Notice of Recommendation of Administrative Action to Tastee Donuts #59, Inc. d/b/a Tastee #47 alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by said Notice of Recommendation of Administrative Action are set for hearing on July 26, 2006, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and Tastee Donuts #59 are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notice of Recommendation of Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:



STIPULATIONS

- 1. Sandra Kruebbe is the President and 100% shareholder of Tastee Donuts #59, Inc. d/b/a Tastee #47.
- 2. Tastee Donuts #59, Inc. d/b/a Tastee # 47, a licensed video gaming establishment, previously entered into a video poker device agreement with Master Video Poker.
- 3. Master Video Poker (MVP) sent video gaming documents ("the Documents") to Tastee Donuts #59, Inc. d/b/a Tastee #47 for execution, including but not limited to the Applicant's Request to Release Information dated May 9, 1996; the Applicant's Request to Release Information dated May 8, 1997; the Applicant's Request to Release Information dated April 30, 1998; the Applicant's Request to Release Information dated April 30, 1999, and the Applicant's Request to Release Information dated June 24, 2002, all signed by Sandra Kruebbe.
- 4. Sandra Kruebbe admits that she relied upon the representations of her device owner, MVP, that there would be a notary present during the time the Documents were completed and signed while on the MVP premises. Sandra Kruebbe admits the identity of the notary was not personally known to her nor did she personally verify there was a notary present to witness her signature on the Documents. However, investigation by the Division revealed that the purported Notary was not a notary. Thus, the Documents were improperly notarized in violation of LAC 42:XI.2405(A)(15).
- 5. Sandra Kruebbe represents that all of the statements, responses, disclosures and representations provided in the documents submitted to the Division bearing her signature are true and correct to the best of her knowledge, information and belief, and represents a complete and accurate account of the requested information.

TERMS AND CONDITIONS

- 1. Within fifteen (15) days of the approval of this settlement by the Louisiana Gaming Control Board, Tastee Donuts #59 shall pay a civil penalty of One Thousand Dollars (\$1000.00).
- 2. The Division hereby agrees to accept the payment of the above stated penalty in full and final settlement of all violations alleged in the August 23, 2005, Notice of Recommendation of Administrative Action.
- 3. Any and all information discovered throughout the course of this or any other investigation may be used in any future determination of the suitability of Sandra Kruebbe, and Tastee Donuts #59, Inc.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Tastee Donuts #59 pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
- 6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

7. If approved, however, payment of the above penalty must be submitted to the Division within (15) fifteen days of approval of this settlement by the Board. The failure to submit the civil penalty within fifteen (15) days of approval by the Board shall result in the immediate suspension of the license until such time as the penalty is paid in full.

I have read this entire Compromise and Settlement Agreement and agree to all stipulations and terms and conditions hereof.
