COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division"), Mojolounge, Inc. d/b/a Mojo Lounge and Louis Maumus, individually, do hereby represent and agree as follows:

WHEREAS, the Division has issued a Notice of Recommendation of Revocation to Mojolounge, Inc. d/b/a Mojo Lounge alleging certain violations of Louisiana Gaming Control Law, as well as a Notice of Recommendation of Finding of Unsuitability to Louis Maumus; and

WHEREAS, the issues raised by the said Notices of Recommendation of Revocation and Recommendation of Finding of Unsuitability were set for hearing on April 27, 2009, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division, Mojolounge, Inc. d/b/a Mojo Lounge, and Louis Maumus, individually, are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notice of Denial of Renewal Application;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

1. On December 10, 2007, the Louisiana State Police, Gaming Division received a Type 2 Video Gaming Application for Mojolounge, Inc. d/b/a Mojo Lounge due to a stock transfer.


2. On January 18, 2008, a State Police agent initiated an investigation of the stock transfer.
3. A video gaming license check revealed that Louis Maumus did not previously apply for a video gaming license.
4. The meeting minutes dated April 9, 2003, indicated that through unanimous agreement Ronda Lee Questad would hold the office of president and Robert Wittorff would hold the office of treasurer.
5. Ronda Lee Questad and Robert Wittorff each owned 50 shares of the stock in Mojolounge, Inc.
6. On April 10, 2005, Bob Wittorff sold his 50 shares, representing 50% of the stock in Mojolounge, Inc., to Louis Maumus for \$5,000.00.
7. The licensee did not notify the Division of this transfer, nor was the change in officers/directors, i.e. Robert Wittorff's removal as treasurer, disclosed to the Division.
8. Louis Maumus had not undergone suitability at the time of the purchase.
9. On May 22, 2007, Ronda Lee Questad passed away. Her 50 shares, representing 50% of the stock in Mojolounge, Inc., transferred to her parents by way of intestate succession.
10. Ronda Lee Questad's parents then transferred those 50 shares to Louis Maumus by Act of Donation executed on August 20, 2007.
11. The division was not notified of the passing of Ronda Lee Questad, nor was it notified of the transfer of her shares to her parents and then the subsequent transfer from her parents to Louis Maumus.

TERMS AND CONDITIONS


1. Mojolounge, Inc. d/b/a Mojo Lounge will pay a civil penalty of ONE THOUSAND and No/100 (\$1,000.00) DOLLARS.
2. Louis Maumus will pay a civil penalty of ONE THOUSAND and No/100 (\$1,000.00) DOLLARS.
3. The Division will dismiss the Notices of Recommendation of Revocation and Recommendation of Finding of Unsuitability.
4. Within fifteen (15) days of the approval of this Compromise and Settlement, Mojolounge, Inc. d/b/a Mojo Lounge and Louis Maumus, individually, shall remit payment of the above referenced penalty to the Division.

5. The Division hereby agrees to accept Mojolounge, Inc. d/b/a Mojo Lounge's payment of the above stated One THOUSAND and No/100 (\$1,000.00) DOLLAR penalty in full and final settlement.
6. The Division hereby agrees to accept Louis Maumus' payment of the above stated One THOUSAND and No/100 (\$1,000.00) DOLLAR penalty in full and final settlement.
7. The Division reserves the right to take into consideration these admitted violations in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of the Licensee's suitability.
8. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
9. This Compromise and Settlement Agreement constitutes the entire agreement between the Division, Mojolounge, Inc. d/b/a Mojo Lounge, and Louis Maumus, individually, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
8. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits. Failure to pay the penalty within fifteen (15) days of approval of this settlement, and to comply with each term and condition listed herein, shall result in the immediate suspension of the Mojolounge, Inc. d/b/a Mojo Lounge license without the necessity of further administrative action, until such time as the penalty is paid in full and Mojolounge, Inc. d/b/a Mojo Lounge is in compliance with all terms and conditions.

I have read this entire Compromise and Settlement Agreement and agree to all stipulations and terms and conditions hereof.
