

COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter the "Division") and Gerald J. Brown d/b/a G&G Restaurant and Lounge, License No. 3601609720 (hereinafter "Licensee") do hereby represent and agree as follows:

WHEREAS, on May 10, 2006, the Louisiana Gaming Control Board issued a Notice of Recommendation of Revocation to the Licensee and a Notice of Recommendation of Finding of Unsuitability to Gerald J. Brown, alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Revocation and Notice of Recommendation of Finding of Unsuitability, are set for hearing on April 11, 2007, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and Licensee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notices;

THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

1. The Licensee and Mr. Brown stipulate that Gerald J. Brown was arrested for violation of La. R.S. 14:68.4, Unauthorized Use of a Movable on March 30, 2005, and failed to notify the Division in violation of L.A.C. 42:XI.2417 (B)(4). This case was refused for prosecution on May 10, 2005.

2. The Licensee and Mr. Brown also stipulate that on April 5, 2005, Gerald J. Brown was arrested for violation of La. R.S. 14:98, Operating a Vehicle While Intoxicated and failed to notify the Division in violation of L.A.C. 42:XI.2417 (B)(4). On January 17, 2007, in the Traffic Court for the City of New Orleans, Gerald J. Brown pled guilty to La. R. S. 14:98.

TERMS AND CONDITIONS

1. Within fifteen (15) days of the approval of this settlement by the Louisiana Gaming Control Board, the Licensee shall pay a Five Hundred and No/100 Dollars (\$500.00) civil penalty for the violations of L.A.C. 42:XI.2417 (B)(4).

2. The Division hereby agrees to accept a Five Hundred and No/100 Dollar (\$500.00) penalty for the Licensee and Mr. Brown's violations of L.A.C. 42:XI.2417 (B)(4) in full and final settlement of the Notice of Recommendation of Revocation and the Notice of Recommendation of Finding of Unsuitability.

3. The Division reserves the right to take into consideration these admitted violations in connection with any further investigation, violation, or assessment of penalty, and in connection with any future assessment of the Licensee's or Mr. Brown's suitability.

4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division, Licensee, and Mr. Brown pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.


6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

7. If approved by the Louisiana Gaming Control Board, the Licensee must pay Five Hundred and No/100 Dollars (\$500.00) within fifteen (15) calendar days of such approval. Any failure to meet this requirement will result in immediate suspension of the gaming license without the necessity of any further administrative action until such time as the penalty is paid in full.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms and conditions hereof.
