

**COMPROMISE AND SETTLEMENT AGREEMENT**

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and Café "Lan-Yap", L.L.C. d/b/a Goody's Café II, Goody's Café, L.L.C. d/b/a Goody's Café, Grand Sports Café, L.L.C. d/b/a Mama Rosa's and Progressive Gaming Systems, L.L.C. d/b/a Progressive Gaming Systems (hereinafter collectively referred to as "the Licensees"), do hereby represent and agree as follows:

**WHEREAS**, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Administrative Action to the Licensees, which notice alleges certain violations of Louisiana Gaming Control Law; and

**WHEREAS**, the issues raised by the said Notice of Recommendation of Administrative Action are set for hearing on December 19, 2007, before the Louisiana Gaming Control Board Administrative Hearing Office; and

**WHEREAS**, the parties hereto are desirous of fully and finally compromising and settling all disputes and issues raised in connection with the said Notice of Recommendation of Administrative Action;

**NOW, THEREFORE**, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

### **STIPULATIONS**

1. Laura and Gilbert Copeland are the Managers/Members of the Licensees.
2. The Licensees submitted various improperly notarized documents to the Division. Among these, documents notarized by a disbarred attorney and documents purportedly notarized by the disbarred attorney which were in actuality signed and sealed by an employee who is not a notary. Additionally, Laura and Gilbert Copeland admit that some of the Documents were not notarized in the Affiant's presence. Thus, these Documents were improperly notarized.
3. On October 15, 2007, the Louisiana Gaming Control Board issued a Notice of Recommendation of Administrative Action to the Licensees, alleging certain violations of Louisiana Gaming Control Law.
4. The Licensees admit in the submission of improperly notarized documents, they were in violation of LAC 42:XI.2405(A)(15).
5. Laura and Gilbert Copeland represent that all of the statements, responses, disclosures and representations provided in documents submitted to the Division bearing their signatures, are true and correct to the best of their knowledge, information and belief, and represent a complete and accurate account of the requested information.

## **TERMS AND CONDITIONS**

1. Any and all information discovered throughout the course of this or any other investigation may be used in connection with any future violation(s), assessment of penalty or in any future determination of the suitability of Laura and Gilbert Copeland or the Licensees.

2. Each Licensee agrees to pay a civil penalty of Five Thousand Dollars (\$5,000.00) for a combined total of Twenty Thousand Dollars (\$20,000.00).

3. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Laura and Gilbert Copeland and the Licensees, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.


4. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

5. If approved, the Licensees must make payment of the civil penalty to the Division within ten (10) days of approval by the Louisiana Gaming Control Board. Failure to do so shall result in the immediate suspension of the licenses without the necessity of any further administrative action until such time as the penalty is paid in full.


6. The terms of this Compromise and Settlement Agreement shall be


