COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and Silvy, LLC d/b/a Comet Inn (hereinafter, "Licensee"), do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has sent a Notice of Recommendation of Administrative Action to Licensee, which Notice contains allegations of certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by said Notice are set for hearing before the Louisiana
Garning Control Board Administrative Hearing Office.

WHEREAS, the Division and Licensee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with said Notice;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

- 1. Licensee is a Type 1 licensed establishment located at 2803 Jefferson Hwy., Jefferson, Louisiana 70121.
 - 2. Licensee's ATC alcohol permit expired on February 28, 2018.

- 3. On May 31, 2018, the ATC renewed and issued Licensee its ATC alcohol permit, after the Licensee paid all fees associated with the renewal.
- 4. The Division verified that the video poker machines located at the licensed establishment were active during the time the ATC alcohol permit was expired.
- 5. The Division verified with the ATC that Licensee was issued a violation notice which proposed to assess a fine against Licensee for its failure to timely renew its alcohol permit. The ATC violation notice also reflected the permit expired on February 28, 2018, and was renewed on May 31, 2018.
- 6. According to the Video Draw Poker revenue report, between March 1, 2018 and May 31, 2018, Licensee generated a net device revenue of approximately \$12,025 from its video poker machines.
- 7. Licensee failed to notify the Division that its ATC alcohol permit expired on February 28, 2018 in violation of LAC 42:XI.2417(B)(2). Additionally, Licensee failed to maintain a valid ATC alcohol permit while operating as a licensed Type 1 video draw poker establishment in violation of LAC 42:XI.2417(A)(1) and La. R.S 27:402(14).

TERMS AND CONDITIONS

- 1. In lieu of administrative action, Licensee will pay a penalty of THREE THOUSAND DOLLARS and 00/100 (\$3,000.00) DOLLARS for its violation of LAC 42:XI.2417(A)(1), LAC 42:XI.2417(B)(2), and La. R.S 27:402(14).
- 2. The Division hereby agrees that payment of a total penalty of THREE THOUSAND DOLLARS and 00/100 (\$3,000.00) DOLLARS shall be in full and final settlement of all matters set forth in the Notice of Recommendation of Administrative Action.

- 3. The Division reserves the right to take into consideration this admitted violation in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Licensee's suitability.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Licensee, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
- 6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.
- 7. If approved, Licensee agrees to make full payment of the civil penalty within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board. Licensee agrees that failure to meet this requirement shall result in immediate suspension of the gaming license without the necessity of any further administrative action until such time as the penalty is paid in full.

I have read this entire Compromise and Settlement Agreement and agree to all stipulations and terms and conditions hereof.

Failure to do so shall result in the immediate suspension of the gaming license without the necessity of any further administrative action until such time as the penalty is paid in full.
