#### COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and David A. Pate (hereinafter, "Mr. Pate") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Revocation, Order of Immediate Emergency Suspension and Notice of Hearing Date to Mr. Pate alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Revocation,
Order of Immediate Emergency Suspension and Notice of Hearing Date are set for hearing
before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and Mr. Pate are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notice of Recommendation of Revocation, Order of Immediate Emergency Suspension and Notice of Hearing Date;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

#### STIPULATIONS

- 1. On or about October 7, 2007, Mr. Pate was charged with violating La. R.S. 40:966, Possession of Marijuana, La. R.S. 14:95(E), Illegal Carrying of a Weapon with Controlled Dangerous Substance and two counts of La. R.S. 14:95, Illegal Carrying of a Weapon.
- 2. Mr. Pate failed to timely notify the Division of his arrest in violation of L.A.C. 42:XIII.2901(B)(4).
- 3. On November 30, 2007, the Calcasieu District Attorney's office rejected the charges against Mr. Pate.

#### TERMS AND CONDITIONS

- 1. Mr. Pate will pay a civil penalty of FIVE HUNDRED AND NO/100 DOLLARS (\$ 500.00).
- 2. The Division hereby agrees to accept Mr. Pate's payment of the above stated penalty in full and final settlement of the Notice of Recommendation of Revocation, Order of Immediate Emergency Suspension and Notice of Hearing Date.
- 3. The Division reserves the right to take into consideration these admitted violations in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of the Mr. Pate's suitability.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Mr. Pate, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

This Compromise and Settlement Agreement is subject to approval by the 6.

Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this

proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory,

but will be submitted to the Louisiana Gaming Control Board for its determination as to whether

to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

Failure to pay the penalty within fifteen (15) days of approval of this settlement shall result in the

immediate suspension of Mr. Pate's permit without the necessity of further administrative action,

until such time as the penalty is paid in full.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms and conditions hereof.
