COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and R.C. Management, Inc. d/b/a River Parishes Truck Stop & Casino (sometimes hereinafter referred to as "Licensee") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Administrative Action to R.C. Management, Inc. d/b/a River Parishes Truck Stop & Casino, alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by said Notice of Recommendation of Administrative Action are set for hearing on December 2, 2009, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and Licensee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with said Notice of Recommendation of Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

- 1. On April 3, 2009, the Division conducted an inspection of the statutorily required on-site restaurant of R.C. Management, Inc. d/b/a River Parishes Truck Stop & Casino ("River Parishes Truck Stop & Casino") at approximately 6:50 a.m. The investigating troopers checked all three (3) entrance doors to the restaurant. The doors were all locked, and the restaurant was not open.
- 2. River Parishes Truck Stop & Casino had previously communicated to the Division that its statutorily required on-site restaurant operated daily from 6:00 a.m. to 6:00 p.m.
- 3. On April 5, 2009, the Division conducted an inspection of the statutorily required on-site restaurant of River Parishes Truck Stop & Casino at approximately 1:52 p.m. The restaurant's entrance doors were locked, and the restaurant was not open.
- 4. The Division's investigation of the closures of the statutorily required on-site restaurant of River Parishes Truck Stop & Casino revealed that the on-site restaurant was not open for at least twelve (12) hours on both April 3, 2009 and April 5, 2009.
- 5. On April 3, 2009 and April 5, 2009, River Parishes Truck Stop & Casino failed to have their statutorily required on-site restaurant open for a period of twelve (12) hours, in violation of La. R.S.27:306(A)(4)(c)(ii)(cc).

TERMS AND CONDITIONS

- 1. R.C. Management, Inc. d/b/a River Parishes Truck Stop & Casino will pay a civil penalty of Twelve Thousand Five Hundred Dollars and No/100 (\$12,500.00) in satisfaction of the violations of the Louisiana Gaming Control Law.
- 2. The Division hereby agrees to accept Licensee's payment of the above stated penalty in full and final settlement of the Notice of Recommendation of Administrative Action issued on August 24, 2009.
- 3. The Division reserves the right to take into consideration these violations in connection with any future investigations, violations or assessments of a penalty.

4. The terms of this Compromise and Settlement Agreement shall be interpreted

under the laws of the State of Louisiana.

5. This Compromise and Settlement Agreement constitutes the entire agreement

between the Division and Licensee, regarding the subject matter contained herein and supersedes

all prior and contemporaneous agreements, representations and understandings of the parties.

6. This Compromise and Settlement Agreement is subject to approval by the

Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this

proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory,

but will be submitted to the Louisiana Gaming Control Board for its determination as to whether

to approve the same or to remand the matter to the Hearing Officer for a full hearing on the

merits. Failure to pay the penalty within fifteen (15) days of approval of this settlement shall

result in the immediate suspension of R.C. Management, Inc. d/b/a River Parishes Truck Stop &

Casino's license without the necessity of further administrative action, until such time as the

penalty is paid in full.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms

and conditions hereof.

Management, Inc. d/b/a River Parishes Truck Stop & Casino without the necessity of any further administrative action, until such time as the penalty is paid in full.
