COME NOW State of Louisiana, Department of Public Safety and Corrections, Office of State Police ("Division") and Virginia Collier d/b/a Bud's Broiler, VGL 2600212420 and d/b/a Coffee Toffee, VGL 26002146097 ("Collier"), who file this Joint Motion for Approval of Compromise and Settlement Agreement, and in support thereof would respectively show unto the Hearing Officer as follows:

The Division and Collier are desirous of compromising and settling all disputes between them relative to the referenced administrative proceeding. In connection therewith, the parties have entered into a compromise and settlement agreement which by its terms will become effective upon approval by the Administrative Hearing Office and the Louisiana Gaming Control Board.

COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and Virginia Collier d/b/a Bud's Broiler, VGL 2600212420, and Virginia Collier d/b/a Coffee Toffee, VGL 2600214097, (hereinafter "Collier") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Denial of Renewal Application to Virginia Collier d/b/a Bud's Broiler and a Notice of Recommendation of Denial of Original Application to Virginia Collier d/b/a Coffee Toffee, both notices alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notices of Recommendation are set for hearing on March 13, 2006, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and Collier are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notices of Recommendation;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

- 1. Virginia Collier is the sole proprietor of Bud's Broiler, a licensed video gaming establishment. Virginia Collier is also the sole proprietor of Coffee Toffee, VGL 2600214097 and The Rocket, VGL 2600214549, two restaurants with pending video gaming applications.
- 2. On March 2, 2005, the Louisiana Gaming Control Board issued a Notice of Recommendation of Denial of Renewal Application to Virginia Collier d/b/a Bud's Broiler and a Notice of Recommendation of Denial of Original Application to Virginia Collier d/b/a Coffee Toffee alleging certain violations of Louisiana Gaming Control Law.

TERMS AND CONDITIONS

- 1. Within fifteen (15) days of the approval of this settlement by the Louisiana Gaming Control Board, Virginia Collier shall divest herself of the licensed establishment known as Bud's Broiler, 2008-10 Clearview Parkway, Metairie, Louisiana, such that she shall not have any ownership, income, profit or economic interest directly or indirectly in the licensed establishment. Virginia Collier shall not owner finance or become a creditor of the buyer as a result of the sale of the licensed establishment. Virginia Collier further agrees that subsequent to the sale of the licensed establishment, she shall receive no remuneration or other economic benefit directly or indirectly from any person's ownership or operation of any licensed establishment.
- 2. Within fifteen (15) days of the approval of this settlement by the Louisiana Gaming Control Board, Virginia Collier shall withdraw the pending applications of Coffee Toffee (2600214097) and The Rocket (2600214549) with prejudice.

- 3. The Division hereby agrees to accept Virginia Collier's divestiture of the licensed establishment and withdrawal with prejudice of the pending applications 2600214097 and 2600214549.
- 4. Additionally, Virginia Collier shall not be eligible, either individually or through any person with whom she is affiliated, directly or indirectly, to apply for or hold any license, permit, or approval authorized by Louisiana Gaming Control Law for a period of five years from the date this Joint Motion for Approval of Compromise and Settlement Agreement is approved by the Louisiana Gaming Control Board.
- 5. Finally, Virginia Collier shall not, directly or indirectly, have or control an ownership, income, profit or economic interest in any person holding an ownership, income, profit, or economic interest in any licensee or permittee of the Louisiana Gaming Control Board.
- 6. Any and all information discovered throughout the course of this or any other investigation may be used in any future determination of the suitability of Virginia Collier.
- 7. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 8. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Virginia Collier, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
- 9. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

10. If approved by the Louisiana Gaming Control Board, Virginia Collier must completely divest herself of all ownership, income or profit interest in the licensed establishment and withdraw with prejudice the pending applications of Coffee Toffee and The Rocket within fifteen (15) calendar days of such approval. Any failure to meet this requirement will result in immediate revocation of the Bud's Broiler video gaming license and denial of the pending applications for Coffee Toffee and The Rocket without the necessity of any further administrative action.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms and conditions hereof.
