NOW COMES the State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereafter the "Division"), and Augie Leopold Advertising Specialties, Inc. (hereafter sometimes referred to as "Permitee"), August D. Leopold, Jr., LeeAnne Leopold, Adelaide J. Musso, and Ashley A. Engerran (hereafter sometimes collectively referred to as "Qualifiers") do hereby and agree as follows:

The Division, Permittees and Qualifiers are desirous of compromising and settling all disputes between them relative to the referenced administrative proceeding. In connection therewith, the parties have entered into a compromise and settlement agreement which by its



terms will become effective upon approval by the Administrative Hearing Office and the Louisiana Gaming Control Board.

A true and correct copy of the proposed Compromise and Settlement Agreement is attached hereto as Exhibit "A" and incorporated by reference for all purposes.



COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereafter "The Division"), and Augie Leopold Advertising Specialties, Inc. (hereafter sometimes referred to as "Permittee"), August D. Leopold, Jr., LeeAnne Leopold, Adelaide J. Musso, and Ashley A. Engerran (hereafter sometimes collectively referred to as "Qualifiers") do hereby and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Denial of Original Application, dated July 31, 2006, to Augie Leopold Advertising Specialties, Inc. and separate Notices of Recommendation of Finding of Unsuitability, dated July 31, 2006, to August D. Leopold, Jr., LeeAnne Leopold, Adelaide J. Musso, and Ashley A. Engerran, (hereafter sometimes collectively referred to as "the Notices") alleging certain violations of the Louisiana Gaming Control Law;

WHEREAS, the issues raised by the Notices are set for hearing on November 1, 2006 before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division, Permittee and Qualifiers are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the Notice;

NOW, THEREFORE, and in consideration of the foregoing, the parties do hereby agree and stipulate as follows:

STIPULATIONS AND TERMS AND CONDITIONS

1. Augie Leopold Advertising Specialties, Inc. voluntarily agrees to withdraw its application for a non-gaming supplier permit. The Division agrees to permit the voluntary withdrawal.

2. Permittee and each Qualifier voluntarily agree that they will not be eligible to re-apply for any approval authorized by the Louisiana Gaming Control Law for a period of sixty months commencing from October 26, 2004, namely the date of the Hearing Officer's approval of the Joint Motion for Entry of Stipulations and Approval of Proposed Settlement in the matter captioned "In Re: Promotional Partners Incorporated, Case No. P082600583."

3. The Division hereby agrees to accept the agreement of Augie Leopold Advertising Specialties, Inc., August D. Leopold, Jr., LeeAnne Leopold, Adelaide J. Musso, and Ashley A. Engerran that they will not be eligible to re-apply, either individually or as shareholders, members, managing members, partners, managers, revenue, profit or income interest holders or as persons, who, in the opinion of the Division, may exercise significant influence over the operations of a Louisiana casino gaming licensee or permittee, for any approval authorized by the Louisiana Gaming Control Law for a period of sixty months commencing from October 26, 2004.

4. Augie Leopold Advertising Specialties, Inc., August D. Leopold, Jr., LeeAnne Leopold, Adelaide J. Musso, and Ashley A. Engerran agree not to directly, or through any natural or juridical person with whom they are affiliated, do business with any Louisiana casino gaming licensee for a period of sixty months commencing from October 26, 2004.

5. LeeAnne Leopold by her signature of this Compromise and Settlement Agreement acknowledges these stipulations and this prohibition on behalf of Auggie Leopold Advertising Specialties, Inc.

6. August D. Leopold, Jr., LeeAnne Leopold, Adelaide J. Musso, and Ashley A. Engerran, by their respective signatures of this Compromise and Settlement Agreement individually acknowledge these stipulations and this prohibition on behalf of themselves.

7. Nothing herein and/or in the Notices shall be construed as a determination of the unsuitability of Augie Leopold Advertising Specialties, Inc., August D. Leopold, Jr., LeeAnne Leopold, Adelaide J. Musso, and Ashley A. Engerran. Additionally, nothing contained herein and/or in the Notices shall be deemed to automatically disqualify Augie Leopold Advertising Specialties, Inc., August D. Leopold, Jr., LeeAnne Leopold, Adelaide J. Musso, and Ashley A. Engerran upon re-application after the expiration of the sixty-month period set forth herein.


8. The Division reserves the right to take into consideration the violations alleged in the Notices in connection with any future violation(s), assessment of penalty or determination of the suitability of Augie Leopold Advertising Specialties, Inc., August D. Leopold, Jr., LeeAnne Leopold, Adelaide J. Musso, or Ashley A. Engerran. The sixty month period set forth herein shall be considered by the Division in connection with any re-application by Permittee and/or any Qualifier for any approval authorized by the Louisiana Gaming Control Law .

9. The form and substance of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.


10. This Compromise and Settlement Agreement constitutes the entire agreement between Augie Leopold Advertising Specialties, Inc., August D. Leopold, Jr., LeeAnne Leopold, Adelaide J. Musso, and Ashley A. Engerran, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

11. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer of the Louisiana Gaming Control Board. It is expressly understood that if this proposed Compromise and Settlement Agreement is approved by the Hearing Officer, this agreement is not executory and will be submitted to the Board no sooner than its regularly scheduled monthly meeting for its determination as to whether the matter should be heard by the Hearing Officer.





Officer**




August D. Leopold, Jr., Individually




LeeAnne Leopold, Individually


ORDER-
