COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State

Police (hereinafter, the "Division") and Galliano Inn, LLC d/b/a Galliano Inn do hereby represent

and agree as follows:

WHEREAS, the Division has issued a Notice of Recommendation of Administrative

Action to Galliano Inn, LLC d/b/a Galliano Inn alleging certain violations of Louisiana Gaming

Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Administrative

Action were set for hearing on June 28, 2010, before the Louisiana Gaming Control Board

Administrative Hearing Office; and

WHEREAS, the Division and Galliano Inn, LLC d/b/a Galliano Inn are desirous of fully

and finally compromising and settling all issues and disputes arising out of and in connection

with the said Notice of Recommendation of Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby

agree and stipulate as follows:

STIPULATIONS

- 1. On December 29, 2009, Galliano Inn, LLC d/b/a Galliano Inn submitted a Multiple Use Reporting Form to the Division in which it stated that it had converted to a limited liability company.
- 2. An investigation was conducted which discovered that the conversion took place approximately one year prior to Galliano Inn, LLC d/b/a Galliano Inn notifying the Division.
- 3. Galliano Inn failed to timely notify the Division of this conversion.

TERMS AND CONDITIONS

- 1. Galliano Inn, LLC d/b/a Galliano Inn will pay a civil penalty of FIVE HUNDRED and No/100 (\$500.00) DOLLARS.
- 2. The Division hereby agrees to accept Galliano Inn, LLC d/b/a Galliano Inn's payment of the above stated FIVE HUNDRED and No/100 (\$500.00) DOLLAR penalty in full and final settlement.
- The Division reserves the right to take into consideration these admitted violations in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of the Licensee's suitability.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Galliano Inn, LLC d/b/a Galliano Inn, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
- 6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits. Failure to pay the penalty within fifteen (15) days of approval of this settlement, and to comply with each term and condition listed herein, shall result in the immediate suspension of the Galliano Inn, LLC d/b/a Galliano Inn license without the necessity of further administrative action, until such time as the penalty is paid in full and Galliano Inn, LLC d/b/a Galliano Inn is in compliance with all terms and conditions.

I have read this entire Compromise and Settlement Agreement and agree to all stipulations and terms and conditions hereof.
