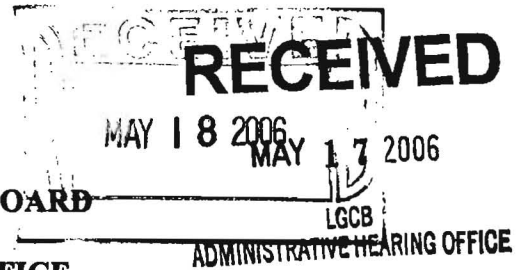





COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter the "Division") and Harrah's Lake Charles, L.L.C. d/b/a Harrah's Pride Riverboat Casino, License No. R016500086 (hereinafter "Licensee") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Enforcement Division has issued a Notice of Violation and Penalty to Licensee, alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Violation and Penalty are set for hearing on March 22, 2006, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and Licensee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notice of Violation and Penalty;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

1. Licensee stipulates that on September 29, 2004, an eighteen year old male patron gained access to the gaming floor in violation of **LAC 42:XIII.2915 (A) METHODS TO**

PREVENT MINORS FROM GAMING AREA OPERATING STANDARDS and as a result of this conduct was issued a significant action report on October 1, 2004.

2. Licensee further stipulates that the Louisiana Gaming Enforcement Division issued a NOTICE OF VIOLATION AND PENALTY CGD 040505B SAR 04-1-06-352-5922.

TERMS AND CONDITIONS

1. Within fifteen (15) days of the approval of this settlement by the Louisiana Gaming Control Board, Licensee shall pay Thirty Thousand and No/ 100 (\$30,000.00) Dollars for the violation of LAC 42:XIII:2915(A) and a written warning for the violation of LAC 42:XIII:2901(A)(1).

2. The Division hereby agrees to a Thirty Thousand and No/ 100 (\$30,000.00) Dollars fine for the Licensee's fourth (4th) Category II violation of LAC 42:XIII:2915(A) within a twelve (12) month period.

3. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

4. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Licensee, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

5. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

6. If approved by the Louisiana Gaming Control Board, Licensee must pay Thirty Thousand and No/ 100 (\$30,000.00) Dollars within fifteen (15) calendar days of such approval. Any failure to meet this requirement will result in immediate revocation of the gaming license without the necessity of any further administrative action.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms and conditions hereof.


