#### COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and Han D. Pham (hereinafter, "Permittee"), do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has sent a Notice of Recommendation of Administrative Action to Permittee, which Notice contains allegations of certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by said Notice were set for hearing before the Louisiana Gaming Control Board Administrative Hearing Office on May 12, 2021.

WHEREAS, on the date of the Hearing on May 12, 2021, in lieu of a formal hearing, Permittee stipulated to the allegations in said Notice;

WHEREAS, the Division and Permittee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with said Notice;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

#### STIPULATIONS

- Han D. Pham ("Permittee") holds a non-key gaming employee permit, number
   P040072644. He resides at 7787 Antebellum Ave., Baton Rouge, Louisiana 70820.
- On April 21, 2020, Permittee was arrested by the East Baton Rouge Parish
   Sheriff's Office for violating La. R.S. 14:67, Theft.
- 3. In a letter dated March 16, 2021, the East Baton Rouge District Attorney's Office stated that no charges will be filed against Permittee regarding the April 21, 2020 incident.
- Permittee failed to timely notify the Division of his arrest, in violation of La. LAC
   42:III.2901(B)(4)(a) and (c).

#### TERMS AND CONDITIONS

- 1. In lieu of administrative action, Permittee will pay a penalty of FIVE HUNDRED and 00/100 (\$500.00) DOLLARS for his violation of LAC 42:III.2901(B)(4)(a) and (c).
- 2. The Division hereby agrees that payment of a total penalty of FIVE HUNDRED and 00/100 (\$500.00) DOLLARS shall be in full and final settlement of all matters set forth in the Notice of Recommendation of Administrative Action.
- 3. The Division reserves the right to take into consideration this admitted violation in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Permittee's suitability.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
