1	We would enter revenue reports.
2	Ms. Jackson, good morning.
3	MS. JACKSON:
4	Good morning, Chairman Johns, Board
5	Members. My name is Donna Jackson with
6	Louisiana State Police Gaming Audit
7	Section.
8	In October, the 14 operating
9	riverboats generated adjusted gross
10	receipts of \$132,508,618. The state
11	collected fees totalling \$28,489,353.
12	Adjusted gross receipts for fiscal
13	year '23-'24 to date are \$554.7 million, a
14	decrease of \$3.9 million or 1% from fiscal
15	year '22-'23.
16	As of October 31st, 2023, the state
17	collected \$119.3 million in fees for
18	fiscal year '23-'24.
19	Page 2 shows the riverboat revenue
20	broken down by regional market. The
21	overall decrease from September was almost
22	\$7 million or 5%. Compared to last
23	October, this month's revenues represent
24	an increase of \$1.5 million or 1.2%.
25	Next is the summary of October 2023

1	gaming activity for Harrah's New Orleans,
2	found on page 3. Harrah's generated
3	\$19,642,152 in gross gaming revenue.
4	These revenues represent a decrease from
5	last month of \$1 million or 5%, and a
6	decrease of \$2.7 million or 12% for the
7	same month last year.
8	During October, the state received
9	\$5,505,465 in minimum daily payments.
10	Adjusted gross receipts for fiscal
11	year '23-'24 to date are \$75.7 million, a
12	decrease of \$11.5 million or 13% from
13	fiscal year '22-'23.
14	As of October 31st, 2023, the state
15	collected \$21.8 million in fees for fiscal
16	year '23-'24.
17	Next I'll present the revenues for
18	Slots at the Racktracks. During October,
19	the four racetrack facilities combined
20	generated adjusted gross receipts of
21	\$22,354,384, a decrease of \$2.7 million or
22	11% from September 2023, and a decrease of
23	\$3.3 million or 13% when compared to the
24	same month last year.
25	During October, the state collected

1	\$3.4 million in fees. Adjusted gross
2	receipts for fiscal year '23-'24 to date
3	are \$100 million, a decrease of \$5.9
4	million or 6% from fiscal '22-'23.
5	As of October 31st, 2023, the state
6	has collected approximately \$15 million in
7	fees for fiscal year '23-'24.
8	I'll now move to the video gaming
9	information. There are 11,834 video
10	gaming devices activated at 1,390
11	locations. Net device revenue for October
12	2023 was \$59,360,167, a decrease of
13	\$724,384 or 1.2% when compared to
14	September 2023, and a decrease of \$3.6
15	million or 5.7% when compared to last
16	October. Total franchise fees for October
17	2023 totaled \$18 million.
18	Fiscal year to date Net device
19	revenue is \$242.6 million, a decrease of
20	\$13.7 million or 5.4% when compared to
21	last fiscal year.
22	As of October 31st, 2023, the state
23	has collected \$73.5 million in franchise
24	fees for fiscal year 2024.
25	Next, I'll present the October

1	revenue for Sportsbook. During October,
2	the 18 retail sportsbooks accepted over
3	\$32 million in sports wagers, resulting in
4	net proceeds of approximately \$3.3 million
5	and \$342,067 in state taxes.
6	The nine mobile sportsbook operators
7	accepted over \$276 million in sports
8	wagers, resulting in net proceeds of \$39.2
9	million and almost \$5 million in taxes
10	paid to the state.
11	Finally, for Daily Fantasy Sports,
12	gross revenues for October was \$1.9
13	million, with net revenue of approximately
14	\$206,000 and taxes of \$16,500.
15	Any questions?

20	mistaken, this may be a new record month
21	for sports for sports wagering.

18	Members. I'm Assistant Attorney General
19	Jeremy Gathe. And today I'll present the
20	staff reports for riverboat and racetrack
21	casino licensees' compliance with
22	employment and procurement conditions for
23	the third quarter of 2023.
24	I'll begin with the riverboats. The
25	third quarter reports are taken from

	riverboats to the Louisiana Gaming Control
3	Board.
4	In the third quarter of 2023,
5	approximately 9,171 people were employed
6	by the riverboat industry. Of that number
7	8,988 were Louisiana residents; 5,647 were
8	minorities, and 5,030 were women.
9	Four licensees achieved total
10	compliance this quarter, and those
11	licensees are Golden Nugget Lake Charles,
12	L'Auberge Baton Rouge, Margaritaville
13	Resort Casino and L'Auberge Lake Charles.
14	Next I'll address employment.
15	Eleven licensees did not meet their total
16	employment goals, and they are: Diamond
17	Jacks Casino & Resort, which achieved 11
18	out of a goal of 650; Sam's Town Hotel &
19	Casino which achieved 394 out of a goal of
20	700; Horseshoe Bossier City which achieved
21	542 out of a goal of 1,000; Boomtown New
22	Orleans, which achieved 451 out of a goal
23	of 555; Belle of Baton Rouge Casino, which
24	achieved 143 out of a goal of 450;
25	Treasure Chest Casino, which achieved 352

1	out of a goal of 500; The Queen Baton
2	Rouge, which achieved 422 out of a goal of
3	450; Amelia Belle Casino which achieved
4	164 out of a goal of 325; Horseshoe Lake
5	Charles which achieved 571 out of a goal
6	of 650; Boomtown Casino Bossier which
7	achieved 304 out of a goal of 650; and
8	Bally's Shreveport, which achieved 631 out
9	of a goal of 950.
10	All licensees either meet or
11	exceeded their goals in all of the
12	subcategories under the main category of
13	employment with the exception of Treasure
14	Chest Casino, which achieved 45.5% out of
15	a goal of 51.86% under the subcategory of
16	female employment.
17	Next I'll address procurement.
18	Licensees are grouped according to three
19	subcategories which appear in your report.
20	Those subcategories are Louisiana,
21	minority and female procurement.
22	Under Louisiana procurement, all
23	licensees either met or exceeded their
24	goals. Under the subcategory of minority
25	procurement, two licensees did not achieve

1	compliance with their voluntary
2	conditions, and those licensees are
3	DiamondJacks Casino, which achieved 2.4%
4	out of a goal of 10%, and Bally's
5	Shreveport, which achieved 9.3% out of a
6	goal of 13%.
7	For female procurement, one licensee
8	did not achieve compliance with its
9	voluntary conditions, and that is Bally's
10	Shreveport, which achieved 13.9% out of a
11	goal of 15%.
12	Are there any questions regarding
13	the riverboats?
14	CHAIRMAN JOHNS:
15	Any questions, Members? If I could
16	make a comment, I I did communicate
17	with Bally's yesterday about not meeting
18	their minority and their women goals.
19	They have acquired Members of the
20	Board, this is for your knowledge. They
21	have acquired a new female minority vendor
22	just a few weeks ago, and and they have
23	assured me that their goals will be met in
24	the future. So I feel comfortable after
25	after visiting with them on that.

9	approximately 1,243 people were employed
10	by the racetrack casino. Of that number,
11	1,023 were Louisiana residents, 654 were
12	minority, and 733 were women. All of the
13	racetracks achieved total compliance this
14	quarter with the exception of Delta Downs,
15	which did not achieve its Louisiana
16	employment condition. It achieved 59.3%
17	out of the 80% condition.
18	Under procurement, all licensees
19	either met or exceeded their goals in all
20	of the subcategories.
21	Are there any questions regarding
22	the racetracks?
23	CHAIRMAN JOHNS:
24	Any questions, Members?
25	No questions.

that there were questions that were specifically asked; hopefully, I'll go over the answer to those. If not, I'll answer afterwards. So I wanted to start off with just a little bit of a historical note on where we have been for quite sometime in the region 1 area, which previously existed prior to us becoming a local government entity being responsible for the services for Orleans, St. Bernard and Plaquemines Parishes. Mental illness, addiction and interventional and developmental disability services are our -- is our purview and gambling falls under addictive disorders. So we have through statutory requirement, the requirement to treat people with compulsive gambling disorders as a part of an addictive spectrum. In addition to, we have a contractual agreement with the Louisiana Department of Health through the Office of Behavioral Health, which requires that we provide



services for people with gambling

disorders.

One of the things that we did that may not be on your radar is pre-Katrina we actually did stand up a room and board gambling residential facility and it was called Core South.

Core South was intended to provide an opportunity for people to have a place to stay overnight, but during the day they connected to outpatient services at MHSD and with other providers in the area. That program I think may have been under five years in existence before pre -before Katrina and it was never resurrected again, and so we were left without a residential program in the area.

At the time funding and support was clearly indicated for it and continues to be indicated, but we've not revisited that. As you know, the only residential program currently exists in Shreveport Core.

But in terms of what we have provided and what's the requirements of us, we have a lot of program requirements

1	and treatment priorities. Categorically
2	we provide outpatient treatment and that
3	treatment includes group and individual
4	therapy in person and online.
5	We also provide referrals for
6	financial counselling. And we do the
7	individual therapy with therapists, who
8	are licensed compulsive gambling trained.
9	And we have on staff three people who have
10	the licensed compulsive gambling
11	certification and other certifications,
12	and we have one contractor who we recently
13	contracted with.
14	The other priority has been to
15	provide community awareness of gambling,
16	because like the other substance abuse
17	disorders, they don't get the press, the
18	knowledge, the information generally in
19	communities about people suffering with
20	this condition. It's a very devastating
21	condition too, as many of you all know,
22	for people to have. And so we do a lot of
23	gambling awareness around that.
24	We also, we have a pretty robust
25	data system around which we direct and

1	determine what is necessary for our
2	communities. So a lot of what we do is
3	data driven decision-making, and then we
4	have a workforce development as a more
5	recent, more robust effort.
6	Though we have always been required
7	to have on staff people with compulsive
8	gambling certification, it's always been
9	very difficult to find people in this
10	state who have that certification and who
11	can really, really do a reputable job for
12	working with compulsive gamblers.
13	So we look at performance and
14	accountability. And we also have
15	certification requirements that we comply
16	with. For our programatic services side,
17	we operate compulsive gambling services in
18	person out of four of five clinics, but
19	you can get virtual and virtual
20	services out of all of clinics and
21	in-person services depending upon where
22	the counselors are residing.
23	The counselors the counselling
24	staff also are civil servants, but also we
25	have contractors who have in the past and

1	currently work with us.
2	Our credentialed staff are also all
3	licensed addiction counselors who have
4	gone on to get an additional certification
5	in compulsive gambling, and two of them
6	also provide supervision for gambling.
7	Financially, we have historically
8	received funding interagency transfer from
9	the Department of Health for both
10	treatment and prevention for gambling.
11	Prevention dollars have hovered around
12	20,000. It hasn't really changed very
13	much, at least not in the last five, six
14	years; but in our treatment dollars have
15	hovered around 150,000, and more recently
16	also the Office of Behavioral Health
17	actually through a private program
18	initiative increased our budget by a half
19	million. And I'll talk a little bit more
20	about the purpose of that and and what
21	has been the outcome of that funding.
22	In terms of trending, our prevention
23	dollars have been pretty much fully spent
24	and have been consistently used more for
25	community awareness, education. It also
-

1	supports our media campaign around
2	gambling; and, of course, treatment I've
3	I've reported to you what that 150 has
4	traditionally provided for us.
5	Now, for the communication part of
6	this, we have three staff. They are very
7	we have an aggressive marketing
8	campaign, and we use a diversified number
9	of media vibes. For example, we have
10	cable television commercials. We have
11	outdoor and indoor ads. We have digital
12	promotion. We have radio commercials, and
13	we have community engagement efforts.
14	Most of this started more robustly
15	in 2017, and has continued through the
16	present fiscal year. We have partnered
17	with other agencies and entities to put
18	together panel discussion and outreach for
19	community awareness about compulsive
20	gambling, particularly with the online
21	betting and the uptake in gaming that has
22	really, really plagued our youth
23	specifically.
24	So our data shows a lot, and I'll
25	just go through a few points with you.

1	With regards to the demographics of the
2	people that we see at Metropolitan, 75
3	percent of them are who have gambling
4	concerns, 75 percent of them are African
5	American, 13 percent Caucasian, white, 9
6	percent Asian. The age diversification is
7	80 percent adult, 20 percent youth.
8	And then gender 53 percent edged out
9	a little bit more for people who come to
10	Metropolitan, 53 percent are women or
11	females, and 45 percent male, 2 percent
12	identified as transgender.
13	When you look at the state hotline
14	data, the number 1 grouping again is
15	African American. Number 2, white
16	Caucasian. And with regards to persons
17	served by the national hotline measures,
18	it's males more than females, a little bit
19	different from our demographics. And in
20	terms of bi-parish of the tri-parish area,
21	Orleans Parish clearly has 80 percent of
22	the people who are calling in to the
23	hotline for services. And then with
24	regards to by age group, the highest age
25	group that the hotline data is showing in

1	our area is 55 to 64. And number 2, is 45
2	to 54 years old. And then the third group
3	really is unknown. They're not
4	identifying their age.
5	That was the 2024 data. I do have
6	data from 2021 through 2024, but we'll
7	we'll move on from that.
8	With regards to calls that we're
9	getting in our regional area, we have seen
10	an uptick in the number of calls directly
11	to Metropolitan for our care center
12	specifically for services around gambling.
13	And FY '21, we got 62 calls that were
14	specific to gambling and these calls may
15	have been for other things as well, but
16	certainly gambling was a part of it.
17	FY '22, 94 calls; FY '23, 126 calls
18	directly for gambling services in our
19	region. And so far we've gotten about 17
20	calls from July through September.
21	We think that the call volume is not
22	as high because people know that there is
23	a limited amount of services that are
24	available in our area with the exception
25	of the district itself, there's not much

1	more in the private sector that's going
2	on, which are also supports why a gambling
3	facility becomes so, so important because
4	the intensity that's needed at a
5	residential level is really what begins
6	the grounding process and the healing
7	process, and then you can reduce the
8	intensity in the community-based services
9	but you've got to get that intense
10	introduction to reforming for people to do
11	better.
12	We screen every call that comes in
13	through our care center. We use the live
14	bet screening tool. You all probably know
15	that's a two a two questionnaire; two
16	questions questionnaire that is both valid
17	
18	and reliable and highly predictable. If
	the person answers yes to one or two of
19	those, there is a likelihood that you need
20	to be assessing them for a compulsive a
21	gambling disorder.
22	We have had about a total of
23	number of people who have called over the
24	years. From FY '21 to '24, that number
25	number number of people screened has

been 11,989 people, but a very, very small percentage of those people actually come into service, less than 2 percent.

4 So even though we know that the 5 people are out there, they are not coming 6 into treatment. They also are more likely 7 to make an appointment but not keep the 8 appointment. So about 30 percent of the 9 time they are scheduling an appointment 10 but are not showing up. Well, 30 percent of the time they're showing up for an 11 12 appointment, which means 70 percent of the 13 time they are not keeping the appointment that they show up for. And that just 14 15 speaks to the need for urgency. In -- in 16 real time supports for addictive 17 disorders, you can miss that window, you 18 miss that opportunity, then you probably 19 are going to miss an opportunity of a 20 lifetime in some cases for those 21 individuals.

We currently have seen for this quarter for this fiscal year, 35 people have actually completed, gone through the process of care at MHSD.

1	Now, what happened, 2022, the Office
2	of Behavioral Health asked that we pilot a
3	residential program to see if, or to see
4	what would be needed if we were going to
5	put a residential program in the area.
6	It's in our purview Metropolitan's
7	responsibility is to survey, do
8	surveillance, do research and understand
9	what are the needs of those populations
10	that we serve. It wasn't an unreasonable
11	ask, and what we did was they wanted to
12	house a program in an existing licensed
13	addictions counsellor's residential
14	addictions program and figure out how that
15	could work to mix people with primary
16	addiction, gambling disorder with people
17	who have psychoactive substance disorders
18	or substance use disorders. And we did.
19	The original idea was to do five
20	beds, male beds and see how that worked.
21	Well, from the beginning, it was a
22	challenge to do that to even isolate out
23	because of the structure of the program.
24	We did this partnership with Bridge House
25	in New Orleans. It was very difficult to

1	isolate out the beds because the program
2	is so addiction centered for substance use
3	disorders. It's difficult to create an
4	environment where those people could be
5	separate and so forth.
6	So what we did was we created a
7	parallel process, a program wherein the
8	people who have the compulsive gambling
9	disorder were able to do a separate track
10	that was complimentary to their substance
11	use track. Because everybody at Bridge
12	House is there because they have an
13	identified substance abuse disorder.
14	So they continue that work, but we
15	added meetings, more didactic meetings and
16	our referrals are the part of a process to
17	treat them. But unfortunately, that
18	program has licensed addiction counselors
19	and people who do that work for substance
20	use, but he was not trained to do gambling
21	work.
22	So what we did was we hired a
23	counselor to work specifically with him to
24	help him and us put in place a program
25	that would be reputable for this parallel



process.

2	We consulted with Janet Miller, who
3	was extremely helpful to us and who we
4	also recognized runs the Core program and
5	certainly does this and would be able to
6	maybe advise; and her advice was very
7	helpful to us. But what was painfully
8	obvious was that you cannot successfully
9	treat a person who has a gambling disorder
10	in a program that is not exclusively
11	staffed and intentionally focussed on
12	gambling as the primary disorder that the
13	person is presenting with.
14	Now, what the data shows, though, is
15	that in at least 40 percent of the cases
16	people who have a gambling disorder have
17	other cooccurring conditions, mental
18	illness, bipolar disorder being often or
19	mood disorders being common, and they also
20	require high-intensity services because in
21	their active addiction and in their most
22	acute phase, they can become suicidal, and
23	often do commit suicide. And so the need
24	for people who are trained to treat mental
25	illness as well as gambling disorder is

1	critical for that population because we're
2	losing a lot of them to the mental illness
3	side of the problem, even though the
4	gambling problem is the thing that is
5	driving the the pain and the need for
6	services.
7	So the two things that we learned
8	from that pilot, we well, before I say
9	that, Grace House I mean the Bridge
10	House program, they screened and assessed
11	more than 75 men in treatment and 29 women
12	in treatment because we also had them to
13	screen the people at Bridge House, which
14	is the parent the female side of that
15	program. We also had them they
16	actually served 18 males and six females
17	for compulsive gambling disorder, though,
18	over 20 percent of the people identified
19	as having positive symptoms of a
20	compulsive of a gambling disorder, but
21	the participation in this parallel program
22	was optional. So nobody was required to
23	participate. So 18 males did. Six
24	females did at the other program. And
25	overall 211 persons were served in group

therapy, and that was from 2022 to 2023, that one-year pilot ended in September of this year.

So what did we learn? Two major lessons we learned. I mentioned one already. That gambling disorder treatment should exist in the dedicated gambling residential program, but that you have to have behavioral health services available as well. Behavioral health meaning mental health treatment as well as substance use treatment, because of the co-occurrence of these conditions and the impact they have on each other.

15 So and when we say in behavioral 16 health that all of these conditions are 17 primary, which means you have to offer 100 18 percent of care to each one of these 19 conditions if you want one of them to get 20 better. And so co-occurring treatment is 21 what we need here. And, secondly, 22 aggressive planning is needed to develop 23 the workforce. 24

So today if we had another program in New Orleans or in Baton Rouge or



1	wherever in the southern part of the
2	state, we would not have the staff who are
3	licensed and credentialed to do the work.
4	And so workforce development is critical
5	at this at this juncture.
6	And so what we have done as a result
7	of the pilot is moved in the direction of
8	developing the workforce. And so as a
9	result of that, we have contracted with
10	two national trainers who we agreed with
11	doing 20 hours of immersed training, 30
12	hours of immersed training for 20
13	individuals over a two-month period on
14	requirements for treating people with
15	gambling disorder. We complete the first
16	cohort of individuals last spring and we
17	are going to have that training resume for
18	the second cohort this coming January,
19	January through February.
20	Now, the interesting thing about
21	this group is now the gambling national
22	gambling community has a second credential
23	that you can get. You can get always
24	you can get a certified gambling
25	credential if you solely wanted to be a

1	person who treated people with gambling or
2	in conjunction with another condition, but
3	it was a singular certification.
4	Now what they have come out with
5	realizing that many, many people don't
6	even like to do that. Many people are not
7	so inclined to just treat people with
8	gambling disorders. They now have a
9	co-occurring credential for anybody who is
10	licensed and works with behavioral health
11	issues in most cases or not, you can get a
12	primary care license, a primary care
13	physician, you could be a licensed nurse,
14	LPN, RN, whatever, if you have an interest
15	in working with people who suffer with
16	this condition, then you can get this
17	co-occurring credential.
18	And so our cohort of people who are
19	trained were nurses, social workers,
20	licensed addiction counselors, peers and
21	we opened it up to community partners.
22	And so the goal here is to train the
23	community around gambling. Because if you
24	ever decide to selectively treat that

1	need to know what to ask, what to say, and
2	what to do. If somebody is sitting in
3	front of you not declaring and saying that
4	they have this condition, you need to be
5	able to ask the right questions so that
6	you can find out the right answers and get

10	operating around why we have invested a
11	significant amount of time into this pilot
12	project. And we'll continue to do these
13	trainings as well as boosters every year.
14	I've had the trainers to train our staff
15	as well on compulsive gambling.

18	requirements for helping people with
19	disabilities that we are responsible for;
20	and we are postured to do whatever we need
21	to do that makes sense for human service

conditions? We're doing everything we can

most effective. And when I say levels of
intervention, it's the degrees of
intensity of services that we are able to
provide with residential being the most
intense; and in the world of addiction,
most people have to visit a period where
they are removed from the triggers and
they are given an intense period of weeks
of treatment so that they can reset and

4	MR. DUTY:
5	Good morning, board members and Mr.
6	Chairman. My name is Wade Duty. I'm the
7	executive director of the Louisiana Casino
8	Association. The bad news is I do have a
9	PowerPoint presentation. The good news is
10	it's only about seven slides and not a
11	whole lot of talking on my part is
12	probably necessary, so we'll beg your
13	indulgence on this.
14	So what you have before you is
15	actually ten individual petitions of
16	certain licensees seeking to amend their
17	employment goals. As you endured last
18	time I made a presentation to you, these
19	were set contemporaneously with the
20	procurement goals so they're equally out
21	of date and probably equally irreverent
22	irrelevant, rather, to their current
23	operation profile.
24	Let me assure anybody that's
25	listening or has concerns later, none of



1	this involves layoffs. This is, in fact,
2	is the other direction. We have openings.
3	So if you have that brother-in-law that's
4	not been able to find employment for about
5	three years, send him to us.
6	I'd like to start with, hopefully
7	now I'm getting this successfully, this
8	you've already actually seen. This is the
9	basis and justification for the relevancy
10	portion of this that these goals were set
11	in most incidents roughly 27 years ago. A
12	lot has changed. Particularly as we
13	emerged from COVID, we saw changes in not
14	only our employment profiles but also what
15	customer preferences were. And as a
16	result, some of our previously
17	labor-intensive amenities have not been
18	brought back online.
19	But prior to that, there's a bigger
20	and frankly a little slightly disturbing
21	story. I've been in this job 23 years now
22	and it didn't really even hit me until I
23	put it on paper, and you'll see this in a
24	slide coming up.
25	But again, the relevancy of this,



again, same situation settlement of 1 2 procurement. Children and sensitive viewers may 3 4 want to look away at this moment. This is 5 1997 admissions tracking through June 6 2023. And the takeaway from this slide is simply this, our admissions are down 48 7 8 percent since the inception of gaming. Ιt 9 is a situation where fewer customers 10 really drive the need for fewer team 11 members to service those customers. 12 And that's to simply put whether you 13 own a bakery, an automotive repair shop or 14 anything else, reduced customer volume is 15 something that you have to address; and 16 your primary mechanism is through 17 staffing. So that is a bit of an 18 eye-opener. 19 Again, I can remember the so-called 20 good old days when we had, you know, 24 to 21 27 million people boarding these boats, 22 and that's no longer the case. 23 Contemporaneously with that, there 24 has also been a trend in revenue. The 25 year 2014, frankly, was as good as it got.

1	We fought our way back to I'm sorry,
2	2016 was as good as it got. 2014 is where
3	we are now. So in other words, we've
4	almost emerged from COVID and other
5	challenges back to where we were about
6	nine years ago.
7	That revenue trend you're seeing on
8	the screen now is the state's portion of
9	revenue; but, obviously, since it's based
10	on our gross revenue, ours tracks
11	similarly. So 2014, I believe, you
12	finally had all 15 casinos open. So that
13	was or 2014, 2015. This is fully
14	operational. This is where we peaked. We
15	declined after that. Where we're headed
16	next is obviously subject to speculation.

2	is not any layoff scenario. This is just
3	an adjustment to recognize current
4	realities or the realities of the last 27
5	years.
6	That's the actual dollars that
7	relates to that chart. So as I had
8	previously mentioned, our admissions are
9	down 48 percent, the revenue is down 29
10	percent from when these goals were
11	originally set.
12	Things such as the evolution TITO
13	and other reductions in labor-intensive

15	casino more trends towards automation less

13	next column the degree of change from
14	where they were on paper to where they
