COMPROMISE AND SETTLEMENT AGREEMENT

The Louisiana State Police, Gaming Enforcement Division (hereinafter, the "Division") and Jester's Junction Casino & Truck Stop, LLC d/b/a Jester's Junction Casino & Truck Stop (hereinafter, "Licensee"), do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has sent a Notice of Recommendation of Administrative Action to Licensee, which Notice contains allegations of certain violations of Louisiana Gaming Control Law; and

WHEREAS, the Division and Licensee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with said Notice;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

- Licensee is a Type 5 licensed establishment located at 29285 Highway 3127
 Vacherie, LA 70090.
- 2. On December 6, 2021, Kent and Jennifer Bonvillain obtained judgment of divorce in the 32nd Judicial District of Terrebonne Parish.

- 4. Prior to the divorce, the membership interest of the Licensee was as follows: 97 Rentals, LLC 50%, G3 Rentals 25%, and Del Group, LLC 25%.
- 5. Kent Bonvillain was the sole member of 97 Rentals, LLC and Jennifer Bonvillain as the spouse of Kent, held a community interest.
- 6. On June 1, 2023, the 32nd Judicial District Court ordered adjudged, and decreed a Consent Judgment of Partition of Community Property ("Consent Judgment") between Kent and Jennifer Bonvillain.
- 7. The Consent Judgment decreed that 100% of the community interest in the Licensee that was owned by 97 Rentals, LLC would be transferred to newly formed Meraki Holdings, LLC.
- 8. As a result of the Consent Judgment, the 50% membership interest of the Licensee was transferred from 97 Rentals, LLC to Meraki Holdings, LLC.
- 9. Therefore, the current membership interest of the Licensee is as follows: Meraki Holdings, LLC 50%, G3 Rentals 25%, and Delgroup LLC 25%.
- 10. The Division did not receive notification of the divorce, the Consent Judgment, or transfer of membership interests until the Licensee submitted its five-year renewal application for its Type 5 video draw poker gaming license on May 10, 2024.
- 11. The Licensee failed to timely notify the Division of a divorce and property settlement in violation of LAC 42:XI.2424.
- 12. The Licensee failed to timely notify the Division of transfers of membership interest in violation of LAC 42:X1.2417(B)(4).

TERMS AND CONDITIONS

- I. In lieu of administrative action, Licensee will pay a penalty of THREE THOUSAND (\$3,000.00) DOLLARS for its violation of LAC 42:XI:2424 and LAC 42:XI.2417(B)(4).
- 2. The Division hereby agrees that payment of a total penalty of THREE THOUSAND and 00/100 (\$3,000.00) DOLLARS shall be in full and final settlement of all matters set forth in the Notice of Recommendation of Administrative Action.
- 3. The Division reserves the right to take into consideration this admitted violation in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Licensee's suitability.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Licensee, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
- 6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.
- 7. If approved, Licensee agrees to make full payment of the civil penalty within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board. Licensee

agrees that failure to meet this requirement shall result in immediate suspension of the gaming license without the necessity of any further administrative action until such time as the penalty is paid in full.

I have read this entire Compromise and Settlement Agreement and agree to all stipulations and terms and conditions hereof.
