COME NOW the State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and Patrick J. Collins d/b/a Eastview Tavern (hereinafter "the Licensee"), who file this, their Joint Motion for Approval of Compromise and Settlement Agreement, and in support thereof would respectively show unto the Hearing Officer as follows:

The Division and the Licensee are desirous of compromising and settling all disputes between them relative to the referenced administrative proceeding. In connection therewith, the parties have entered into a compromise and settlement agreement which by its terms will become effective upon approval by the Administrative Hearing Officer and the Louisiana Gaming Control Board.

STIPULATIONS

- 1. The Internal Revenue Service notified the Division, on October 16, 2008, that the Licensee was ineligible for the required tax clearance.
- 2. On October 24, 2008, the Division issued a letter, via certified mail, instructing the Licensee to resolve the delinquency within thirty (30) days. The letter was received on November 4, 2008.
- 3. On March 31, 2009, the Louisiana Gaming Control Board issued a Notice of Recommendation of Revocation alleging certain violations of Louisiana Gaming Control Law.
- 4. The Licensee acknowledges that it was in violation of LAC 42:XI.2405B(1)(b) in that it did not remain eligible for the required tax clearance for a portion of the existence of the license.
- 5. The Licensee is now eligible for and has received tax clearance from the IRS.

TERMS AND CONDITIONS

- 1. The Licensee agrees to pay a civil penalty of Five Hundred Dollars (\$500.00).
- 2. The Division hereby agrees to accept the payment of Five Hundred Dollars Dollars (\$500.00) in full and final settlement of the Notice of Recommendation of Revocation.
- 3. The Division reserves the right to take into consideration these admitted stipulations and violations in connection with any future investigation, violation or assessment of penalty, and in connection with any future determination of the suitability of the Licensee.

COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State

Police (hereinafter the "Division") and Patrick J. Collins d/b/a Eastview Tavern, VGL

No. 3601110487 (hereinafter the "Licensee") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Revocation to the Licensee, which notice alleges certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Revocation are set for hearing before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the parties hereto are desirous of fully and finally compromising and settling all disputes and issues raised in connection with the said Notice of Recommendation of Revocation;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

- 4. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and the Licensee pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
- 5. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.
- 6. If approved, the Licensee must make full payment of the civil penalty and delinquency fee to the Division within ten (10) days of approval by the Louisiana Gaming Control Board. Failure to do so shall result in the immediate suspension of the license without the necessity of any further administrative action until such time as the penalty is paid in full.

7. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
