### COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and Cash Magic Berwick, LLC d/b/a Hollywood Truck Plaza & Casino (hereinafter, "Licensee"), do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has sent a Notice of Recommendation of Administrative Action to Licensee, which Notice contains allegations of certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by said Notice are set for hearing before the Louisiana Gaming Control Board Administrative Hearing Office on Tuesday, January 19, 2016.

WHEREAS, the Division and Licensee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with said Notice;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

#### **STIPULATIONS**

- 1. On October 22, 2015, the Division conducted a compliance inspection of the licensed establishment of the Licensee. The licensed establishment is a truck stop facility with 50 active video gaming devices.
- 2. During the inspection, General Manager/Tech 1, Britanya D. Levy ("Ms. Levy"), was on duty at the licensed establishment. Also, Sherneeka R. Phillips ("Ms. Phillips") was the security guard on duty at the licensed establishment.

- The Division asked Ms. Phillips for her credentials as a security officer. In response, Ms. Phillips stated that she was employed by Weiser Security Services, Inc. ("Weiser") and that Weiser did not issue her a Louisiana State Board of Private Security Examiners security card or a temporary card. Ms. Phillips did not have her security identification card during the inspection. Ms. Phillips later recanted her previous statements and stated she had left her security identification card at home.
- 4. On October 29, 2015, Ms. Levy submitted Ms. Phillips' security credentials to the Division by email. According to documents submitted with the email, she was hired by Weiser on November 3, 2012, the Louisiana Board of Security Examiners issued her a card on October 30, 2014, and the card is valid until November 3, 2016.
- 5. The Licensee failed to have an off duty uniformed P.O.S.T. certified law enforcement officer or a security guard who possessed a security guard identification card issued by the Louisiana State Board of Security Examiners on duty at the licensed establishment.

#### TERMS AND CONDITIONS

- 1. In lieu of administrative action, Licensee will pay a penalty of TWO HUNDRED FIFTY and No/100 (\$250.00) DOLLARS for its violation of LAC 42:XI.2415(B)(1).
- 2. The Division hereby agrees that payment of a total penalty of TWO HUNDRED FIFTY and No/100 (\$250.00) DOLLARS shall be in full and final settlement of all matters set forth in the Notice of Recommendation of Administrative Action.
- 3. The Division reserves the right to take into consideration this admitted violation in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Licensee's suitability.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

5. This Compromise and Settlement Agreement constitutes the entire agreement

between the Division and Licensee, pertaining to the subject matter contained herein and

supersedes all prior and contemporaneous agreements, representations and understandings of the

parties.

6. This Compromise and Settlement Agreement is subject to approval by the

Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this

proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory,

but will be submitted to the Louisiana Gaming Control Board for its determination as to whether

to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

7. If approved, Licensee agrees to make full payment of the civil penalty within

fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board.

Licensee agrees that failure to meet this requirement shall result in immediate suspension of the

gaming license without the necessity of any further administrative action until such time as the

penalty is paid in full.

I have read this entire Compromise and Settlement Agreement and agree to all stipulations and

terms and conditions hereof.
