
A true and correct copy of the proposed Compromise and Settlement Agreement is attached hereto as Exhibit "A" and incorporated by reference for all purposes.

COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and Perino's, Inc. d/b/a Sam Perino's Seafood & Deli (hereinafter, "Sam Perino's"), do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Administrative Action to Sam Perino's alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Administrative Action are set for hearing before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and Sam Perino's are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notice of Recommendation of Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

1. On August 1, 2007, by a "Donation", Lena R. Perino transferred all of her shares of stock in Sam Perino's, namely 75 shares to Salvadore J. Perino, Jr. (Mr. Perino), wherein Mr. Perino became the 100% owner of Sam Perino's

2. The licensee failed to notify the Division of the transaction within 10 days of its occurrence.

TERMS AND CONDITIONS

1. In lieu of administrative action, Sam Perino's will pay a civil penalty of Five Hundred and No/100 (\$500.00) Dollars.

2. The Division hereby agrees to accept Sam Perino's payment of the above stated penalty in full and final settlement of the Notice of Recommendation of Administrative Action.

3. The Division hereby agrees to dismiss the Notice of Recommendation of Administrative Action against Sam Perino's.

4. The Division reserves the right to take into consideration these admitted violations in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Sam Perino's suitability.

5. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

6. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Sam Perino's, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.


7. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits. Failure to pay the penalty within fifteen (15) days of approval of this settlement by the Louisiana

Gaming Control Board, and to comply with each term and condition listed herein, shall result in the immediate suspension of Sam Perino's license without the necessity of further administrative action, until such time as the penalty is paid in full.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms and conditions hereof.


ORDER
