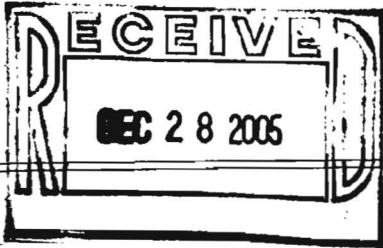

**JOINT MOTION FOR ENTRY OF STIPULATIONS AND
APPROVAL OF PROPOSED SETTLEMENT**

ON THE JOINT MOTION OF:

1. the State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "Division"), and
2. MCD Inc. d/b/a Fantastique Lounge, license No. 2600109867 (hereinafter "Licensee"), who respectfully represent the following:

WHEREAS:

1. The Licensee is barred by LAC 42:XI.2405(A)(15) from making or assisting in making false statements, including the submission of improperly notarized documents to the Division.
2. The Licensee submitted improperly notarized documents signed by Bruce Keen, President of MCD, Inc. d/b/a Fantastique Lounge, to the Division which included but was not limited to the following documents:

Request to Release Information, dated May 2, 2000,
signed by Bruce Keen

Annual License form dated May 14, 2001 and signed by
Bruce Keen

Registry Information/VERIFICATION form, dated June
13, 2002, signed by Bruce Keen

Request to Release Information form, dated May 8, 2003,
signed by Bruce Keen

3. The attached affidavit of Bruce Keen supports these stipulations and is incorporated into this agreement by reference.

4. This matter has been scheduled for hearing on December 27, 2005, at 9:30 a.m. before the Honorable Joseph E. Anzalone, Jr.

NOW THEREFORE, in consideration of the foregoing stipulations, the Division and the Licensee hereby propose to settle this matter pursuant to the following terms and conditions:

- 1. The Licensee admits that it submitted improperly notarized documents to the Division in violation of LAC 42:XI.2405(A)(15);**
- 2. Further, the Licensee agrees to pay a civil penalty of One Thousand Dollars (\$1000.00);**
- 3. The Division hereby agrees to accept the payment of this civil penalty as full and final settlement of this matter;**
- 4. The Division reserves the right to take into consideration these violations in connection with any future violation;**
- 5. The form and substance of this settlement are to be interpreted under the laws of the State of Louisiana;**
- 6. This settlement constitutes the entire agreement between the Division and MCD Inc. d/b/a Fantastique Lounge pertaining to the subject matter contained herein, and supercedes all prior and contemporaneous agreements, representations, and understandings of the parties; and**
- 7. This settlement is subject to approval by the Hearing Officer of the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not executory and will be submitted to the Board for its determination as to whether the matter should be remanded to the Hearing Officer for a full hearing. If approved, however, the Licensee must make payment of the**

civil penalty to the Division within fifteen (15) days of approval. Failure to




