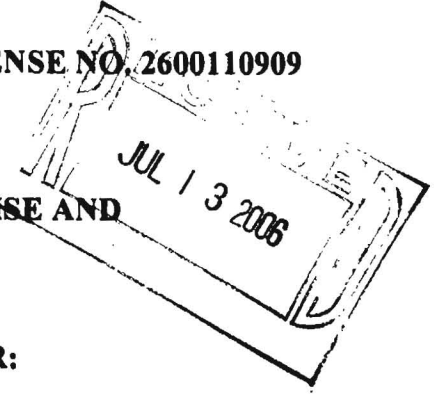

COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and McGuire Pit Stop d/b/a McGuire's Pub of New Orleans (hereinafter "Pub of New Orleans") VGL 2600110909, do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Administrative Action to Pub of New Orleans, which notice alleges certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Administrative Action are set for hearing on July 19, 2006, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the parties hereto are desirous of fully and finally compromising and settling all disputes and issues raised in connection with the said Notice of Recommendation of Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

1. Pub of New Orleans is licensed as a Type 1 video gaming establishment.

2. Pub of New Orleans sent improperly notarized video gaming documents, including, but not limited to, the Video Gaming Application (the "Documents") to the Division.

3. On April 18, 2006, the Louisiana Gaming Control Board issued a Notice of Recommendation of Administrative Action to Pub of New Orleans alleging certain violations of Louisiana Gaming Control Law.

4. Jeffrey T. McGuire and Janine McGuire stipulate that all of the statements, responses, disclosures and representations provided in the Documents bearing their signatures, are true and correct to the best of their knowledge, information and belief, and represent a complete and accurate account of the requested information.

TERMS AND CONDITIONS

1. Any and all information discovered throughout the course of this or any other investigation may be used in any future determination of the suitability of Jeffrey T. McGuire and Janine McGuire.

2. Pub of New Orleans agrees to pay a civil penalty of One Thousand and No/100 (\$1,000.00) Dollars.


3. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Pub of New Orleans pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

4. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

5. If approved, Pub of New Orleans must make payment of the civil penalty to the Division within ten (10) days of approval by the Louisiana Gaming Control Board. Failure to do so shall result in the immediate suspension of the license without the necessity of any further administrative action until such time as the penalty is paid in full.


6. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

I have read this entire Compromise Settlement Agreement, understand it, and agree to all stipulations and terms and conditions hereof.

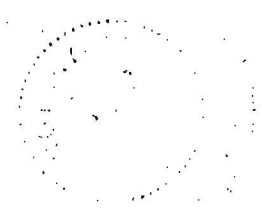


