**COMPROMISE AND SETTLEMENT AGREEMENT**

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter sometimes referred to as the "Division") and Little Deuces, Inc. d/b/a Little Deuces (hereinafter sometimes referred to as "Licensee") do hereby represent and agree as follows:

**WHEREAS**, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Administrative Action ("Notice") to Licensee alleging certain violations of Louisiana Gaming Control Law; and

**WHEREAS**, the issues raised by the said Notice are set for hearing on April 21, 2010, before the Louisiana Gaming Control Board Administrative Hearing Office; and

**WHEREAS**, the Division and Licensee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notice of Recommendation of Administrative Action;

**NOW, THEREFORE**, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

## STIPULATIONS

1. Licensee failed to timely notify the Division of a December 17, 1998, change in ownership and change in roster of officers and directors, in violation of LAC 42:XI.2405(A)(13), LAC 42:XI.2411(A)(9) and LAC 42:XI.2417(B)(4);
2. Licensee failed to timely notify the Division of a December 31, 1999, change in ownership, in violation of LAC 42:XI.2405(A)(13) and LAC 42:XI.2417(B)(4);
3. Salvador Tantillo, Jr. failed to disclose on his 1999-2000 Personal History Questionnaire that he was issued a summons for Resisting Arrest by the Hammond Police Department on August 21, 1998, in violation of LAC 42:XI.2405(A)(13), LAC 42:XI.2417(B)(4) and LAC 42:XI.2417(C)(1)(f);
4. Licensee failed to disclose on its 1999-2000 renewal application and its 2004-2005 renewal application that Salvador Tantillo, Jr. was issued a summons for Resisting Arrest by the Hammond Police Department on August 21, 1998, in violation of LAC 42:XI.2405(A)(13), LAC 42:XI.2417(B)(4) and LAC 42:XI.2417(C)(1)(f);
5. Licensee failed to timely notify the Division of the arrest of Salvador Tantillo, Jr. on May 29, 2006, for Domestic Violence, in violation of LAC 42:XI.2405(A)(13) and LAC 42:XI.2417(B)(4);
6. Licensee to failed timely disclose the marriage of Salvador Tantillo, Jr. to Erin McAndrew on December 4, 2005, in violation of LAC 42:XI.2405(A)(13) and LAC 42:XI.2417(B)(4);
7. Licensee to failed timely disclose the issuance of a protective order against Salvador Tantillo, Jr. on May 21, 2006, in violation of LAC 42:XI.2405(A)(13) and LAC 42:XI.2417(B)(4); and

8. Licensee failed to timely notify the Division of the divorce of Salvador Tantillo, Jr. and Erin McAndrew on August 23, 2007, in violation of LAC 42:XI.2405(A)(13) and LAC 42:XI.2417(B)(4).

#### **TERMS AND CONDITIONS**

1. In lieu of administration action, the Licensee will pay a civil penalty of THREE THOUSAND TWO HUNDRED FIFTY DOLLARS and No/100 (\$3,250.00) for violating LAC 42:XI.2405(A)(13), LAC 42:XI.2411(A)(9), LAC 42:XI.2417(B)(4) and LAC 42:XI.2417(C)(1)(f).

2. The Division hereby agrees to accept the Licensee's payment of the above stated penalty in lieu of administrative action in full and final settlement of the Notice of Administrative Action issued February 4, 2010.

3. The Division reserves the right to take into consideration these admitted violations in connection with any future investigation, violation or assessment of penalty, and in connection with any future assessments of the Licensee's suitability.


4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the state of Louisiana.

5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Licensee, regarding the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve the same or to remand the matter to the Hearing Officer for a full hearing on the

merits. Failure to pay the penalty within fifteen (15) days of approval of this settlement shall result in the immediate suspension of Little Deuces, Inc. d/b/a Little Deuces license without the necessity of further administrative action, until such time as the penalty is paid in full.

I have read this entire Compromise and Settlement Agreement and agree to all stipulations and terms and conditions hereof.

ORDERED, ADJUDGED, AND DECREED that the Compromise and Settlement Agreement attached to the parties' Joint Motion for Approval of Compromise and Settlement Agreement be, and the same is hereby, APPROVED; that the Licensee must pay Three Thousand Two Hundred Fifty Dollars and No/100 (\$3,250.00) to the Division within fifteen (15) days of the approval by the Louisiana Gaming Control Board. Failure to do so shall result in the immediate suspension of the license of Little Deuces, Inc. d/b/a Little Deuces without the necessity of any further administrative action until such time as the penalty is paid in full.


