COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and PNK (Lake Charles), L.L.C. d/b/a L'Auberge du Lac (hereinafter, "PNK Lake Charles") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Administrative Acton to PNK Lake Charles alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Administrative
Acton are set for hearing before the Louisiana Gaming Control Board Administrative Hearing
Office; and

WHEREAS, the Division and PNK Lake Charles are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notice of Recommendation of Administrative Acton;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

- 1. In 2005, PNK Lake Charles employed a Senior Director of Security, Compliance and Risk Management. This position required the individual to possess a Key Gaming Employee Permit.
 - 2. A conditional Key Gaming Employee Permit was issued on May 3, 2006.
- 3. Prior to securing the conditional permit, the Senior Director of Security, Compliance and Risk Management performed activities regulated by the Louisiana Gaming Control Law.
- 4. These activities constitute a violation of LAC 42:XIII.2107, LAC 42:XIII.2159, and LAC 42:XII.2715(G).

TERMS AND CONDITIONS

- 1. PNK Lake Charles will pay a civil penalty of NINETY THOUSAND AND NO/100 DOLLARS (\$ 90,000.00).
- 2. The Division hereby agrees to accept PNK Lake Charles' payment of the above stated penalty in full and final settlement of CGD060092.
- 3. The Division reserves the right to take into consideration these admitted violations in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of PNK Lake Charles' suitability.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and PNK Lake Charles, pertaining to the subject matter contained herein

and supersedes all prior and contemporaneous agreements, representations and understandings of

the parties.

6. This Compromise and Settlement Agreement is subject to approval by the

Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this

proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory,

but will be submitted to the Louisiana Gaming Control Board for its determination as to whether

to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

Failure to pay the penalty within fifteen (15) days of approval of this settlement by the Louisiana

Gaming Control Board, and to comply with each term and condition listed herein, shall result in

the immediate suspension of PNK Lake Charles' license without the necessity of further

administrative action, until such time as the penalty is paid in full.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms

and conditions hereof.
