DECISION OF THE LOUISIANA GAMING CONTROL BOARD

IN RE: BRANDI N. BRADBURY NO. P040066150

This matter is before the Louisiana Gaming Control Board on appeal by Brandi N. Bradbury, from the Hearing Officer's decision dated December 7, 2022, wherein her Non-Key Gaming Employee permit was revoked.

Brandi N. Bradbury was arrested on August 24, 2022 for violation of La. R.S. 14:69.1(8)(1), Illegal Possession of Stolen Firearms First Offense; La. R.S. 40:966(A) (I), Produce, Manufacture, Distribute or Possess with Intent Schedule I Narcotic; La. R.S. 40: I023(C), Prohibited Acts; Drug Paraphernalia; La. R.S. 14:95(E), Illegal Carrying of Weapons, During Commission of a Crime or in the Presence of CDS; La. R.S. 14:9 I. 13, Illegal Use of Controlled Dangerous Substances in the Presence of Persons Under Seventeen Years of Age.

A Bill of Information was filed on October 31, 2022 charging Brandi N. Bradbury with violation of La. R.S. 40:966(A)(I), Possession of CDS I With Intent, a Felony; La. R.S. 14:69. 1(A), Illegal Possession of a Stolen Firearm, a Felony; and La. R.S. 14:95.(E), Illegal use/possession/control of weapons/CDS, a Felony. These Felony criminal charges remain pending against Ms. Bradbury.

The evidence offered by the Division showed that the Permittee allowed an individual to stay in her home and store illegal items in the home that she shares with her children. According to La. R.S. 27:28(0), "An applicant who is not disqualified as a result of Subsection B... shall still be required to demonstrate to the board or division that he otherwise meets the remaining requirements for suitability, particularly those contained in Subparagraphs (A)(1), (2), and (3) of this Subsection. Evidence of, or relating to, an arrest, summons, charge, or indictment of an applicant, or the dismissal thereof, may be considered by the board or division even if the arrest,

summons, charge, or indictment results in acquittal, deferred adjudication, probation, parole, or pardon." Ms. Bradbury allowed criminal activity in her home, which led to her current criminal charges. Even if the Permittee's charges are dismissed at a later date, it would not erase the fact that she acquiesced to the criminal activity in her home.

Based on the actions of Ms. Bradbury and pursuant to Louisiana Gaming Law, Brandi N. Bradbury is unsuitable for possession of a Non-Key Gaming Employee permit.

ORDER

This matter having been re-considered by the Louisiana Gaming Control Board in open meeting of March 16, 2023:

IT IS ORDERED THAT the Hearing Officer's decision revoking the Non-Key Gaming Employee permit of Brandi N. Bradbury, P040066150, is **AFFIRMED**.
