#### COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and Allison G. Enterprise, LLC d/b/a Bayou Belle Truck Stop & Casino (hereinafter, "Allison G."), do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Revocation to Allison G., which Notice contains allegations of certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Revocation has been set for hearing before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and Allison G. are desirous of fully and finally settling all issues and disputes arising out of and in connection with the said Notice of Recommendation of Revocation;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

#### STIPULATIONS

 Allison G. is a Type 5 licensed establishment located at 2924 Grand Point Highway, Breaux Bridge, Louisiana 70517.

 On April 30, 2015, the Division conducted a compliance inspection at Allison G., which revealed violations of Louisiana Gaming Law and regulations.

3. Allison G. stipulates that it did not have fifty (50) available eighteen-wheel tractor trailer parking spaces.

4. On June 9, 2016, a follow-up inspection was completed and Allison G. had corrected all violations, which were revealed during the April 30, 2015 inspection.

## TERMS AND CONDITIONS

1. In lieu of Revocation of its Gaming License, Allison G. will pay a civil penalty of TEN THOUSAND AND NO/100 (\$10,000.00) DOLLARS for the violation of La. R.S. 27:2(A), La. R.S. 27:412(A)(1), La. R.S. 412(A)(2), La. R.S. 27:417(A)(3)(a) and (c), La. R.S. 27:417(C), LAC 42:XI.2415(D)(6), LAC 42:XI.2417(A)(1), LAC 42:XI.2417(A)(3), and LAC 42:XI.2417(C)(1)(c).

2. The Division hereby agrees to accept Allison G.'s payment of the above stated penalty in full and final settlement of the Notice of Recommendation of Revocation for Allison G.'s violation of La. R.S. 27:2(A), La. R.S. 27:412(A)(1), La. R.S. 412(A)(2), La. R.S. 27:417(A)(3)(a) and (c), La. R.S. 27:417(C), LAC 42:XI.2415(D)(6), LAC 42:XI.2417(A)(1), LAC 42:XI.2417(A)(3), and LAC 42:XI.2417(C)(1)(c).

3. The Division reserves the right to take into consideration this admitted violation in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Allison G.'s suitability. 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Allison G., pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations, and understandings of the parties.

6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if the Hearing Officer approves this proposed settlement, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

7. If approved, Allison G. agrees to make full payment of the civil penalty to the Division within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board. Allison G. agrees that failure to meet this requirement shall result in immediate suspension of the gaming license without the necessity of any further administrative action, until such time as the penalty is paid in full.

I have read this entire Compromise and Settlement Agreement and agree to all stipulations and rerms and conditions hereof.
