#### COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter the "Division") and Atlas Blowpipe & Sheet Metal Works, Inc. License No. P082602582 (hereinafter "Permittee") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Enforcement Division has issued a Notice of Recommendation of Administrative Action to Permittee, alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Administrative Action are set for hearing on April 4, 2007, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and Permittee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notice of Recommendation of Administrative Action;

**NOW, THEREFORE**, in consideration of the foregoing, the parties hereto do herby agreed and stipulate as follows:

#### STIPULATION

Permittee stipulates that on January 6, 2006, Mr. Douglas T. Stubbs, the executive Vice-President of the company was arrested, by the Jefferson Parish Sheriff's Office for Battery of a Police Officer in violation of La. R.S. 14:34.2. On June 7, 2006 Mr. Stubbs pled guilty to the amended charge of Disturbing the Peace under Article 894. Permittee failed to notify the Division of the arrest of Mr. Stubbs within fifteen (15) calendar days of the arrest which violates, LAC 42:XIII.2901(B)(4).

#### TERMS AND CONDITIONS

- 1. Within fifteen (15) days of the approval of this settlement by the Louisiana Gaming Control Board, Permittee shall pay Five Thousand and No/ 100 (\$5,000.00) Dollars for the violation of LAC 42:XIII.2901 (B) (4).
- 2. Pursuant to the Administrative penalty schedule approved by the Louisiana Gaming Control Board, the Division hereby agrees to a Five Thousand and No/ 100 (\$5,000.00) Dollars fine for the Permittee's violation of LAC 42:XIII.2901 (B) (4).
- 3. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 4. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Permittee, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
- 5. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory,

but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

6. If approved by the Louisiana Gaming Control Board, Permittee must pay Five Thousand and No/ 100 (\$5,000.00) Dollars within fifteen (15) calendar days of such approval. Any failure to meet this requirement will result in immediate suspension of the gaming permit until such payment is made without the necessity of any further administrative action.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms and conditions hereof.
