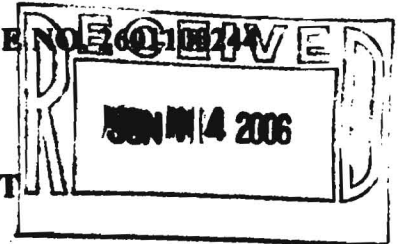

COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and DC's Lounge, Inc. d/b/a DC's Lounge (hereinafter "DC's Lounge") VGL 2601100244, do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Administrative Action to DC's Lounge, which notice alleges certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Administrative Action are set for hearing on June 12, 2006, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the parties hereto are desirous of fully and finally compromising and settling all disputes and issues raised in connection with the said Notice of Recommendation of Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

1. DC's Lounge is licensed as a Type 1 video gaming establishment.

2. DC's Lounge sent improperly notarized video gaming documents, including, but not limited to, the Video Gaming Application (the "Documents") to the Division.

3. On April 18, 2006, the Louisiana Gaming Control Board issued a Notice of Recommendation of Administrative Action to DC's Lounge alleging certain violations of Louisiana Gaming Control Law.

4. Rachel Poplin admits that she did not sign the Documents in the presence of a notary and that the Documents were not notarized in the Affiant's presence. Thus, the Documents were improperly notarized in violation of LAC 42:XI.2405 (A)(15).

5. Rachel Poplin stipulates that all of the statements, responses, disclosures and representations provided in the Documents bearing her signature, are true and correct to the best of her knowledge, information and belief, and represent a complete and accurate account of the requested information.

6. Eve Lynn Taquino admits that she failed to produce documents related to the 1998 bankruptcy to the Division in a timely fashion in violation of La. R.S. 27:309(A).

TERMS AND CONDITIONS

1. Any and all information discovered throughout the course of this or any other investigation may be used in any future determination of the suitability of Rachel Poplin.

2. DC's Lounge agrees to pay a civil penalty of One Thousand and No/100 (\$1,000.00) Dollars, for the improper notarization and Five Hundred and No/100 (\$500.00) Dollars for the failure to produce documents in a timely fashion.


3. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and DC's Lounge pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

4. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this





Failure to do so shall result in the immediate suspension of the license without the necessity of any further administrative action until such time as the penalty is paid in full.


6. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.


