LOUISIANA GAMING CONTROL BOARD

Minutes of December 15, 2016

The monthly meeting of the Louisiana Gaming Control Board was convened on Thursday, December 15, 2016, 10:00 a.m., in House Committee Room 1 of the Louisiana State Capitol. Present at the meeting were: Ronnie Jones, Chairman, Ayres Bradford, Mark Stipe, James Singleton, Claude Jackson, Julie Berry and Wanda Theriot. Absent were board member Robert Gaston and ex-officio members, Colonel Mike Edmonson and Secretary Kimberly Robertson.

The meeting was called to order. It was moved by Mr. Singleton to waive the reading and approve the minutes of the November meeting. That motion was seconded by Mr. Stipe and unanimously approved by the Board.

Ms. Donna Jackson, State Police Gaming Audit Section, provided revenue reports for the riverboats, landbased casino, slots at the track, video poker, and also reported on the employee numbers for the landbased casino.

The Board considered the Certificate of Compliance for the Alternate Riverboat Inspection of the gaming vessel of Red River Entertainment of Shreveport Partnership in Commendam d/b/a Sam's Town Hotel and Casino, No. R016500097. Following discussion, it was moved by Mr. Jackson to the issue the Certificate of Compliance. That motion was seconded by Ms. Berry and unanimously approved by the Board.

The Board considered the Certificate of Compliance for the Alternate Riverboat Inspection of the gaming vessel of Eldorado Casino Shreveport Joint Venture d/b/a Eldorado Resort Casino Shreveport, No. R013600005.
