COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State

Police (hereinafter, the "Division") and Lawrence Weatherstrand (hereinafter, "Mr.

Weatherstrand") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of

Recommendation of Suspension and Penalty to Mr. Weatherstrand alleging certain violations of

Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Suspension and

Penalty are set for hearing before the Louisiana Gaming Control Board Administrative Hearing

Office on July 27, 2011; and

WHEREAS, the Division and Mr. Weatherstrand are desirous of fully and finally

compromising and settling all issues and disputes arising out of and in connection with the said

Notice of Recommendation of Suspension and Penalty;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby

agree and stipulate as follows:

STIPULATIONS

1. Mr. Weatherstrand is a non-key gaming employee permittee residing at 1784

Carol Sue, Apartment 10A, Gretna, Louisiana 70056.

- 2. By application dated October 21, 2010, Mr. Weatherstrand sought renewal of his non-key gaming employee permit.
- 3. On January 5, 2011, the Division received notification from the Internal Revenue Service that Mr. Weatherstrand was not current in the filing of all applicable tax returns or in the payment of all taxes owed, in violation of La. R.S. 27:28(F), LAC 42:XIII.2115(A), LAC 42:XIII.2115(B)(1) and (2), LAC 42:IX.2131(A), LAC 42:IX.2131(B), LAC 42:VII.2115(A) and LAC 42:VII.2115 (B)(1) and (2).
- 4. The Division notified Mr. Weatherstrand by certified mail that his tax delinquency must be corrected within thirty (30) days of receipt of the notice and that a failure to do so would result in his permit being recommended for suspension, revocation and/or the imposition of a civil penalty. Mr. Weatherstrand received the delinquency letter on January 11, 2011. As of April 15, 2011, the Division had not received a tax clearance for Mr. Weatherstrand.
- 5. On May 3, 2011, the Division was notified that Mr. Weatherstrand was granted Federal tax clearance, as the Federal tax compliance and/or payment issues for Mr. Weatherstrand had been resolved.
- 6. Between January 5, 2011, and May 3, 2011, Mr. Weatherstrand was not current in the filing of all applicable tax returns or in the payment of all taxes owed, in violation of La. R.S. 27:28(F), LAC 42:XIII.2115(A), LAC 42:XIII.2115(B)(1) and (2), LAC 42:IX.2131(A), LAC 42:IX.2131(B), LAC 42:VII.2115(A) and LAC 42:VII.2115 (B)(1) and (2).

TERMS AND CONDITIONS

1. In lieu of Suspension and Penalty of his gaming permit, Mr. Weatherstrand will pay a civil penalty of TWO HUNDRED FIFTY AND NO/100 (\$250.00) DOLLARS for his violations of La. R.S. 27:28(F), LAC 42:XIII.2115(A), LAC 42:XIII.2115(B)(1) and (2),

LAC 42:IX.2131(A), LAC 42:IX.2131(B), LAC 42:VII.2115(A) and LAC 42:VII.2115 (B)(1) and (2).

- 2. The Division hereby agrees to accept Mr. Weatherstrand's payment of the above stated penalty in full and final settlement of the Notice of Recommendation of Suspension and Penalty for Mr. Weatherstrand's violations of La. R.S. 27:28(F), LAC 42:XIII.2115(A), LAC 42:XIII.2115(B)(1) and (2), LAC 42:IX.2131(A), LAC 42:IX.2131(B), LAC 42:VII.2115(A) and LAC 42:VII.2115 (B)(1) and (2).
- 3. The Division reserves the right to take into consideration these admitted violations in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Mr. Weatherstrand's suitability.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Mr. Weatherstrand, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations, and understandings of the parties.
- 6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits. Failure to pay the penalty within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board, and to comply with each term and condition listed herein, shall result in

the immediate suspension of Mr. Weatherstrand's permit without the necessity of further administrative action, until such time as the penalty is paid in full.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms and conditions hereof.
