COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State

Police (hereinafter the "Division") and Assa Abloy Hospitality, Inc., Permit No. P086501804

(hereinafter "Permittee") do hereby represent and agree as follows:

WHEREAS, the Louisiana General Gaming Division has issued a Notice of

Recommendation of Suspension and Penalty dated May 22, 2006, and a Notice of

Administrative Action dated April 25, 2006, alleging certain violations of Louisiana Gaming

Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Administrative

Action, are set for hearing on October 18, 2006, before the Louisiana Gaming Control Board

Administrative Hearing Office; and

WHEREAS, the Division and Permittee are desirous of fully and finally compromising

and settling all issues and disputes arising out of and in connection with the said Notice of

Recommendation of Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby

agree and stipulate as follows:

1

STIPULATIONS

- 1. Permittee stipulates that Assa Abloy Hospitality, Inc. failed to report material changes made since the submission of the original application. Assa Abloy Hospitality, Inc. submitted affidavits with the 2005 renewals that indicated no changes occurred, and as a result of this conduct violated LAC 42:XIII.2901(B)(2)(c).
- 2. Assa Abloy Hospitality, Inc. submitted the annual permit fee after the anniversary date of the permit and as a result of this conduct violated La. R.S. 27:29(F).
- 3. The suitability documents of Marc Freundlich, President of Assa Abloy Hospitality, Inc., are considered timely and acceptable and were submitted August 16, 2006, and received by the Division on August 17, 2006.

TERMS AND CONDITIONS

- 1. Within fifteen (15) days of the approval of this settlement by the Louisiana Gaming Control Board, Permittee shall pay Twenty Thousand and No/100 (\$20,000.00) Dollars for the violation of La. R. S. 27:29(F) and LAC 42:XIII:2901(B)(2)(c).
- 2. The Division hereby agrees to a Twenty Thousand and No/100 (\$20,000.00) Dollar fine for the Permittee's violation of La. R.S. 27:29(F) and LAC 42:XIII.2901(B)(2)(c).
- 3. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 4. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Permittee pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

This Compromise and Settlement Agreement is subject to approval by the

but will be submitted to the Louisiana Gaming Control Board for its determination as to whether

to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

6. If approved by the Louisiana Gaming Control Board, Permittee must pay Twenty

Thousand and No/100 (\$20,000.00) Dollars within fifteen (15) calendar days of such approval.

Any failure to meet this requirement will result in immediate revocation of the gaming license

without the necessity of any further administrative action.
