

## LOUISIANA GAMING CONTROL BOARD

## Minutes of July 15, 2021

The monthly meeting of the Louisiana Gaming Control Board was convened on Monday, June 17, 10:00 a.m., at the Louisiana State Capitol Building, House Committee Room 1. Present at the meeting were: Vice-Chair Julie Berry, Harry Avant, Claude Jackson, Julie Lewis, O. Lamar Poole, Jr., Franchesca Hamilton-Acker, Ronald Sholes, and Ashley Traylor. Absent were exofficio members Col. Lamar Davis and Sec. Kimberly Lewis.

The meeting was called to order. It was moved by Mr. Jackson to waive the reading and approve the minutes of the May 17, 2021, meeting. The motion was seconded by Ms. Lewis and unanimously approved by the Board.

Jeff Traylor, Director of Louisiana State Police Gaming Audit Section, provided revenue reports for the riverboats, slots at the racetracks and landbased casino. He also reported on the video poker statistics.
