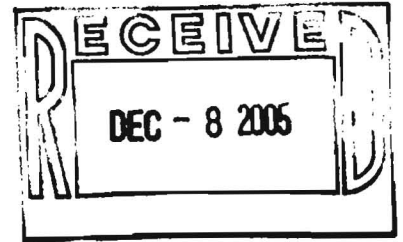

**JOINT MOTION FOR ENTRY OF STIPULATIONS AND
APPROVAL OF PROPOSED SETTLEMENT**

ON THE JOINT MOTION OF:

1. The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "Division"), and
2. MARVIN ANTOINE, Permit No. P086501469 (hereinafter "Permittee"),

who respectfully represent the following:

WHEREAS:

1. On or about September 22, 2005, the Division received notification from the Internal Revenue Service that Permittee was not current in the filing of all applicable tax returns or in the payment of all taxes owed. Permittee was notified on or about September 25, 2005, by certified mail that Permittee had thirty (30) days to provide the Division with documentation that a tax clearance had been issued.
2. The Permittee had not provided documentation of a tax clearance to the Division until on or about October 21, 2005.
3. The Permittee is mandated by La. R.S. 27:28B(3) to remain current with all tax filings and payments owed to the State of Louisiana, any political subdivision of Louisiana, or the Internal Revenue Service.

4. Permittee was issued a *Notice of Recommendation of Suspension and Penalty* by the Louisiana Gaming Control Board (hereinafter, "Board").

5. This matter has been scheduled for hearing on December 1, 2005, at 9:30 a.m. before the Honorable Joseph E. Anzalone, Jr.

NOW THEREFORE, in consideration of the foregoing stipulations, the Division and the Permittee hereby propose the following settlement, that:

1. The Permittee acknowledges that La. R.S. 27:28B(3) mandates a permittee to remain current with all tax filings and payments owed to the State of Louisiana, any political subdivision of Louisiana, or the Internal Revenue Service;
2. The Permittee further acknowledges receipt of notification on or about September 25, 2005, by certified mail that he had had thirty (30) days to provide the Division with documentation that a tax clearance had been issued;
3. The Permittee had not provided documentation of a tax clearance to the Division until on or about October 21, 2005;
4. In consideration of the previous and aforementioned delay in submission of the tax clearance and in lieu of further administrative action against the Permittee's gaming permit, Permittee shall pay a \$250.00 civil penalty;
5. The Division hereby agrees to accept the Permittee's payment of the above stated penalty in full and final settlement of this *Notice of Recommendation of Suspension and Penalty*;
6. The Division reserves the right to take into consideration these violations in connection with any future violation;
7. The form and substance of this settlement are to be interpreted under the laws of the State of Louisiana;

8. This settlement constitutes the entire agreement between the Division and Permittee pertaining to the subject matter contained herein, and supersedes all prior and contemporaneous agreements, representations, and understandings of the parties;

9. This settlement is subject to approval by the Hearing Officer of the Board; it is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not executory and will be submitted to the Board for its approval or remand to the Hearing Officer; if approved by the Board, however, payment of the above penalties must be submitted to the Division within fifteen (15) days of such approval; the failure to pay the civil penalty within fifteen (15) days of approval by the Board shall result in the Permittee being immediately suspended without the necessity of further notice or administrative proceedings until such time as the penalty is paid in full; and

10. The Division and the Permittee waive their rights to appeal this settlement if the Order is signed by the Hearing Officer and accepted by the Board.

Considering the foregoing Joint Motion For Entry of Stipulations and Approval of Proposed Settlement, IT IS HEREBY ORDERED that such proposed settlement be approved, to wit:

The Permittee acknowledges that La. R.S. 27:28B(3) mandates a permittee to remain current with all tax filings and payments owed to the State of Louisiana, any political subdivision of Louisiana, or the Internal Revenue Service.

In consideration of the previous and aforementioned delay in submission of the tax clearance and in lieu of further administrative action against the Permittee's gaming permit, Permittee shall pay a \$250.00 civil penalty.

Payment of the above penalty must be submitted to the State of Louisiana, Office of State Police within fifteen (15) days of such approval of this settlement by the Board; and

The failure to pay the civil penalty within fifteen (15) days of approval of this settlement by the Board shall result in the Permittee being immediately suspended without the necessity of further notice or administrative proceedings until such time as the penalty is paid in full.





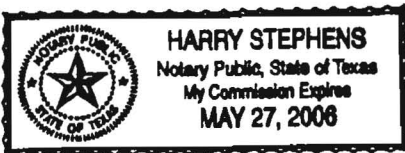
