COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of

State Police (hereinafter the "Division") and Charlette Ford (hereinafter "the Permittee")

do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of

Recommendation of Suspension and Penalty to the Permittee, which notice contains

allegations of certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of

Suspension and Penalty are set for hearing before the Louisiana Gaming Control Board

Administrative Hearing Office; and

WHEREAS, the parties hereto are desirous of fully and finally compromising

and settling all disputes and issues raised in connection with the said Notice of

Recommendation of Suspension and Penalty;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do

hereby agree and stipulate as follows:

STIPULATIONS

- 1. On November 4, 2010, the Division received notification from the Internal Revenue Service (hereinafter the "IRS") that the Permittee was not eligible for the required tax clearance.
- 2. On or about November 24, 2010, the Permittee received, via certified mail, notification that he had thirty (30) days to resolve the tax problem.
- 3. On March 15, 2011, the Louisiana Gaming Control Board issued a Notice of Recommendation of Suspension and Penalty to the Permittee alleging the Permittee's failure to remain in compliance.
- 4. Subsequent to the thirty (30) day period allowed by the Division for resolution of the tax issue, the Permittee became eligible for the IRS tax clearance.

TERMS AND CONDITIONS

- 1. The Permittee agrees to pay a civil penalty of Two Hundred Fifty Dollars (\$250.00), in lieu of suspension, for the period of non-compliance.
- 2. The Division agrees that payment of a civil penalty of Two Hundred Fifty Dollars (\$250.00) shall be in full and final settlement of all matters set forth in the Notice of Recommendation of Suspension and Penalty.
- 3. The Division reserves the right to take into consideration these admitted stipulations and violations in connection with any future investigation, violation or assessment of penalty, and in connection with any future determination of the suitability of the Permittee.
- 4. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and the Permittee pertaining to the Permittee's failure to

timely submit the tax clearances as required by gaming law and supersedes all prior and

contemporaneous agreements, representations and understandings of the parties.

5. This Compromise and Settlement Agreement is subject to approval by the

Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that

if this proposed settlement is approved by the Hearing Officer, this agreement is not

thereby executory, but will be submitted to the Louisiana Gaming Control Board for its

determination as to whether to approve same or to remand the matter to the Hearing

Officer for a full hearing on the merits.

6. If approved, the Permittee must make full payment of the civil penalty to the

Division within fifteen (15) days of approval by the Louisiana Gaming Control Board.

Failure to do so shall result in the immediate suspension of the permit without the

necessity of any further administrative action until such time as the penalty is paid in full.

7. The terms of this Compromise and Settlement Agreement shall be

interpreted under the laws of the State of Louisiana.

I have read this entire Compromise Settlement Agreement, understand it, and agree to all

stipulations and terms and conditions hereof.
