JOINT MOTION FOR ENTRY OF STIPULATIONS
AND APPROVAL OF SETTLEMENT

OCT 26 2006

ON THE JOINT MOTION OF:

1. The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "Division"), and
2. Catalanotto & Marcades, Ltd. d/b/a Southside Gaming (hereinafter "Southside"), Vincent Catalanotto (hereinafter "Catalanotto"), and Barry Marcades (hereinafter "Marcades"),

who respectfully represent the following:

WHEREAS:

This matter is pending before the Honorable William H. Brown; and

NOW, THEREFORE, in consideration of the hereinafter stipulations, Southside and Catalanotto and Marcades in their individual capacities and as shareholders of Southside do hereby propose and agree to the following settlement (hereinafter "Stipulations and Settlement") that:

1. In lieu of administrative action, Southside, Catalanotto and Marcades accept the denial of the Southside application for a device owner license and agree that Southside will not be eligible to apply for any approval authorized by the Louisiana Gaming Control Law for a



period of five (5) years from the date of approval, and Catalanotto and Marcades will not be eligible to apply for any approval authorized by the Louisiana Gaming Control Law for a period of three (3) years from the date of approval by the Board.

2. The Division hereby accepts the above agreement that Southside will not be eligible to apply for any approval authorized by the Louisiana Gaming Control Law for a period of five (5) years and that Catalanotto and Marcades will not be eligible to apply for any approval authorized by the Louisiana Gaming Control Law for a period of three (3) years from the date of approval by the Board.

3. Southside hereby agrees that it shall not, directly or indirectly, participate in the Louisiana gaming industry in any capacity which would require it to be found suitable by the Board and/or the Division for a period of five (5) years from the date of the approval by the Board.

4. Catalanotto and Marcades hereby agree that they shall not, directly or indirectly, participate in the Louisiana gaming industry in any capacity which would require them to be found suitable by the Board and/or Division for a period of three (3) years from the date of the approval by the Board.

5. By signature of their representative on this Stipulations and Settlement, Southside, Catalanotto and Marcades acknowledge these stipulations and the above prohibitions. Nothing herein shall be construed as a determination of the unsuitability of Catalanotto and Marcades.

6. The Division reserves the right to take into consideration these allegations in connection with any future applications by Southside, Catalanotto and Marcades. Consideration of these allegations shall not be deemed as an automatic disqualification.

7. The form and substances of this Stipulations and Settlement shall be interpreted under the laws of the State of Louisiana.

8. This Stipulations and Settlement constitutes the entire agreement between the Division, Southside, Catalanotto and Marcades pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

9. This Stipulations and Settlement is subject to approval by the Hearing Officer of the Louisiana Gaming Control Board; it is expressly understood that if this proposed Stipulations and Settlement is approved by the Hearing Officer, this agreement is not executory and will be submitted to the Board for its determination as to whether the matter should be heard by the Hearing Officer.

10. The Division, Southside, Catalanotto and Marcades waive their rights to appeal this Stipulations and Settlement if the Order approving this Stipulations and Settlement is signed by the Hearing Officer and approved by the Board.

ORDER

Considering the foregoing Joint Motion for Entry of Stipulations and Approval of Proposed Settlement, IT IS HEREBY ORDERED that such proposed Stipulations and Settlement be approved, to-wit:

1. Catalanotto & Marcades, Ltd. d/b/a Southside Gaming, Vincent Catalanotto, and Barry Marcades accept the denial of the application; Southside will not be eligible to apply for any approval authorized by the Louisiana Gaming Control Law for a period of five (5) years and Catalanotto and Marcades will not be eligible to apply for any approval authorized by the Louisiana Gaming Control Law for a period of three (3) years from the date of approval by the Board.

2. The Office of State Police shall accept the denial of Catalanotto & Marcades, Ltd. d/b/a Southside Gaming's application for a device owner license.

3. Catalanotto & Marcades, Ltd. d/b/a Southside Gaming shall not, directly or indirectly, participate in the Louisiana gaming industry in any capacity which would require it to be found suitable by the Board and/or the Division for a period of five (5) years from the date of approval by the Board.

4. Vincent Catalanotto and Barry Marcades shall not, directly or indirectly, participate in the Louisiana gaming industry in any capacity which would require them to be found suitable by the Board and/or the Division for a period of three (3) years from the date of approval by the Board.

5. The Office of State Police may take into consideration these allegations in connection with any future applications by Catalanotto & Marcades, Ltd. d/b/a Southside Gaming, Vincent Catalanotto, and Barry Marcades.

Consideration of these allegations shall not be deemed as an automatic disqualification.

6. The Division, Catalanotto & Marcades, Ltd. d/b/a Southside Gaming, Vincent Catalanotto, and Barry Marcades waive their rights to appeal upon approval by the Board.
