

COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter the "Division") and Oasis Foods, Inc., Permit No. P081001078 (hereinafter "Permittee"), do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Enforcement Division issued a Notice of Recommendation of Administrative Action dated October 29, 2008, alleging violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Administrative Action are set for hearing on November 18, 2009, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and Permittee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notice of Recommendation of Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

1. Oasis Foods, Inc. ("Oasis" or the "company") was incorporated in 1989. The company's articles of incorporation represent that Oasis's one hundred (100) shares of common stock were issued to:

Edward Joe Abrusley	31 shares
Wedad Anton Abrusley	20 shares

Elham Anton Deeb	29 shares
Abbas Assad Deeb	20 shares

2. In September 1997, Oasis filed its original application for a non-gaming supplier permit. The application represents the company's ownership as:

Edward Abrusley	26%
Wedad Abrusley	25%
Elham Deeb	25%
Abbas Deeb	24%

3. In May 2000, Mr. Edward Abrusley donated thirty-one (31) Oasis stock shares to his wife, Ms. Wedad Abrusley ("Ms. Abrusley"). The Division's records reflect that Oasis did not notify the Division of this transfer until the company's 2001 renewal application was filed.

4. In June 2007, Oasis redeemed the stock of Ms. Elham Deeb and Mr. Abbas Deeb. Oasis's annual permit update form dated July 9, 2007, does not reflect the stock redemption. The Division was not notified of the stock redemption until an on-site inspection in October 2007.

TERMS AND CONDITIONS

1. Permittee will pay a civil penalty of Three Thousand Five Hundred and No/100 (\$3,500.00) Dollars.

2. The Division hereby agrees to accept Permittee's payment of the above stated penalty in full and final settlement of the Notice of Recommendation of Administrative Action.


3. The Division reserves the right to take into consideration these admitted violations in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Permittee's suitability.

4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Permittee, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits. Failure to pay the penalty within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board, and to comply with each term and condition listed herein, shall result in the immediate suspension of Permittee's license without the necessity of further administrative action, until such time as the penalty is paid in full .

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms and conditions hereof.


