- 3. The licensee failed to submit the required state and local tax clearance certificate by July 1st;
- 4. Pursuant to this information, the Division issued a Notice of Violation and Hearing (Violation/Inspection Report #13913) to the licensee on or about September 24, 2002, alleging violations of LAC 42:XI.2405(B)(7);
- 5. Subsequently, the Division received the state and local tax clearance certificate on December 23, 2002;
- 6. This matter has been scheduled for hearing before the Honorable Joseph E. Anzalone, Jr.,

- 1. Willis D. Lucas, Jr. d/b/a Spring Bayou Lounge acknowledges that it was in violation of LAC 42:XI.2405(B)(7), in that it did not submit state or local tax clearances to the Division by July 1, 2002;
- 2. Willis D. Lucas, Jr. d/b/a Spring Bayou Lounge shall pay a civil penalty in the amount of \$250.00;
- 3. payment of the above penalty shall be submitted to the Division within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board; and
- 4. the failure to submit the above penalty within fifteen (15) days of approval by Willis D. Lucas, Jr. d/b/a Spring Bayou Lounge of this settlement by the Board shall result in the video gaming license of being suspended and its gaming devices being disabled.
