


**JOINT MOTION FOR APPROVAL OF COMPROMISE AND

COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and Joey's Sports Bar, LLC d/b/a Joey's Sports Bar & Casino, VGL 500113442; Joey's Sports Bar, LLC d/b/a Joey's Sports Bar & Casino A, VGL 5000113441; Joey's Sports Bar, LLC d/b/a Joey's Sports Bar & Casino B, VGL 5000113439; Joey Sports Bar & Casino, VGL 5600614427; Paula Theriot, Case No. 06007; and Hardy Joey Theriot, Jr., Case No. 06006, (hereinafter "the Licensees"), do hereby represent and agree as follows:

WHEREAS, on February 17, 2006, the Louisiana Gaming Control Board issued Notices of Recommendation of Revocation, Notices of Recommendation of Finding of Unsuitability and a Notice of Denial of Original Application to the Licensees alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by said Notices of Recommendation of Revocation, Notices of Recommendation of Finding of Unsuitability and a Notice of Denial of Original Application are set for hearing on July 26, 2006, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and the Licensees are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notices of Recommendation of Revocation, Notices of Recommendation of Finding of Unsuitability and a Notice of Denial of Original Application;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

1. On or about May 17, 2004, the Division received Licensees' renewal application.
2. On or about May 27, 2004, the Division commenced a background investigation of Licensees.
3. As a result of the investigation, the Division determined Licensees did not provide adequate notice of a criminal offense.
4. Licensee made misleading or false statements to the Division in violation of LAC 42:XI.2417 B (2) (c).
5. Licensee and spouse knowingly and willingly voted in a city election on April 6, 2002, in violation of La. R.S. 18:1461 A (10).

TERMS AND CONDITIONS

1. Within fifteen (15) days of the approval of this settlement by the Louisiana Gaming Control Board, the Licensee shall pay a civil penalty of Thirty Thousand Dollars (\$30,000.00).
2. The Division hereby agrees to accept the payment of the above stated penalty in full and final settlement of all violations alleged in the February 17, 2006, Notices of Recommendation of Revocation, Notices of Recommendation of Finding of Unsuitability and a Notice of Denial of Original Application.

3. Nothing herein shall be construed as a determination of the unsuitability of Paula Theriot, Hardy Joey Theriot, Jr., or Joey's Sports Bar, L.L.C.

4. The Division reserves the right to take into consideration these allegations in connection with any future violations by Licensees. Consideration of these allegations shall not be an automatic disqualification.

5. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

6. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and the Licensees pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

7. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

8. If approved, however, payment of the above penalty must be submitted to the Division within fifteen (15) days of approval of this settlement by the Board. The failure to submit the civil penalty within fifteen (15) days of approval by the Board shall result in the immediate suspension of the licenses until such time as the penalty is paid in full.

The parties have read this entire Compromise and Settlement Agreement and agree to all stipulations and terms and conditions hereof.


