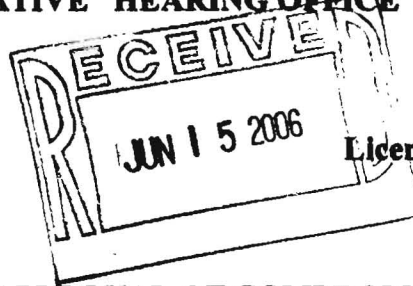

A true and correct copy of the proposed Compromise and Settlement Agreement is attached hereto as Exhibit "A" and incorporated by reference for all purposes.



COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and RGGB Marketing, Inc. d/b/a Jabba Jaws, VGL 2600110418, do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Administrative Action to RGGB Marketing, Inc. d/b/a Jabba Jaws ("Jabba Jaws") which notice alleges certain violations of Louisiana Gaming Control Law; and

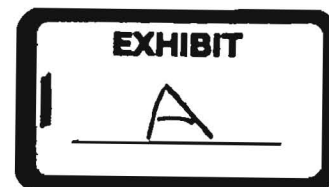
WHEREAS, the issues raised by the said Notice of Recommendation of Administrative Action are set for hearing on June 14, 2006, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the parties hereto are desirous of fully and finally compromising and settling all disputes and issues raised in connection with the said Notice of Recommendation of Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

1. RGGB Marketing, Inc. d/b/a Jabba Jaws, is a licensed video gaming establishment.



2. On July 16, 1999, Joseph G. Trapani, Stephanie B. Trapani, Jessie J. Autin, Jr. and Tari T. Autin each purchased 25% of RGBB Marketing, Inc.

3. On July 25, 2001 Joseph Trapani, Jessie Autin, Jr. and Tari Autin sold their individual 25% shares to Camille Delise. The Division was not timely notified of the stock transfer.

4. Also on July 25, 2001, Camille Delise, owner of 75% of the shares of RGBB Marketing d/b/a Jabba Jaws, became the president of RGBB Marketing, Inc.

5. The 2002/2003 renewal application, submitted July 1, 2002, and purportedly notarized on June 25, 2002, included the signature of Joseph Trapani, as President.

6. On December 18, 2003, Stephanie Trapani transferred her remaining 25% to Joseph Trapani, as part of the community property settlement in their divorce. On December 18, 2003, Joseph Trapani transferred the remaining 25% to Camille Delise, which resulted in her becoming the 100% owner.

7. Various documents submitted to the Division, including but not limited to the Annual License form, dated May 21, 2001, which was signed by Joseph Trapani, were improperly notarized documents as the purported notary was not present when the documents were signed. Thus, the Documents were improperly notarized in violation of LAC 42:XI.2405(A)(15).

8. At all times relevant to this Agreement, Master Video Poker ("MVP") was the device owner of Jabba Jaws.

9. The shareholders of Jabba Jaws indicate that they relied upon MVP and its agents to inform the Division of the changes in ownership, however the Licensees themselves remain ultimately responsible for timely reporting material changes in the status of the corporation to the Division.

10. Camille Delise is currently the sole member of RGBB Marketing, Inc. d/b/a Jabba Jaws.

11. Camille Delise stipulates that the notarized Documents submitted to the Division, were not notarized in the Affiant's presence.

12. On February 6, 2006, the Louisiana Gaming Control Board issued a Notice of Recommendation of Administrative Action to Jabba Jaws, alleging certain violations of Louisiana Gaming Control Law.

13. Camille Delise represents that all of the statements, responses, disclosures and representations provided in the improperly notarized documents submitted to the Division, are true and correct to the best of her knowledge, information and belief, and represent a complete and accurate account of the requested information.

TERMS AND CONDITIONS

1. Any and all information discovered throughout the course of this or any other investigation may be used in any future determination of the suitability of Camille Delise.

2. Any and all information discovered throughout the course of this or any other investigation may be used in any future consideration of a license for RGBB Marketing, Inc. d/b/a Jabba Jaws.

3. RGBB Marketing, Inc. d/b/a Jabba Jaws agrees to pay a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00).

4. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and RGBB Marketing, Inc. d/b/a Jabba Jaws, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

5. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory,

but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

6. If approved, RGBB Marketing, Inc. d/b/a Jabba Jaws must make payment of the civil penalty to the Division within ten (10) days of approval by the Louisiana Gaming Control Board. Failure to do so shall result in the immediate suspension of the license without the necessity of any further administrative action until such time as the penalty is paid in full.

7. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

I have read this entire Compromise Settlement Agreement, understand it, and agree to all stipulations and terms and conditions hereof.




