

JOINT MOTION FOR ENTRY OF STIPULATIONS AND APPROVAL OF PROPOSED SETTLEMENT

ON THE JOINT MOTION OF:

- 1. the Louisiana Department of Public Safety and Corrections, Office of State Police, Video Gaming Division (hereinafter "Division"), and
- 2. Coronado Amusement Co., Inc., License No. 3101605925 (hereinafter "Licensee"),

who respectfully represent the following:

WHEREAS:

- 1. On or about March 1, 2003, the Division mailed the annual form, which must be submitted annually by all licensees, to the Licensee;
- 2. The Licensee was mandated by La. R.S. 27:311(K)(4), LAC 42:XI.2405(B)(4) and (7) to submit the above annual form to the Division, along with all appropriate fees and current tax clearance certificates, on or before July 1, 2003;
- On or about June 1, 2003, the Division sent a notice to the Licensee, advising it of its obligation to submit the annual fee and tax clearances by July 1, 2003.
- 4. On or about July 23, 2003, the Division received the Licensee's Annual Form, fee, and local and state tax clearance certificates; however, the items were not received by the Division prior to July 1, 2003.
- 5. Pursuant to this information, the Division issued Violation/Inspection Report #14079 to the Licensee on or about July 28, 2003, citing violation of La. R.S. 27:311(K)(4) and LAC 42:XI.2405(B)(4).
- 6. Attendant to the Violation/Inspection Report, the Louisiana Gaming Control Board issued a Notice of Recommendation of Administrative Action to the licensee on or about October 9, 2003 for the Licensee's failure to submit the

Annual Form, fee, and local and state tax clearance certificates before July 1, 2003.

7. This matter has been scheduled for hearing on December 17, 2003 at 9:00 a.m. before the Honorable William H. Brown,

NOW THEREFORE, in consideration of the foregoing stipulations, the Division and the Licensee hereby propose the following settlement, that:

- The Licenses acknowledges that it was in violation of La. R.S. 27:311(K)(4), LAC 42:XL2405(B)(4), and LAC 42:XL2405(B)(7), in that it did not submit the Licensee's Annual Form, fee, and local and state tax clearance certificates to the Division by July 1, 2003;
- 2. In lieu of an administrative action, the Licensee shall pay a \$500.00 civil penalty;
- 4. The Division hereby agrees to accept the Licensee's payment of the above stated penalty in full and final settlement of Violation/Inspection Report No. 14079 and this Notice of Recommendation of Administrative Action;
- 5. The Division reserves the right to take into consideration these violations in connection with any future violation;
- 6. The form and substance of this settlement are to be interpreted under the laws of the State of Louisiana;
- This settlement constitutes the entire agreement between the Division and the Licensee pertaining to the subject matter contained herein, and supercedes all prior and contemporaneous agreements, representations, and understandings of the parties;
- 8. This settlement is subject to approval by the Hearing Officer of the Louisiana Gaming Control Board; it is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not executory and will be submitted to the Board for its determination as to whether the matter should be heard by the Hearing Officer; if approved, however, payment of the above penalties must be submitted to the Division within fifteen (15) days of approval of this settlement by the Board; the failure to submit the civil penalty within fifteen (15) days of approval by the Board shall result in the video gaming license of the Licensee being revoked and its gaming devices being disabled; and
- 9. The Division and the Licensee waive their rights to appeal this settlement if the Order is signed by the Hearing Officer and accepted by the Board.

- 1. The Licensee acknowledges that it was in violation of La. R.S. 27:311(K)(4), LAC 42:XI.2405(B)(4), and LAC 42:XI.2405(B)(7), in that it did not submit the Licensee's Annual Form, fee, and local and state tax clearance certificates to the Division by July 1, 2002;
- 2. having submitted the Annual Licensee Form, fee, local and state tax clearance certificates untimely to the Division, the Licensee shall pay a civil penalty in the amount of \$500.00;
- 3. payment of the above penalty shall be submitted to the state within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board; and
- 4. the failure to submit the above penalty within fifteen (15) days of approval of this settlement by the Board shall result in the video gaming license of Coronado Amusement Co., Inc. being revoked and its gaming devices being disabled.
