## COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Office of State Police Gaming Enforcement Division (hereinafter, the "Division") and Aaron's Investment, Inc. d/b/a Aarons (hereinafter, "Licensee"), do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has sent a Notice of Recommendation of Administrative Action to Licensec, which Notice contains allegations of certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by said Notice were set for hearing before the Louisiana Gaming Control Board Administrative Hearing Office on March 29, 2023;

WHEREAS, the Division and Licensee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with said Notice;

NOW, THEREFORE, in consideration of the foregoing, the parties herein do hereby agree and stipulate as follows:

#### STIPULATIONS

 Licensee is a Type 2 licensed establishment located at 2545 Paris Road, Suite A. Chalmette, Louisiana 70043.

- 2. On March 14, 2022, the Division emailed a Video Gaming Advisory Notice to Licensee informing them of the requirement to submit the annual fee and forms no later than June 30, 2022.
- On October 5, 2022, the Davision received the required annual renewal forms and fee.
- 4. Licensee failed to timely submit the required annual fee and supporting documents, in violation of La R.S. 27:435(K)(4)(a) and (d) and LAC 42:X1 2405(B)(4)

#### TERMS AND CONDITIONS

- 1. In lieu of administrative action, Licenser will pay a penalty of SEVEN HUNDRED FIFTY and 00/100 (\$750.00) DOLLARS for its violation of La R.S. 27:435(K)(4)(a) and (d) and LAC 42:XI.2405(B)(4).
- 2. The Division hereby agrees that payment of a total penalty of SEVEN HUNDRED FIFTY and 00/100 (\$750.00) DOLLARS shall be in full and final settlement of all matters set forth in the Notice of Recommendation of Administrative Action.
- 3. The Division reserves the right to take into consideration this admitted violation in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Licensee's suitability.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Licensee, pertaining to the subject matter contained herein and

supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

6. This Compromise and Settlement Agreement is subject to approval by the

Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this

proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory.

gaming license without the necessity of any further administrative action until such time as the

penalty is paid in full
