**COMPROMISE AND SETTLEMENT AGREEMENT**

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and LML Enterprises, LLC d/b/a Cajun Country Casino (hereinafter, "Licensee"), do hereby represent and agree as follows:

**WHEREAS**, the Louisiana Gaming Control Board has sent a Notice of Recommendation of Administrative Action to Licensee, which Notice contains allegations of certain violations of Louisiana Gaming Control Law; and

**WHEREAS**, the issues raised by said Notice were set for hearing before the Louisiana Gaming Control Board Administrative Hearing Office on July 13, 2015.

**WHEREAS**, the Division and Licensee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with said Notice;

**NOW, THEREFORE**, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

**STIPULATIONS**

1. On January 21, 2015, the Division conducted a compliance inspection at the licensed establishment of Licensee. The inspection revealed the following.

2. The Licensee was offering several different monthly promotions. The Licensee had a promotion board, which listed four separate promotions being offered during the month of January 2015: random cash drawings, Spin 2 Win, 3x Points, and \$5 Free Play Coupon.

3. The Division was unable to find the rules, terms, and conditions for any of the promotions posted within the licensed establishment. The certified technician level 1 on duty, as well as the casino's manager, confirmed that the rules, terms, and conditions for the promotions were not posted inside of the licensed establishment. The Licensee failed to display the rules, terms, and conditions of the promotions it was offering, in violation of gaming law.

4. The on-site restaurant is leased to and operated by El Cajun's La Mex, LLC. According to the posted business hours, the restaurant was open on Sunday through Thursday from 10:00 a.m. to 9:00 p.m. and on Friday and Saturday from 10:00 a.m. to 9:30 p.m. Contradictorily, a sign inside of the restaurant stated that the restaurant was closed on Monday through Friday from 2:00 p.m. to 5:00 p.m. The on-site restaurant was not open at least twelve hours per day, seven days per week, in violation of gaming law.

5. On or about March 11, 2015, the Division received documents from the Licensee showing that the rules, terms, and conditions of its promotions are now posted within the gaming area and that the on-site restaurant is now open on Sunday through Thursday from 9:00 a.m. to 9:00 p.m. and on Friday and Saturday from 9:00 a.m. to 9:30 p.m.

#### **TERMS AND CONDITIONS**

1. In lieu of administrative action, the Licensee will pay a penalty of **ONE THOUSAND and No/100 (\$1,000.00) DOLLARS** for its violation of La. R.S. 27:417(A)(2)(b) and a penalty of **TWO HUNDRED FIFTY and No/100 (\$250.00) DOLLARS** for its violation

of LAC 42:XI.2407(A)(8)(d), for a total penalty of **ONE THOUSAND TWO HUNDRED FIFTY and No/100 (\$1,250.00) DOLLARS**.

2. The Division hereby agrees that payment of a total penalty of **ONE THOUSAND TWO HUNDRED FIFTY and No/100 (\$1,250.00) DOLLARS** shall be in full and final settlement of all matters set forth in the Notice of Recommendation of Administrative Action.

3. The Division reserves the right to take into consideration this admitted violation in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Licensee's suitability.

4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and the Licensee, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

7. If approved, Licensee agrees to make full payment of the civil penalty within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board. Licensee agrees that failure to meet this requirement shall result in immediate suspension of the


gaming license without the necessity of any further administrative action until such time as the penalty is paid in full.

**ORDERED, ADJUDGED, AND DECREED** that the Compromise and Settlement Agreement attached to the parties' Joint Motion for Approval of Compromise and Settlement Agreement be, and the same is hereby, **APPROVED**; that the Licensee must pay a total penalty of ONE THOUSAND TWO HUNDRED FIFTY and No/100 (\$1,250.00) DOLLARS to the Division within fifteen (15) days of approval by the Louisiana Gaming Control Board. Failure to do so shall result in the immediate suspension of the gaming license without the necessity of any further administrative action until such time as the penalty is paid in full.
