## LOUISIANA GAMING CONTROL BOARD

## Minutes of September 18, 2025

The monthly meeting of the Louisiana Gaming Control Board (the "Board") convened on Thursday, September 18, 2025, 10:00 a.m., at the Louisiana State Capitol – House Committee Room 1. Present at the meeting were Chairman Christopher Hebert, Vice-Chairman Lamar Poole, Kathryn Becnel, Franchesca Hamilton-Acker, Claude Jackson, Nicholas Langley, Julie Lewis, Ronald Sholes, and Ashley Traylor. Major Adam Albright was present for Col. Robert Hodges and Jarrod Coniglio was present for Sec. Richard Nelson. Absent were ex officio members Col. Hodges and Sec. Nelson.

Chairman Hebert called the meeting to order. There were no public comments made. It was moved by Mr. Jackson to waive the reading and approve the minutes of the August 21, 2025 Board meeting. That motion was seconded by Vice-Chairman Poole and unanimously approved by the Board.

Donna Jackson, Louisiana State Police ("LSP") Gaming Audit Section, provided revenue reports for the riverboats, slots at the racetracks, and land-based casino. She also reported on video poker, retail and mobile sports wagering, and daily fantasy sports contest revenue.

The Board considered the institution of rulemaking procedures for amendments to LAC 42:III.2325 (Administrative Actions and Penalty Schedule) and LAC 42:III.2723 (Internal Controls; Slots). After presentation by Cathryn Gits, Assistant Attorney General, it was moved by Mr. Sholes to institute rulemaking procedures for the proposed amendments. That motion was seconded by Ms. Becnel and unanimously approved by the Board.

The Board considered the original truck stop application for Silver Fox Casino, LLC d/b/a Silver Fox Casino – No. 5100518048. After a presentation by Steven Sumbler, Assistant Attorney General, and Investigator Glenn Verrett, LSP Gaming Enforcement Division, it was moved by Ms. Lewis to approve the truck stop application. That motion was seconded by Ms. Traylor and unanimously approved by the Board.

The Board considered the original truck stop application for CStore Properties2, LLC d/b/a Wynners Club Casino – No. 3904518517. After a presentation by Cathyrn Gits, Assistant Attorney General, and Investigator William

Landry, LSP Gaming Enforcement Division, it was moved by Ms. Hamilton-Acker to approve the truck stop application. That motion was seconded by Mr. Langley and unanimously approved by the Board.

The Board considered the original truck stop application for L.M. Daigle Oil Company, Inc. d/b/a Lucky Delta Casino – No. 1006518486. After a presentation by Quintele Jackson, Assistant Attorney General, and Investigator Glenn Verrett, LSP Gaming Enforcement Division, it was moved by Ms. Becnel to approve the truck stop application. That motion was seconded by Vice-Chairman Poole and unanimously approved by the Board.

The Board considered the Approval of Problem Gambling Program Updates for Betfair Interactive US, LLC d/b/a FanDuel Sportsbook – No. B016503481. Responsible Gaming Compliance Senior Manager Allie Frank was present on behalf of the Permittee. After presentation by Sharon McCoy, Assistant Attorney General, it was moved by Mr. Langley to adopt the resolution approving the problem gambling program. That motion was seconded by Mr. Jackson and unanimously approved by the Board.

The Board considered the settlement of Ben Nelson Golf & Utility Vehicles, LLC d/b/a Ben Nelson Golf & Outdoor – No. P086503387. After presentation by Sharon McCoy, Assistant Attorney General, Ms. Lewis moved to approve the settlement. That motion was seconded by Ms. Traylor and unanimously approved by the Board.

The Board considered the settlement of MLMWBM, LLC d/b/a The Pour House Saloon – No. 2600117892. After presentation by Virginia Evans, Assistant Attorney General, Ms. Becnel moved to approve the settlement. That motion was seconded by Mr. Sholes and unanimously approved by the Board.

The Board considered the appeal of Tiffany Jackson – No. P040065896. After presentation by Permittee Tiffany Jackson and Sharon McCoy, Assistant Attorney General, Mr. Jackson moved to affirm the Hearing Officer's decision. That motion was seconded by Vice-Chairman Poole and unanimously approved by the Board.

Lastly, Chairman Hebert took a moment of personal privilege to announce the departure of the Board's Appeal Docket Clerk, Jasmine Dunklin. Chairman Hebert thanked Ms. Dunklin for her years of service to the Board and introduced her successor, Shanaquoa Wright. Chairman Hebert also acknowledged the retirement of Kim Ginn, General Manager of PNK (Baton Rouge) Partnership d/b/a L'Auberge Casino and Hotel Baton Rouge – No. R011000801.

There being no further business, it was moved by Mr. Jackson to adjourn the meeting. That motion was seconded by Ms. Becnel and the meeting adjourned.
