

**JOINT MOTION FOR APPROVAL OF COMPROMISE AND
SETTLEMENT AGREEMENT**


TO THE HONORABLE ADMINISTRATIVE HEARING OFFICER:

COMES NOW the State of Louisiana, Department of Public Safety and Corrections, Office of State Police (the "Division") and Single Source Supply, LLC, (sometimes hereinafter referred to as the "Permittee") and Michael J. Buford, Catherine F. Galloway, and Keith E. Galloway (sometimes hereinafter collectively referred to as the "Principals"), who file this Joint Motion for Approval of Compromise and Settlement Agreement, and in support thereof would respectively show unto the Hearing Officer as follows:

1.

The Division, Permittee and Principals are desirous of compromising and settling all matters relative to this administrative proceeding. In connection therewith, the parties have entered into a compromise and settlement agreement which by its terms will become effective upon approval by the Administrative Hearing Office and the Louisiana Gaming Control Board.

WHEREAS, the Division, Permittee and Principals are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with said Notice of Recommendation of Denial of Renewal Application and the Notices of Recommendation of Finding of Unsuitability;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

1. On or about June 11, 2007, Single Source Supply, LLC submitted a Level II Renewal Business Application to the Division.
2. Michael J. Buford, Catherine F. Galloway, and Keith E. Galloway are the members and owners of Single Source Supply, LLC.
3. During the Division's background investigation of Single Source Supply, LLC's Level II Renewal Business Application, Michael J. Buford, Catherine F. Galloway, and Keith E. Galloway were denied tax clearances by the Louisiana Department of Revenue.
4. On May 29, 2008, the Division received Louisiana Department of Revenue tax clearances for Michael J. Buford, Catherine F. Galloway, and Keith E. Galloway.
5. The Principals of the Permittee failed to remain current in the filing of all applicable tax returns and in the payment of all taxes, interest and penalties owed to the State of Louisiana, which is in violation of LAC 42:VII.2115(B)(2), LAC 42:IX.2149(B)(5), and LAC 42:XIII.2115(B)(2).

TERMS AND CONDITIONS

1. Single Source Supply, LLC will pay a civil penalty of TWO HUNDRED FIFTY DOLLARS and No/100 (\$250.00) for each Principals' violation of LAC 42:VII.2115(B)(2), LAC 42:IX.2149(B)(5), and LAC 42:XIII.2115(B)(2), for a total civil penalty amount of SEVEN HUNDRED FIFTY DOLLARS and No/100 (\$750.00), in satisfaction of the alleged violations of the Louisiana Gaming Control Law.

2. The Division hereby agrees to accept the Permittee's payment of the above stated penalty in full and final settlement of the Notice of Recommendation of Denial of Renewal Application that was issued on March 31, 2008.

3. The Division hereby agrees to dismiss the Notices of Recommendation of Finding of Unsuitability that were issued to Michael J. Buford, Catherine F. Galloway, and Keith E. Galloway on March 31, 2008.

4. The Division reserves the right to take into consideration these admitted violations in connection with any future investigations, violations, or assessments of a penalty.

5. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.


6. This Compromise and Settlement Agreement constitutes the entire agreement between the Division, Permittee and Principals, regarding the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations, and understandings of the parties.


7. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve the same or to remand the matter to the Hearing Officer for a full hearing on the merits. Failure to pay the penalty within fifteen (15) days of approval of this settlement shall result in the immediate suspension of Single Source Supply, LLC's permit without the necessity of further administrative action, until such time as the penalty is paid in full.


A true and correct copy of the proposed Compromise and Settlement Agreement is attached hereto as Exhibit "A" and incorporated by reference for all purposes.


COMPROMISE AND SETTLEMENT AGREEMENT

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms and conditions hereof.




