COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State

Police (hereinafter the "Division") and Ronnie W. Harrell, Permit No. P040050545 (hereinafter

"Permittee") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Enforcement Division has issued a Notice of

Recommendation of Revocation, Order of Immediate Emergency Suspension, and Notice of

Hearing to Permittee, alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Revocation,

Order of Immediate Emergency Suspension, and Notice of Hearing are set for hearing on

March 10, 2008, before the Louisiana Gaming Control Board Administrative Hearing Office:

and

WHEREAS, the Division and Permittee are desirous of fully and finally compromising

and settling all issues and disputes arising out of and in connection with the said Notice of

Recommendation of Revocation, Order of Immediate Emergency Suspension, and Notice of

Hearing:

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do herby agree and stipulate as follows:

STIPULATION

- 1. Permittee stipulates that on July 17, 2007, he was arrested by the East Feliciana Parish Sheriff's Office and charged with violating La. R.S. 14:80, Felony Carnal Knowledge of a Juvenile.
- 2. On November 20, 2007, Permittee pled guilty under Code of Civil Procedure Article 894 to the amended charge of Misdemeanor Carnal Knowledge of a Juvenile, La. R.S. 14:80.1.
- 3. Permittee failed to notify the Division of the arrest within fifteen (15) calendar days of the arrest, which violates LAC 42:XIII.2901 (B) (4).

TERMS AND CONDITIONS

- 1. Pursuant to La. R.S. 27:28(B)(1)(a) and 27:28(B)(2), any and all information discovered throughout the course of this or any other investigation may be used in any future consideration of the suitability of Permittee. Although, consideration of these allegations shall not be deemed as an automatic disqualifier.
- 2. The Division withdraws the Recommendation of Revocation based upon the fact that Permittee pled to the lesser charge of Misdemeanor Carnal Knowledge of a Juvenile, La. R.S. 14:80.1 under Article 894.
- 3. Pursuant to the Administrative penalty schedule, Permittee agrees to pay and the Division agrees to accept a civil penalty of One Thousand and No/100 (\$1,000.00) Dollars, for the violation of LAC 42:XIII.2901 (B) (4), said penalty to be paid within fifteen (15) days of the approval of this settlement by the Louisiana Gaming Control Board.

4. The terms of this Compromise and Settlement Agreement shall be interpreted

under the laws of the State of Louisiana.

This Compromise and Settlement Agreement constitutes the entire agreement

between the Division and Permittee, pertaining to the subject matter contained herein and

supersedes all prior and contemporaneous agreements, representations and understandings of the

parties.

6. This Compromise and Settlement Agreement is subject to approval by the

Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this

proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory,

but will be submitted to the Louisiana Gaming Control Board for its determination as to whether

to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

7. If approved by the Louisiana Gaming Control Board, Permittee must pay One

Thousand and No/ 100 (\$1,000.00) Dollars within fifteen (15) calendar days of such approval.

Any failure to meet this requirement will result in immediate suspension of the gaming permit

until such payment is made without the necessity of any further administrative action.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms

and conditions hereof.
