ORDER



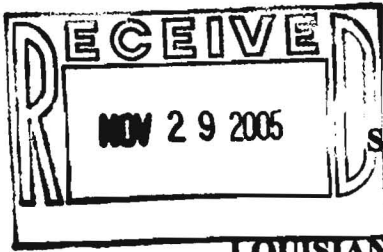

**JOINT MOTION FOR ENTRY OF STIPULATIONS AND
APPROVAL OF PROPOSED SETTLEMENT**

ON THE JOINT MOTION OF:

1. the State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "Division"), and
2. North Louisiana Amusement & Gaming L.L.C. d/b/a North Louisiana Amusement & Gaming, license no. 0801612412, (hereinafter "North Louisiana"),

who respectfully represent the following:

WHEREAS:

1. North Louisiana is a licensed video draw poker device owner;
2. On September 4, 2003, North Louisiana sold TLC Games, Inc. 108 video draw poker devices;
3. TLC Games, Inc. was not a licensed video draw poker device owner;
4. On or about February 9, 2004, the sale was rescinded;
5. Based on the North Louisiana's sale of the video draw poker machines to an unlicensed person, North Louisiana was issued a Notice of Recommendation of Revocation by the Louisiana Gaming Control Board on September 27, 2005;

NOW THEREFORE, in consideration of the foregoing stipulations, the Division and North Louisiana hereby propose to settle this matter pursuant to the following terms and conditions:



1. North Louisiana admits that it violated L.A.C. 42:XI.2411(D)(5);
2. Further, North Louisiana agrees to pay a civil penalty of Ten Thousand Dollars (\$10,000.00);
4. The Division hereby agrees to accept the payment of this civil penalty as full and final settlement of this matter;
5. The Division will withdraw its recommendation that Leon S. Miletello be found unsuitable;
6. The form and substance of this settlement are to be interpreted under the laws of the State of Louisiana;
7. This settlement constitutes the entire agreement between the Division and North Louisiana pertaining to the subject matter contained herein, and supersedes all prior and contemporaneous agreements, representations, and understandings of the parties;
8. This settlement is subject to approval by the Hearing Officer of the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not executory and will be submitted to the Board for its approval or determination as to whether the matter should be remanded to the Hearing Officer for a full hearing. If approved, however, North Louisiana must make payment of the civil penalty to the Division within ten (10) days of approval. Failure to do so shall result in the immediate suspension of the license until such time as the penalty is paid in full.

Considering the foregoing Joint Motion For Entry of Stipulations and Approval of Proposed Settlement, IT IS HEREBY ORDERED that such proposed settlement be approved, to wit:

- 1. The admission of North Louisiana Amusement & Gaming L.L.C. d/b/a North Louisiana Amusement & Gaming to the violation of L.A.C. 42:XI.2411(D)(5) is accepted;
2. North Louisiana Amusement & Gaming L.L.C. d/b/a North Louisiana Amusement & Gaming shall pay a civil penalty of Ten Thousand Dollars (\$10,000.00);
3. North Louisiana Amusement & Gaming L.L.C. d/b/a North Louisiana Amusement & Gaming shall make payment of the civil penalty to the Division within ten (10) days of approval. Failure to do so shall result in the immediate suspension of the license until such time as the penalty is paid in full.
