COME NOW State of Louisiana, Department of Public Safety and Corrections, Office of State Police ("Division") and Laura B. Wood d/b/a Vaughan's Lounge, VGL 3601103282, who file this, their Joint Motion for Approval of Compromise and Settlement Agreement, and in support thereof would respectively show unto the Hearing Officer as follows:

1.

The Division and Laura B. Wood d/b/a Vaughan's Lounge are desirous of compromising and settling all disputes between them relative to the referenced administrative proceeding. In connection therewith, the parties have entered into a compromise and settlement agreement which by its terms will become effective upon approval by the Administrative Hearing Office and the Louisiana Gaming Control Board.

Failure to do so shall result in the immediate suspension of the license without the necessity of any further administrative action until such time as the penalty is paid in full.
- 6. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State

Police (hereinaster "the Division") and Laura B. Wood d/b/a Vaughan's Lounge, VGL

3601103282, do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of

Recommendation of Administrative Action to Laura B. Wood d/b/a Vaughan's Lounge, which

notice alleges certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Administrative

Action are set for hearing on July 6, 2006, before the Louisiana Gaming Control Board

Administrative Hearing Office; and

WHEREAS, the parties hereto are desirous of fully and finally compromising and

settling all disputes and issues raised in connection with the said Notice of Recommendation of

Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby

agree and stipulate as follows:

STIPULATIONS

1. Laura B. Wood d/b/a Vaughan's Lounge, a licensed video gaming

establishment, previously entered into a video poker device agreement with Master Video Poker.



- 2. Master Video Poker sent video gaming documents ("the Documents") to Laura B. Wood d/b/a Vaughan's Lounge for execution, including but not limited to the Annual License form, dated May 5, 2003, which was signed by Laura Wood.
 - 3. Laura Wood is 100% owner of Laura B. Wood d/b/a Vaughan's Lounge.
- 4. Laura Wood admits that she did not sign the Documents in the presence of a notary and the Documents were not notarized in the Affiant's presence. Thus, the Documents were improperly notarized in violation of LAC 42:XI.2405(A)(15).
- 5. On May 12, 2006, the Louisiana Gaming Control Board issued a Notice of Recommendation of Administrative Action to Laura B. Wood d/b/a Vaughan's Lounge, VGL # 3601103282, alleging certain violations of Louisiana Gaming Control Law.
- 6. Laura Wood represents that all of the statements, responses, disclosures and representations provided in documents submitted to the Division bearing her signature, are true and correct to the best of her knowledge, information and belief, and represent a complete and accurate account of the requested information.

TERMS AND CONDITIONS

- 1. Any and all information discovered throughout the course of this or any other investigation may be used in any future determination of the suitability of Laura Wood.
- 2. Laura Wood d/b/a Vaughan's Lounge agrees to pay a civil penalty of One Thousand Dollars (\$1,000.00).
- 3. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Laura B. Wood d/b/a Vaughan's Lounge, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
- 4. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this
