A true and correct copy of the proposed Compromise and Settlement Agreement is attached hereto as Exhibit "A" and incorporated by reference for all purposes.



**COMPROMISE AND SETTLEMENT AGREEMENT**

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and Lesley Enterprises, LLC d/b/a Gattuso's Deli (hereinafter, "Gattuso's Deli") do hereby represent and agree as follows:

**WHEREAS**, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Administrative Action to Gattuso's Deli alleging certain violations of Louisiana Gaming Control Law; and

**WHEREAS**, the issues raised by the said Notice of Recommendation of Administrative Action are set for hearing before the Louisiana Gaming Control Board Administrative Hearing Office on April 18, 2011; and

**WHEREAS**, the Division and Gattuso's Deli are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notice of Recommendation of Administrative Action;

**NOW, THEREFORE**, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

**STIPULATIONS**

1. Gattuso's Deli operates a restaurant located at 435 Huey P. Long Avenue, Gretna, Louisiana 70053.

2. Lesley Gattuso Brown (hereinafter, "Ms. Gattuso") is the one member of Gattuso's Deli and owns one-hundred (100%) percent of the interest.

3. Ms. Gattuso married Benjamin Brown (hereinafter, "Mr. Brown") on November 24, 2007.

4. Gattuso's Deli submitted a personal history questionnaire to the Division for Mr. Brown on June 24, 2010, two years and seven months after the marriage occurred.

5. Gattuso's Deli did not notify the Division of the marriage until June 24, 2010, when Gattuso's Deli submitted the personal history questionnaire for Mr. Brown, notifying the Division of the marriage between Ms. Gattuso and Mr. Brown, in violation of **LAC 42:XI.2417(B)(4)**.

#### **TERMS AND CONDITIONS**

1. In lieu of Administrative Action of its Gaming License, Gattuso's Deli will pay a civil penalty of SEVEN HUNDRED FIFTY AND NO/100 (\$750.00) DOLLARS for its violation of **LAC 42:XI.2417(B)(4)**.

2. The Division hereby agrees to accept Gattuso's Deli's payment of the above stated penalty in full and final settlement of the Notice of Recommendation of Administrative Action for the licensee's violation of **LAC 42:XI.2417(B)(4)**.

3. The Division reserves the right to take into consideration these admitted violations in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Gattuso's Deli's suitability.

4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.


5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Gattuso's Deli, pertaining to the subject matter contained herein and



supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits. Failure to pay the penalty within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board, and to comply with each term and condition listed herein, shall result in the immediate suspension of Gattuso's Deli's license without the necessity of further administrative action, until such time as the penalty is paid in full.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms and conditions hereof.

Failure to do so shall result in the immediate suspension of the gaming license without the necessity of any further administrative action until such time as the penalty is paid in full.
