**TO THE HONORABLE ADMINISTRATIVE HEARING OFFICER:**



**COMPROMISE AND SETTLEMENT AGREEMENT**

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and Beacon Lakeside, L.L.C. d/b/a Beacon Lakeside (hereinafter, "Lakeside") do hereby represent and agree as follows:

**WHEREAS**, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Administrative Action to Lakeside, which Notice contains allegations of certain violations of Louisiana Gaming Control Law; and

**WHEREAS**, the issues raised by the said Notice of Recommendation of Administrative Action has been set for hearing before the Louisiana Gaming Control Board Administrative Hearing Office; and

**WHEREAS**, the Division and Lakeside are desirous of fully and finally settling all issues and disputes arising out of and in connection with the said Notice of Recommendation of Administrative Action;

**NOW, THEREFORE**, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

**STIPULATIONS**

1. Lakeside is a Type 1 licensed establishment located at 202 Old Highway 51 South, Akers, Louisiana 70421.

2. On February 2, 2015, the Division mailed a Video Gaming Advisory Notice to Lakeside informing them of the requirement to submit the annual fee and annual renewal application no later than July 1, 2015.

3. On September 8, 2015, Lakeside submitted an Annual Licensee Form and annual fee to the Division.

4. The documents were rejected by the Division and returned to Lakeside as incomplete on or about September 10, 2015.

5. On September 17, 2015, the Division received the required annual renewal forms and fee.

6. Lakeside failed to timely submit the required annual fee and supporting documents, a violation of **LAC 42:XI.2405(B)(4)(a) and (b)**.

#### **TERMS AND CONDITIONS**

1. In lieu of Administrative Action, Lakeside will pay a penalty of SEVEN HUNDRED AND FIFTY AND NO/100 (\$750.00) DOLLARS for its violation of **LAC 42:XI.2405(B)(4)(a) and (b)**.

2. The Division hereby agrees to accept Lakeside's payment of the above stated penalty in full and final settlement of the Notice of Recommendation of Administrative Action for Lakeside's violation of **LAC 42:XI.2405(B)(4)(a) and (b)**.

3. The Division reserves the right to take into consideration this admitted violation in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Lakeside's suitability.

4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Lakeside, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations, and understandings of the parties.

6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if the Hearing Officer approves this proposed settlement, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

7. If approved, Lakeside agrees to make full payment of the civil penalty to the Division within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board. Lakeside agrees that failure to meet this requirement shall result in immediate suspension of the gaming license without the necessity of any further administrative action, until such time as the penalty is paid in full.

I have read this entire Compromise and Settlement Agreement and agree to all stipulations and terms and conditions hereof.
