

NOW COME the State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and Maria T. COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and Maria T. Grayson (hereinafter, "Ms. Grayson") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has sent a Notice of Recommendation of Administrative Action to Ms. Grayson, containing allegations of certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Administrative Action are set for hearing before the Louisiana Gaming Control Board Administrative Hearing Office on February 13, 2012; and

WHEREAS, the Division and Ms. Grayson are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notice of Recommendation of Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

- 1. Maria T. Grayson holds a Non-Key Gaming Employee Permit.
- 2. Maria T. Grayson's Non-Key Gaming Employee Permit expires on December 3, 2013.

- 3. On May 12, 2011, the Jefferson Parish Sheriff's Office arrested Maria T. Grayson for violation of La. R.S. 14:56(B)(2) and La. R.S. 40:967(C)(2).
- 4. The above-referenced charges were refused by the Jefferson Parish District Attorney's Office on June 3, 2011 and November 4, 2011.
- 5. Maria T. Grayson admits that she failed to notify the Division of this arrest, in violation of LAC 42:XIII.2901(B)(4).

TERMS AND CONDITIONS

- In lieu of Administrative Action against Maria T. Grayson's Non-Key Gaming Permit,
 Maria T. Grayson will pay a civil penalty of TWO HUNDRED FIFTY AND NO/100
 DOLLARS (\$250.00) for her violation of LAC 42:XIII.2901(B)(4).
- 2. The Division hereby agrees that payment of a TWO HUNDRED FIFTY AND NO/100 DOLLARS (\$250.00) civil penalty shall be in full and final settlement of all matters set forth in the Notice of Recommendation of Administrative Action on December 22, 2011.
- 3. The Division reserves the right to take into consideration these admitted violations in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Maria T. Grayson's suitability.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Maria T. Grayson, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations, and understandings of the parties.

6. This Compromise and Settlement Agreement is subject to approval by the Hearing

Officer and the Louisiana Gaming Control Board. It is expressly understood that if this

proposed settlement is approved by the Hearing Officer, this agreement is not thereby

executory, but will be submitted to the Louisiana Gaming Control Board for its

determination as to whether to approve same or to remand the matter to the Hearing

Officer for a full hearing on the merits.

7. If approved, Maria T. Grayson agrees to make full payment of the civil penalty to the

Division within fifteen (15) days of approval of this settlement by the Louisiana Gaming

Control Board. Maria T. Grayson agrees that failure to meet this requirement shall result

in immediate suspension of her Non-Key Employee Permit without the necessity of any

further administrative action, until such time as the penalty is paid in full.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms

and conditions hereof.
